ACTUARIAL ASSUMPTIONS AND METHODS

The valuation of a defined benefit pension plan involves estimates and assumptions about the probability of events occurring far into the future. Examples include assumptions about future employment, mortality, and retirement. Below is a description of the actuarial assumptions and methods used in the valuation.

Actuarial Cost Methods

Funding Target Liability: As required by PPA, the Traditional Unit Credit Cost Method is used.

Actuarial Value of Assets: Market Value, as provided by the Trustee.

Funding Target Liability

Valuation Date: January 1, 2024

Demographic Information: The demographic information was provided as of January 1, 2024 by R.H. Marcon, Inc. Although we did not audit the data, we did review the data for reasonableness.

Actuarial Valuation Software: For purposes of developing the projected future benefit payments as well as determining attributed liabilities and normal costs as of the valuation date, we utilized the ASC software platform developed by Actuarial Systems Corporation. We believe this externally developed valuation system is appropriate, was used for its intended purpose, and did not produce unreasonable results.

Interest Rates for Minimum Required Contribution: The adjusted 24-month average January 2024 funding segment rates using 25-year average segment rate corridors were utilized as prescribed by IRC Section 430(h), after reflection of interest rate stabilization provisions included in various legislation.

Segment 1 is applied to benefit payments expected to be made in the first 5 years, segment 2 is applied to benefit payments expected to be made in the next 15 years and segment 3 is applied thereafter.

Effective Interest Rate: 5.36%

Interest Rates for Maximum Alternative Contribution: The January 2024 funding segment rates were utilized as prescribed by IRC Section 430(h), and elected by R.H. Marcon, Inc. without reflection of the interest rate stabilization provisions included in various legislation. These rates were utilized to determine the LDRM calculations.

Rate of Compensation Increase: Salaries are assumed to increase at 3.00% per year.

Retirement Rates: Employees were assumed to retire at normal retirement age (the later of age 65 or the fifth anniversary of initial entry to the plan) or one year after the valuation date, if later.

ACTUARIAL ASSUMPTIONS AND METHODS

Post-retirement Mortality: The base mortality tables are the blended sex distinct Pri-2012 mortality tables. The base mortality table is adjusted as described in Internal Revenue Regulation 1.430(h)(3)–1(c)(2) by projecting mortality improvements using the 2024 Adjusted Scale MP-2021 Rates from the year 2012 through 2024, with an additional projection period of 8 years for males and 9 years for females. For ages below 80, the additional projection period is increased by 1 year for each year below age 80. For ages above 80, the additional projection period is reduced (but not below zero) by 1/3 year for each year above 80.

Administrative Expenses: Actual plan expenses, not including investment advisory fees, paid out of the trust during the previous plan year, rounded to the nearest thousand dollars - \$28,000.

Form of Benefit: 100% of active participants are assumed to receive a deferred lump sum distribution at their assumed retirement age. 100% of terminated vested participants are assumed to receive an immediate lump sum distribution.



SUMMARY OF PLAN PROVISIONS

This summary is intended as an outline of plan provisions and does not alter the intent or meaning of the provisions contained in the plan document.

Effective Date of Plan:	October 1, 2015
Last Amendment Date:	January 1, 2021
Plan Year:	Each consecutive 12-month period ending on December 31 st .
Eligibility:	Eligible employees become eligible to participate in the Plan on the January 1 st or July 1 st coincident with or next following the later of attainment of age 21 and the completion of 1 Year of Service. Government Contract Employees subject to Prevailing Wage Contributions will enter the Plan on the date first worked.
Normal Retirement Date:	The first day of the month on or next following the Participant's attainment of age 65, or the 5 th anniversary of plan participation, if later.
Year of Service:	Completion of at least 1,000 Hours of Service in a Plan Year.
Compensation:	Taxable wages on the participant's IRS Form W-2 including any amount deferred on a tax-preferred basis to any Company benefit plan.
Accrued Benefit:	If currently payable, a single life annuity which is actuarially equivalent to the current Hypothetical Account Balance. If not currently payable, a single life annuity payable at Normal Retirement Date which is actuarially equivalent to the projected Hypothetical Account Balance. The projected Hypothetical Account Balance is the current Hypothetical Account Balance plus the sum of future Interest Credits through Normal Retirement Date. The benefit shall not exceed the maximum permitted benefit under Internal Revenue Code Section 415.
Late Retirement Benefit:	Upon retirement after Normal Retirement Date, the Accrued Benefit, calculated and payable as of the Late Retirement Date.
Hypothetical Account Balance:	The balance of the account established for each participant, equal to the sum of Principal Credits and Interest Credits.
Principal Credits:	A dollar amount or percentage of annual compensation, depending on membership in an allocation group. The groups and the amounts are:

Some Participants' Hypothetical Allocations were increased in order to meet minimum participation requirements as stated in the 11(g) amendment for 2023.

SUMMARY OF PLAN PROVISIONS

Interest Credits:	The interest that is credited to a Participant's Hypothetical Account Balance on the last day of the Plan Year, based on a fixed annual interest crediting rate of 3.00%.
Vesting:	A Participant is 100% vested upon the completion of 3 Years of Service. Employees who are Government Contract Employees subject to Prevailing Wage Contributions as defined in the R. H. Marcon, Inc. Profit Sharing Plan shall be 100% vested at all times.
Pre-Retirement Death Benefit:	The Death Benefit is payable as a Lump Sum, the amount payable is the vested Hypothetical Account Balance.
Normal Form of Retirement Benefit:	A single Life Annuity. If married to a qualified spouse, a 100% Qualified Joint and Survivor Annuity, which is the actuarial equivalent of a Life Annuity.
Optional Forms of Benefit:	Qualified Optional Survivor Annuity (50%) Lump Sum
