Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor’s Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the *Auditor’s Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control related matters that we identified during the audits.

### **Supplemental Schedules Required by ERISA**

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### Note 1—Description of the Plan

The following description of the ERMI, LLC 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement or the Summary Plan Document for a more complete description of the Plan’s provisions.

*General* – The Plan is a defined contribution plan established by ERMI, LLC (the “Company” or the “Plan Administrator”), under the provisions of Section 401(k) of the Internal Revenue Code (“IRC”). The Plan covers all eligible employees and is administered by the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Assets of the Plan are held by Ascensus Trust Company (the “Trustee”).

*Plan Amendments* – On January 1, 2021, the Plan was amended to allow the Company to make safe harbor matching contributions and discretionary profit sharing contributions.

*Eligibility* – All employees are eligible to participate in the Plan upon completion of 1,000 hours of services within a 12 consecutive month period or are employed at the end of the period of service, if applicable.

*Participant Contributions* – Participants may elect to defer the pre-tax portion of their annual compensation subject to IRC limitations. Each year, participants may elect to contribute up to the maximum as allowed by the Internal Revenue Service (“IRS”), not to exceed \$23,000 in 2024. As allowed by the IRS, the limit on catch-up elective deferrals for participants aged 50 and over was an additional \$7,500 for the 2024 Plan year. Participants who have a balance in another qualified employee benefit plan, may transfer or rollover the lump-sum values of their account directly into the Plan, provided it meets the requirements of the IRC.

*Employer Contributions* – The Company may make safe harbor matching, discretionary matching, and discretionary profit sharing contributions equal to the declared percentage of participant deferrals for the period. During 2024, the Company elected to make matching contributions to the Plan of up to 100% on the first 3% contributed and 50% on the next 2% contributed. For the year ended December 31, 2024, the Company recognized safe harbor employer matching contributions in the total amount of \$433,126.

Employer contributions will be allocated to the participants’ accounts in the same ratio as each participant’s compensation bears to the total compensation of all qualifying participants and allocated to investment funds, as the participant’s contributions are allocated. If the participant’s account does not allocate to an investment fund, the employer contributions are then allocated to a target date fund account in the participant’s account.

*Investment Options* – Participants may direct the Trustee, as to the investment of their account balances in accordance with guidelines established by the Plan. Participants may change their investment elections at any time. Transfers of account balances between elected investment options may be made at any time.

*Participant Accounts* – Each participant’s account is credited with the participant’s contribution and allocations of the Company’s contributions and Plan earnings. Participant accounts are charged with withdrawals and an allocation of Plan losses and administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Vesting* – All participants’ contributions, discretionary profit sharing contributions, safe harbor matching contributions, and earnings thereon are fully vested immediately upon contribution.

### Note 1—Description of the Plan (continued)

*Notes Receivable from Participants* – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000. The loans are secured by the balance in the participant's account. The loan interest rate is set at the prime rate. All Plan notes receivable from participants must be repaid in five years, except those that are used for the purchase of a principal residence, in which case the loan can be extended. In most cases, repayment of the loan will be made through after-tax payroll deductions. If a participant defaults on the loan, the outstanding loan balance plus accumulated interest is deemed a distribution and reported as income to the participant, subject to early withdrawal penalty.

*Payment of Benefits* – The full value of a participant's account is available to be paid when (1) the participant retires at age 65 or later; (2) the participant becomes permanently disabled; (3) the participant terminates employment; (4) the participant dies while an active participant in the Plan; and (5) early retirement distribution is permitted so long as the participant is 59½ years of age and is fully vested. At the time of death, termination, or retirement, if the vested value of the participant's individual account does not exceed \$5,000, the vested balance will be automatically distributed to the participant or their beneficiary or will be distributed to an individual retirement arrangement. Distributions may be deferred to a later date if the participant's vested balance is in excess of \$5,000.

*Forfeited Accounts* – On December 31, 2024 and 2023, forfeited nonvested accounts totaled \$-0- and \$10,952, respectively. These accounts will be used to reduce future Company contributions or to pay administrative expenses of the Plan. During the year ended December 31, 2024, \$11,184 of forfeitures were used to pay administrative expenses.

### Note 2—Summary of significant accounting policies

*Basis of Accounting* – The financial statements of the Plan are based on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

*Use of Estimates* – The preparation of financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates. Significant estimates of the Plan include the estimate of the fair value of investments.

*Payment of Benefits* – Benefits are recorded when paid.

*Investment Valuation and Income Recognition* – Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

The Plan presents in the statement of changes in net assets available for benefits the net appreciation (depreciation) in the fair value of its investments which consists of the realized gains or losses and the unrealized appreciation (depreciation) on those investments. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned daily and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

*Notes Receivable from Participants* – Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

### Note 2—Summary of significant accounting policies (continued)

*Contributions Receivable* – The number of participant-related contributions that have been deducted from the participant's payroll as of the end of the year but have not been deposited with the Plan until after the end of the year is reflected as participant contributions receivable in the Plan's financial statements. In addition, any contributions due and payable by the Company are reflected as Company contributions receivable in the Plan's financial statements.

*Administrative Expenses* – Certain expenses of maintaining the Plan are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

*Recently Issued Pronouncements* – Plan management is not aware of any recently issued accounting pronouncements applicable to the Plan's financial statements.

### Note 3—Fair value measurements

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets as of the reporting date.

*Level 2* – Inputs to the valuation methodology include the following:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**Note 3—Fair value measurements (continued)**

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023:

*Money Market Funds* – Valued at cost, which approximates fair value using Level 1 inputs.

*Mutual Funds* – Valued at quoted prices in active markets based on the last reported sales price of the fund on the last day of business of the year on a national exchange using Level 1 inputs. These investments are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. These investments are classified within Level 1 of the valuation hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values, Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 4—Income tax status

The Plan is a volume submitter 401(k) profit sharing plan created by Ascensus, Inc. The IRS has determined and informed Ascensus, Inc. by a letter dated June 30, 2020, that the prototype is designed in accordance with applicable sections of the IRC. Although the Plan has not obtained an individual determination letter and has been amended since receiving Ascensus, Inc.'s opinion letter, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC and has no income subject to unrelated business income tax.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 5—Plan termination

Although, it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### Note 6—Information prepared and certified by Trustee (unaudited)

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus Trust Company, the qualified institution and Trustee has certified to the completeness and accuracy of the following data included in the accompanying financial statements:

- Investments, at fair value, and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, interest and dividend income from investments, and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

### Note 7—Parties-in-interest

During the year ended December 31, 2024, fees in the amount of approximately \$13,501 were paid to the Trustee by the Plan. Ascensus Trust Company is the Plan Trustee; therefore, the transactions qualify as party-in-interest transactions. In addition, the Company paid audit fees on behalf of the Plan during the year ended December 31, 2024, which also qualifies as a party-in-interest transaction. In addition, the Company provided certain Plan administrative services without compensation during the year ended December 31, 2024. Notes receivable from participants qualify as party-in-interest transactions.

**Note 8—Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and supplemental schedules.

**Note 9—Prohibited transactions**

During the Plan years ended December 31, 2024 and 2023, the Company failed to remit to the Plan's trustee certain employee contributions totaling \$42,773 and \$53,025, respectively, within the period prescribed by the Department of Labor regulations. Delays in remitting contributions to the trustee were due to administrative errors, and the Company has made contributions to the affected participants' accounts to compensate those participants for potential lost income due to the delays.

**Note 10—Subsequent events**

The Plan has evaluated subsequent events through October 1, 2025, which is the date the financial statements were available to be issued.
