INDEPENDENT AUDITORS' REPORT

To the Finance Committee

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Glenwood Inc. 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audits of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings and certain internal control-related matters that we identified during the audits.

Other Matter

Supplemental Schedule Required by ERISA

1. DESCRIPTION OF THE PLAN

The following description of the Glenwood Inc. 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan, which was established effective September 1, 1985, is a tax-deferred annuity plan available to qualified employees, as defined, of Glenwood Inc. (Company or Plan administrator). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Administration

The Plan is administered by the Company which, as Plan administrator, has substantial control of and discretion over the administration of the Plan. Corebridge Financial, Inc. (Corebridge) (formerly Variable Annuity Life Insurance Company (VALIC)) has been appointed as recordkeeper of the Plan. VALIC, a wholly owned subsidiary of Corebridge, is the custodian of the fixed annuity contracts and variable annuity accounts. VALIC Trust Company Inc. (VTC) is the custodian of the mutual funds held by the Plan. All assets of the Plan, with the exception of the mutual funds, are in investment plan accounts of VALIC under a group annuity contract. The Plan administrator determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

All full-time employees of the Company are immediately eligible to participate in the deferral provision of the Plan. To become eligible for the employer match, employees must have attained 21 years of age and completed 12 months of service, as defined.

Employee Contributions

As permitted under Section 403(b) of the Internal Revenue Code (IRC), participants may elect to defer a portion of their compensation to make pre-tax or after-tax (Roth) contributions up to the annual IRC limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Employer Contributions

The Company makes matching contributions to the Plan on behalf of eligible participants at a rate of 100% of elective pre-tax deferrals made by each employee who contributes at least 1% of compensation as defined by the Plan. Employer contributions shall not exceed a percentage of compensation, which is determined according to the following schedule based on months of service:

Months of Service	Employer Matching Contribution
0-12	0%
13-24	1%
25-36	2%
37-48	3%
49-60	4%
61 or more	5%

Participant Accounts

Each participant account is credited or charged with the participant's contributions and Company matching contributions, an allocation of net Plan investment earnings or losses, withdrawals and expenses. The investment earnings or losses are allocated to each participant's account in the proportion that the balance of each participant's account bears to the total balance of all participants in each investment option. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

The Plan offers an investment contract with VALIC, various insurance company separate accounts, and mutual funds as investment options for participants. Participants may elect to transfer balances between funds within their account at any time.

Vesting

Participants are immediately vested in their contributions, rollovers, Company matching contributions and related earnings thereon.

Notes Receivable from Participants

Participants may borrow from their mutual fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and may not exceed a term of five years, unless the proceeds are used for purchase of the participant's principal residence, in which case the loan may not exceed a term of 20 years. The loans bear interest at a rate that is prescribed by the Plan administrator based on periodic re-evaluations of the adequacy of such rate.

Policy Loans

Policy loans are available to participants through VALIC, subject to certain limitations. Policy loans are issued directly from funds owned by VALIC, and loan proceeds are not removed from a participant's account balance. However, a portion of a participant's account is held in a security reserve as security for the loan. The security reserve balance is made up of the loan balance, the

loan interest due with a quarterly loan payment, the reserved surrender charge, if applicable, and all interest credited to the foregoing amounts.

At December 31, 2024 and 2023, participants had active outstanding policy loan balances of \$157,904 and \$190,319, respectively. These loans are secured by the VALIC Loan Collateral Fund and the VALIC Loan Escrow.

Loans that are not repaid under the terms of the agreement are defaulted and reported in one of two ways. If a participant defaults on a loan and has reached a distributable event, the defaulted loan is considered a distribution and included in benefits paid to participants. However, if a participant defaults on the loan when the participant has not reached a distributable event, the defaulted loan is treated as a deemed distribution. In this case, the outstanding loan balance is deducted from the participant's account, and the loan collateral is held in a separate account, accruing interest until a distributable event is reached. The interest rate is based on prevailing market conditions and may be fixed or variable over the life of the loan.

Payment of Benefits

Upon termination of service due to death, disability, retirement (age 65) or separation of service, a participant may elect to receive a lump-sum amount or partial payments equal to their vested account balance in the Plan. If the vested account balance upon termination of service is \$5,000 or less, a participant's account balance will automatically be distributed from the Plan. In-service distributions at age 59½ are also allowed by the Plan if certain criteria are met.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Plan administrative expenses paid by the Plan are included in administrative expenses on the statement of changes in net assets available for benefits. Administrative expenses were paid by the Plan for asset-based fees and individually requested transactions. Certain other fees and expenses may be charged to Plan investments (as an expense ratio) and are reflected in net appreciation in fair value of investments. The Company, on behalf of the Plan, paid all other administrative expenses of the Plan, and those expenses are excluded from these financial statements.

3. INFORMATION CERTIFIED BY PLAN CUSTODIANS

Certain information related to investments disclosed in the accompanying financial statements and the ERISA-required supplemental schedule, including investments held as of December 31, 2024 and 2023, and interest and dividend income and net appreciation in fair value of investments for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by VALIC and VTC.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under

Financial Accounting Standards Board (FASB), Accounting Standards Codification (ASC) 820, *Fair Value Measurements (ASC 820)*, are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Fixed annuity contracts: The fixed annuity contracts are not actively traded, and significant other observable inputs are not available. Therefore, the fair value of the fixed annuity contracts is determined using an income approach by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer. These contracts have liquidity restrictions and are non-benefit responsive.

Variable annuity accounts: Valued based on each account's daily NAV, which is considered by Plan management to be the best approximation of fair value. Data for NAV's are distributed to Plan administrators and client investors on the qualified service providers' website and provide sufficient corroborative evidence to ascertain the relationship between each fund's NAV and the values of the individual underlying holdings. Underlying holdings, held in the VALIC separate accounts, are primarily valued using market quotations or prices obtained from independent pricing sources. There are no unfunded commitments from participants in the Plan who invest in these accounts.

The methods above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in fixed annuity contracts and variable annuity accounts held in insurance company separate accounts managed by VALIC, the custodian. The Plan paid VALIC asset-based fees charged by the separate accounts and those amounts are included within the net appreciation in fair value of investments in the statement of changes in net assets available for benefits. In addition, the Plan paid VALIC for participant-initiated transactions, which are reflected as administrative expenses in the statement of changes in net assets available for benefits. Transactions with the custodian qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

6. GROUP ANNUITY CONTRACT

The Plan entered into a Group Annuity Contract (the Contract) with VALIC, which offers fixed and variable annuity products. The fixed options are backed by the general assets of the insurance company. The variable annuities options are held in separate accounts by the insurance company as custodian of the separate accounts. The Fixed Account Plus Fund (FAP), the Short-Term Fixed Fund (STF) and the Fixed Interest Option are fixed annuity options offered under the Contract. The FAP employs a modified new money interest crediting policy. VALIC declares a current interest rate at the beginning of each month applicable to contributions received during that month. The current rate declared is guaranteed until the end of that calendar year for contributions received that month. It is the intent of VALIC, though not guaranteed, to continue to credit interest at the same rate for such contributions for an additional calendar year. At the beginning of the third calendar year, such contributions will earn interest at a new declared pool rate. This rate is established January 1 of each calendar year and guaranteed for that entire calendar year. The contractually guaranteed minimum interest rate is applicable for the lifetime of the contract. VALIC permits transfers of up to 20% per year from the FAP option. STF crediting rates are established on a portfolio basis, whereby all deposits in the option receive the same crediting rate, regardless of initial date of deposit. Once a transfer has been made into the STF account, no other transfers from this account will be permitted for 90 days. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The minimum guaranteed interest rate is 3%. The guarantees are based on VALIC's ability to meet its financial obligations from the assets of VALIC.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would remain 100% vested in their employer contributions.

8. TAX STATUS

The Company adopted a volume submitter 403(b) prototype plan document sponsored by VALIC Retirement Services Company, which received an advisory letter from the Internal Revenue Service (IRS) dated April 5, 2018, indicating that the prototype plan is designed in accordance with the applicable sections of the IRC. The Plan is required to operate in conformity with the IRC to maintain tax-exempt status for the Plan participants under Section 403(b). The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 26, 2025, which is the date the financial statements were available to be issued, and has determined there are no subsequent events which require disclosure under FASB ASC 855, *Subsequent Events*.
