Note 1. Description of Plan

The following description of CareCentrix, Inc. Retirement Savings Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established to provide certain employees of CareCentrix, Inc. (the Company) with retirement benefits in accordance with Sections 401(a) and 401(k) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Effective April 15, 2021, the Plan was amended and restated to bring the Plan into compliance with the legislative and regulatory changes set forth in the six-year pre-approved plan restatement cycle.

Eligibility

All employees of the Company, as defined, except for a resident of Puerto Rico, leased employees, those employees under a collective bargaining agreement, nonresident aliens, and non-common law employees, are eligible to participate in the Plan as soon as administratively possible following their date of hire. Part-time employees and temporary employees are eligible to participate in the Plan after completing at least 1,000 hours of service.

Participant Contributions

Eligible participants who are not highly compensated employees may make voluntary contributions through salary reductions from 1% to 90% and highly compensated employees may make voluntary contributions through salary reductions from 1% to 9% of their eligible annual pre-tax compensation, as defined by the Plan, limited to the maximum amounts allowed under the provisions of the IRC \$23,000 in 2024. Further, participants who are 50 years of age or older as of December 31, 2024, may contribute an additional "catch up" contribution \$7,500 in 2024. The Plan currently offers various mutual funds and a common collective trust as investment options for participants.

The Plan includes an automatic enrollment provision under which the Company automatically defers 4% of the participant's eligible compensation (as defined), commencing 30 days after the participant's date of hire. These deferrals are automatically invested in a T Rowe Price Retirement Fund based on the participant's age at the time of enrollment. Participants may cancel, modify, or otherwise change any of the automatic elections.

The Plan also allows participants to make after-tax contributions. These deferrals are subject to federal income taxes, and the maximum allowable combined contributions of the after-tax deferrals and pre-tax deferrals is determined by provisions of the IRC \$23,000 in 2024.

Employer Contributions

The Company may make discretionary matching contributions on behalf of each participant enrolled in the Plan who has been credited with one year of service, as defined in the plan document. For the plan year ended December 31, 2024, the matching contribution was equal to 50% of a participant's contribution up to 6% of eligible compensation. For the plan year ended December 31, 2024, matching contributions totaled \$2,770,980. The Company may also make a discretionary non-elective contribution on behalf of those participants who are employed on the last day of the plan year. There was no discretionary contribution for the year ended December 31, 2024.

Participants' Accounts

Each participants' account is credited with its respective contributions and its allocation of (a) employer contributions and (b) Plan earnings or losses.

Vesting

Participants' voluntary contributions, rollover contributions, and earnings thereon vest immediately. Participants vest in employer contributions ratably over five years, as defined, beginning with the first year of service. In the event of death, disability, or attainment of age 65, participants' accounts become fully vested.

Payment of Benefits

Upon termination of employment, retirement, death, or disability, the participant or the participant's beneficiary is entitled to receive the vested portion of the participant's account in a single lump-sum, installment or partial withdrawals. Participants may take withdrawals of their after-tax contributions and/or rollover contributions and earnings thereon at any time. Further, withdrawals of pre-tax contributions before leaving the Company are available after attaining the age of 59 ½ or for special "hardship" reasons (as defined). Such withdrawals are only permitted after the participant has withdrawn all amounts in his or her account attributable to after-tax contributions. Distributions to participants are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Participants may borrow up to 50% of their vested account balance up to a maximum of \$50,000. Participant loans are subject to the approval of the plan administrator and the interest rate is set periodically to be in line with current market rates for similar types of loans. Loan terms range from one to five years. However, if the loan is to acquire the principal residence of the participant, the term may be extended. Loans are secured by the balance in the participant's account. Principal and interest is paid ratably through payroll deductions.

Forfeitures

The Plan provides that forfeitures, the unvested portion of employer contributions for terminated participants, may serve to reduce future Company contributions or plan expenses. As of December 31, 2024 and 2023, the balance in the forfeiture account was \$62,794 and \$30,686, respectively. Forfeitures totaling \$235,000 were used to reduce Company contributions during the year ended December 31, 2024.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan determines its valuation policies utilizing information provided by the trustee. See Note 8 for discussions of fair value measurements.

Realized gains and losses on investments sold and the unrealized appreciation and depreciation of investments held are reported on an average current cost basis, based on fair market value of the investments at the beginning of the plan year or at the time of purchase during the plan year. Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits.

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Plan or the Company, as provided in the Plan document.

Subsequent Events

Subsequent events have been evaluated through September 10, 2025, which is the date the financial statements were available to be issued.

Note 3. Certification of Plan Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, (Fidelity), a qualified institution, has certified the following investment and notes receivable from participants information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income on notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by FMR LLC. This prototype plan document has been filed with the appropriate agency and has obtained a favorable opinion letter dated June 30, 2020 from the IRS stating that the plan constitutes a qualified plan under section 401 of the Internal Revenue Code and that the related trust was tax-exempt as of the financial statement date. The Plan has been amended since issuance of the opinion letter.

However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, or a person who owns more 50% or more or such an employer or employee association or relatives of such persons.

Certain Plan investments are shares of mutual funds and a common collective trust managed by Fidelity. Fidelity is the trustee, as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rules, as defined by ERISA.

The Plan paid \$87,851 of recordkeeping fees to Fidelity during the years ended December 31, 2024. The Company provides certain administrative services at no cost to the Plan.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event that the Plan and the related trust terminate, all accounts will be valued as of the termination date, participants will become 100% vested in their accounts, and the account balances will be distributed in full to participants.

Note 7. Risks and Uncertainties

The Plan provides for various investment options in accounts which invest in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that these changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Note 8. Disclosures About Fair Value of Plan Assets and Liabilities

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

Level 1 - Quoted prices in active markets for identical assets or liabilities

Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. The Plan had no Level 2 or Level 3 investments at December 31, 2024 and 2023.

Note 10. Voluntary Correction Program

The Company filed a Voluntary Correction Program (VCP) submission with the IRS during 2023 to address issues noted with contributions limits of highly compensated employees for the 2015-2022 plan years and the calculation of matching contributions for certain employees for 2016-2022 plan years. The plan sponsor has disclosed the error to the Internal Revenue Service ("IR) via the Voluntary Correction Program (VCP). The Plan sponsor has received approval of the VCP from the IRS in August 2023.

All corrective action was taken by the Plan Sponsor during 2023. The corrective balance amounted to approximately \$34,905 along with gains amounting to approximately \$4,681, which were funded through forfeitures during 2023.

None of these items had a material impact on the Plan's net assets available for benefits and has no effect on the Plan's tax status.

Note 1. Description of Plan

The following description of CareCentrix, Inc. Retirement Savings Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established to provide certain employees of CareCentrix, Inc. (the Company) with retirement benefits in accordance with Sections 401(a) and 401(k) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Effective April 15, 2021, the Plan was amended and restated to bring the Plan into compliance with the legislative and regulatory changes set forth in the six-year pre-approved plan restatement cycle.

Eligibility

All employees of the Company, as defined, except for a resident of Puerto Rico, leased employees, those employees under a collective bargaining agreement, nonresident aliens, and non-common law employees, are eligible to participate in the Plan as soon as administratively possible following their date of hire. Part-time employees and temporary employees are eligible to participate in the Plan after completing at least 1,000 hours of service.

Participant Contributions

Eligible participants who are not highly compensated employees may make voluntary contributions through salary reductions from 1% to 90% and highly compensated employees may make voluntary contributions through salary reductions from 1% to 9% of their eligible annual pre-tax compensation, as defined by the Plan, limited to the maximum amounts allowed under the provisions of the IRC \$23,000 in 2024. Further, participants who are 50 years of age or older as of December 31, 2024, may contribute an additional "catch up" contribution \$7,500 in 2024. The Plan currently offers various mutual funds and a common collective trust as investment options for participants.

The Plan includes an automatic enrollment provision under which the Company automatically defers 4% of the participant's eligible compensation (as defined), commencing 30 days after the participant's date of hire. These deferrals are automatically invested in a T Rowe Price Retirement Fund based on the participant's age at the time of enrollment. Participants may cancel, modify, or otherwise change any of the automatic elections.

The Plan also allows participants to make after-tax contributions. These deferrals are subject to federal income taxes, and the maximum allowable combined contributions of the after-tax deferrals and pre-tax deferrals is determined by provisions of the IRC \$23,000 in 2024.

Employer Contributions

The Company may make discretionary matching contributions on behalf of each participant enrolled in the Plan who has been credited with one year of service, as defined in the plan document. For the plan year ended December 31, 2024, the matching contribution was equal to 50% of a participant's contribution up to 6% of eligible compensation. For the plan year ended December 31, 2024, matching contributions totaled \$2,770,980. The Company may also make a discretionary non-elective contribution on behalf of those participants who are employed on the last day of the plan year. There was no discretionary contribution for the year ended December 31, 2024.

Participants' Accounts

Each participants' account is credited with its respective contributions and its allocation of (a) employer contributions and (b) Plan earnings or losses.

Vesting

Participants' voluntary contributions, rollover contributions, and earnings thereon vest immediately. Participants vest in employer contributions ratably over five years, as defined, beginning with the first year of service. In the event of death, disability, or attainment of age 65, participants' accounts become fully vested.

Payment of Benefits

Upon termination of employment, retirement, death, or disability, the participant or the participant's beneficiary is entitled to receive the vested portion of the participant's account in a single lump-sum, installment or partial withdrawals. Participants may take withdrawals of their after-tax contributions and/or rollover contributions and earnings thereon at any time. Further, withdrawals of pre-tax contributions before leaving the Company are available after attaining the age of 59 ½ or for special "hardship" reasons (as defined). Such withdrawals are only permitted after the participant has withdrawn all amounts in his or her account attributable to after-tax contributions. Distributions to participants are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Participants may borrow up to 50% of their vested account balance up to a maximum of \$50,000. Participant loans are subject to the approval of the plan administrator and the interest rate is set periodically to be in line with current market rates for similar types of loans. Loan terms range from one to five years. However, if the loan is to acquire the principal residence of the participant, the term may be extended. Loans are secured by the balance in the participant's account. Principal and interest is paid ratably through payroll deductions.

Forfeitures

The Plan provides that forfeitures, the unvested portion of employer contributions for terminated participants, may serve to reduce future Company contributions or plan expenses. As of December 31, 2024 and 2023, the balance in the forfeiture account was \$62,794 and \$30,686, respectively. Forfeitures totaling \$235,000 were used to reduce Company contributions during the year ended December 31, 2024.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan determines its valuation policies utilizing information provided by the trustee. See Note 8 for discussions of fair value measurements.

Realized gains and losses on investments sold and the unrealized appreciation and depreciation of investments held are reported on an average current cost basis, based on fair market value of the investments at the beginning of the plan year or at the time of purchase during the plan year. Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits.

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Plan or the Company, as provided in the Plan document.

Subsequent Events

Subsequent events have been evaluated through September 10, 2025, which is the date the financial statements were available to be issued.

Note 3. Certification of Plan Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, (Fidelity), a qualified institution, has certified the following investment and notes receivable from participants information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income on notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by FMR LLC. This prototype plan document has been filed with the appropriate agency and has obtained a favorable opinion letter dated June 30, 2020 from the IRS stating that the plan constitutes a qualified plan under section 401 of the Internal Revenue Code and that the related trust was tax-exempt as of the financial statement date. The Plan has been amended since issuance of the opinion letter.

However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, or a person who owns more 50% or more or such an employer or employee association or relatives of such persons.

Certain Plan investments are shares of mutual funds and a common collective trust managed by Fidelity. Fidelity is the trustee, as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rules, as defined by ERISA.

The Plan paid \$87,851 of recordkeeping fees to Fidelity during the years ended December 31, 2024. The Company provides certain administrative services at no cost to the Plan.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event that the Plan and the related trust terminate, all accounts will be valued as of the termination date, participants will become 100% vested in their accounts, and the account balances will be distributed in full to participants.

Note 7. Risks and Uncertainties

The Plan provides for various investment options in accounts which invest in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that these changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Note 8. Disclosures About Fair Value of Plan Assets and Liabilities

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

Level 1 - Quoted prices in active markets for identical assets or liabilities

Level 2 - Observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities

Level 3 - Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. The Plan had no Level 2 or Level 3 investments at December 31, 2024 and 2023.

Note 10. Voluntary Correction Program

The Company filed a Voluntary Correction Program (VCP) submission with the IRS during 2023 to address issues noted with contributions limits of highly compensated employees for the 2015-2022 plan years and the calculation of matching contributions for certain employees for 2016-2022 plan years. The plan sponsor has disclosed the error to the Internal Revenue Service ("IR) via the Voluntary Correction Program (VCP). The Plan sponsor has received approval of the VCP from the IRS in August 2023.

All corrective action was taken by the Plan Sponsor during 2023. The corrective balance amounted to approximately \$34,905 along with gains amounting to approximately \$4,681, which were funded through forfeitures during 2023.

None of these items had a material impact on the Plan's net assets available for benefits and has no effect on the Plan's tax status.
