### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of PKF O'Connor Davies 401(k) Savings & Retirement Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### ***Responsibilities of Management for the Financial Statements***

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**1. Description of Plan**

The following description of the PKF O'Connor Davies 401(k) Savings and Retirement Plan (the "Plan") is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions. The Plan was amended on November 18, 2024, updating the plan sponsor to PKFOD Management Company LLC.

***General and Eligibility***

The Plan is a defined contribution plan covering substantially all full-time employees of PKFOD Management Company LLC (the "Company" or "Employer"), excluding collectively bargained employees, non-resident aliens, leased employees, college intern and consultants. To become eligible for employee contributions, an employee must be 21 years or older and completed three months of service. To become eligible for employer contributions, employee must be 21 years or older and completed one year of service. An employee can enter the Plan on the first day of the month coincident with or following the date he or she satisfies the minimum age and service requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

***Contributions***

Each year, participants may elect to have a percentage or specified dollar amount deducted from their compensation as defined by the Plan. Participant contributions may be deducted in "pre-tax" dollars for the 401(k) and "post-tax" dollars for the Roth 401(k). Participants who have attained age of 50 before the end of the Plan year are eligible to make catch-up contributions. Rollover contributions are subject to the terms of the Plan and are fully vested and non-forfeitable. A participant may elect to increase, decrease or suspend deductions according to procedures established by the Company. There is an annual limit as to the amount that can be deducted from compensation that is determined by the Internal Revenue Code ("IRC").

The Plan includes an automatic deferral feature under which newly eligible employees are automatically enrolled to make pre-tax contributions into the Plan at a rate of 4% of compensation, unless the employee elects otherwise, and their accounts under the Plan are automatically invested in accordance with the Plan's investment policies. There is an auto escalation feature in which a participant's contributions will increase by 1% each year until reaching 6% of their eligible compensation.

The Company may elect to make a discretionary contribution to participants of the Plan. For the year ended December 31, 2024, the discretionary contribution to employees was 3% of eligible compensation for employees. Partners may receive the maximum contribution based on the maximum earning base determined by the IRC.

***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of (a) the Employer's contributions and (b) allocations of Plan earnings (losses) thereon and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants direct the investment of their balances into various investment options offered by the Plan. If the participant does not make an investment election, the participant accounts are automatically invested in the Plan's Qualified Default Investment Alternative ("QDIA"). The Plan has elected the T. Rowe Price Retirement Trust Series as its QDIA.

***Vesting***

A participant is 100% vested in their contributions plus allocated earnings thereon at all times. Vesting in the Employer's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested either after completing six years of credited service, or upon reaching normal retirement age, death or disability prior to termination of employment.

***Forfeitures***

If a participant terminates their employment with the Company, the non-vested contributions plus allocated earnings thereon may be used to reduce future Employer contributions or Plan expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$17,762 and \$82,739. Forfeitures from participants approximated \$277,551. During 2024, \$253,066 in forfeitures were used to reduce Employer contributions and \$140,318 of forfeitures were used to reduce Plan expenses.

***Revenue Credit Account***

The Plan and Transamerica Financial Life Insurance Company have entered into a revenue sharing arrangement whereby a portion of the revenue earned by the custodian from certain funds is passed through to the Plan for payment of permitted plan expenses. In order for the Plan to receive credits as a result of this revenue sharing arrangement, and to use this credit to pay Plan expenses, the Company created the Revenue Credit Account under the Plan. The Revenue Credit Account is a cash account within the Plan, similar in design to forfeiture accounts, and is used to record keep the redistribution of Plan-generated fund revenue that exceeds the costs associated with Plan administration. The Revenue Credit Account balance was \$59,084 and \$44,168 at December 31, 2024 and 2023, respectively. During 2024, the Plan received \$361,637 from the revenue sharing arrangement. Expenses paid by the Plan were reduced by \$201,805 from the Revenue Credit Account.

***Payment of Benefits***

Upon termination of service due to death, disability or retirement or other reason, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account, or annual installments. Participants are permitted to receive in-service withdrawals upon attainment of age 59 ½ or as a hardship distribution, as defined in the plan document.

***Notes Receivable from Participants***

Participants may borrow from their account balance a minimum amount of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear prime interest rate plus 1%. Loans must be repaid within five years. If the loan is used to purchase a participant's principal residence, the maturity date of the loan may be extended beyond five years. Principal and interest is paid ratably through payroll deductions.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accounts of the Plan are maintained, and the accompanying financial statements have been prepared, on the modified cash basis, which is an accepted method under the Department of Labor's Rules and Regulations; investment income and contributions are recognized when received and disbursements and expenses are recognized when paid. In accordance with the modified cash basis, investments are recorded at fair value. Accordingly, the financial statements are not intended to present the net assets available for benefits and changes in net assets available for benefits of the Plan in conformity with generally accepted accounting principles in the United States of America ("U.S. GAAP").

***Use of Estimates***

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, investments where fair value is measured using the Net Asset Value ("NAV") per share as a practical expedient are not categorized within the fair value hierarchy.

***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. Mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the mutual funds are open-ended and are registered with the Securities and Exchange Commission. These mutual funds are required to publish their daily NAV and to transact at that price. The common/collective trusts are valued at the NAV of units held by the Plan. The NAVs, as provided by the trustees, are used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the funds less their liabilities. The practical expedient is not used when it is determined to be probable that a fund will sell the investment for an amount different than the reported NAV.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded when received. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are paid. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

***Payment of Benefits***

Benefits are recorded when paid.

***Expenses***

Expenses of maintaining the Plan are paid directly by the Plan and are included in these financial statements, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the NAV of the respective investment vehicles and, consequently, those expenses are not separately reflected but are a component of net appreciation in fair value of investments.

***Subsequent Events Evaluation by Management***

The Plan has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 2, 2025.

**3. Information Certified (Unaudited)**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements (modified cash basis) and ERISA-required supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) (modified cash basis) including investments and notes receivable from participants held at December 31, 2024 and 2023, and the net appreciation in value of investments, dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company and Transamerica Trust Company, qualified institutions.

## 5. Tax Status

The Internal Revenue Service (“IRS”) issued an opinion letter to the prototype plan document preparer, Compass 360 LLC, dated June 30, 2020, which states that the form of the prototype plan qualifies under the applicable provisions of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

**6. Party-in-Interest Transactions**

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits (modified cash basis).

UBS Financial Services Inc. is the investment advisor and broker of the Plan's investments and, therefore, certain transactions qualify as exempt party-in-interest transactions. Fees of \$210,269 were paid to UBS Financial Services Inc. from the Plan during the year ended December 31, 2024.

FuturePlan by Ascensus was the third-party administrator of the Plan through December 31, 2023 and Compass 360 LLC through December 31, 2024 and, therefore, certain transactions qualify as exempt party-in-interest transactions. Administrative fees of \$28,646 were paid to FuturePlan by Ascensus and \$111,675 to Compass 360 LLC from the Plan during the year ended December 31, 2024.

Transamerica Retirement Solutions, LLC is the recordkeeper of the Plan and, therefore, certain transactions qualify as exempt party-in-interest transactions. Administrative fees of \$309,346 were paid to Transamerica Retirement Solutions, LLC from the Plan during the year ended December 31, 2024.

Audit fees paid from the Plan for 2024 were \$37,625 and are included in administrative expenses.

**7. Plan Termination**

Although it has not expressed any intention to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants would become 100% vested in their Employer contributions.

**8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits (modified cash basis).
