## **REPORT OF INDEPENDENT CERTIFIED PUBLIC ACCOUNTANTS**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of The Acutronic Company 401(K) Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Acutronic Company 401(K) Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### **Opinion**

### (1) DESCRIPTION OF PLAN

The following description of The Acutronic Company 401(K) Retirement Savings Plan (the “*Plan*”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### **GENERAL**

The Plan is a safe harbor 401(k) defined contribution plan covering all eligible employees of The Acutronic Company and its subsidiaries, Acutronic USA Inc., Acutronic Turbines Inc., Acutronic Power Systems Inc. and Acutronic Actuation Inc., (collectively the “*Company*”). The Plan was established and originally effective April 1, 1990 to provide eligible employees of the Company the opportunity to accumulate savings that provide benefits in the event of retirement, disability or death. The Plan has been amended and restated to comply with the latest regulations of the Internal Revenue Code. The Plan is structured to comply with the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Company retains Empower Annuity Insurance Company of America as the Trustee to maintain the assets of the Plan and Baker Tilly as the third party administrator to perform record keeping.

#### **ELIGIBILITY**

Certain nonresident aliens, leased employees, co-ops and interns, as well as union employees governed by a collective bargaining agreement (unless the agreement states otherwise) are excluded from the Plan. All other employees who have attained the age of 18 are eligible to become members of the Plan at their date of hire.

#### **CONTRIBUTIONS**

Every year, participants may contribute a percentage of annual compensation, as defined in the Plan document. Contributions are subject to limitations to comply with the requirements of the Internal Revenue Code. The Company makes discretionary safe harbor matching contributions equal to 100% of employee contributions up to 3% of eligible compensation, and 50% of employee contributions from 3% to 5% of eligible compensation, capped at a maximum match of 4% for employee deferrals of 5% or greater. Matching contributions are funded with each payroll. Participants are immediately vested in the matching contributions. The Company may also make annual discretionary profit-sharing contributions to eligible employees who have completed at least 1,000 hours of service. No profit-sharing contributions were made in 2024.

#### **PARTICIPANT ACCOUNTS**

Each participant’s account is credited with the participant’s contribution, an allocation of Company contributions and investment results and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### **VESTING**

Participants are immediately vested in their contributions, safe harbor matching contributions, rollover contributions and actual earnings thereon. Vesting in the Company profit-sharing contributions are based on years of continuous service. Profit-sharing contributions are not vested during an employee’s first two years of service. Any such contributions vest on the third anniversary of an employee’s hire date.

### ***PARTICIPANT LOANS***

Participants may borrow from their fund accounts a minimum of \$1,000 of their vested account balance. Loan terms range from one to five years. Loans are secured by the balance in the participant's account and accrue interest at a rate equivalent to the Prime Rate plus 1%. As of December 31, 2024, the interest rate for the loans ranged from 4.25% to 9.5%. Principal and interest are paid ratably through bi-weekly payroll deductions. In the event of retirement, death, disability or termination of employment, the loan becomes payable in full.

### ***FORFEITURES***

Upon termination from service, the non-vested portion of a participant's account is forfeited. Forfeitures will be used to pay plan expenses and reduce employer contributions. The balance in the forfeiture account was \$6,367 and \$6,223 as of December 31, 2024 and 2023, respectively.

### ***PAYMENT OF BENEFITS***

Upon retirement, disability or termination, a participant must consent to receive a lump-sum amount equal to the value of the vested interest in his or her account, if the account balance is at least \$5,000. Empower Annuity Insurance Company of America will automatically distribute balances of terminated participants that do not exceed \$1,000. A participant who has reached age 59½ may elect to withdraw all or a portion of their entire account while still employed by the Company. Participants may take hardship withdrawals in accordance with Plan provisions to satisfy an immediate and heavy financial need as defined by the Plan. Upon the death of a participant, the participant's beneficiary shall be entitled to the balance of the participant's account.

## (2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### ***BASIS OF ACCOUNTING***

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Empower Annuity Insurance Company of America guaranteed interest accounts are considered fully benefit responsive, and are presented at contract value as of December 31, 2024 and 2023.

### ***USE OF ESTIMATES***

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***INVESTMENT VALUATION AND INCOME RECOGNITION***

The Plan's investments in mutual funds are stated at fair value. Fair value is the price that would be received for the sale of an asset or paid for the transfer of a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Net realized and unrealized gains include the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***PAYMENT OF BENEFITS***

Benefits are recorded when paid.

### ***ADMINISTRATIVE EXPENSES***

Costs associated with participant-initiated transactions are paid by the respective participants' accounts. Administrative expenses of the Plan are partially paid by the Plan and partially absorbed by the Plan sponsor.

The Plan has a group annuity contract with Empower Annuity Insurance Company of America, wherein the participants of the Plan may direct the investments of their contributions to Empower Annuity Insurance Company of America guaranteed interest accounts or mutual funds. Contributions directed to the guaranteed interest account are invested in Empower Annuity Insurance Company of America general accounts and are guaranteed as to principal and interest; however, market value adjustments may apply on early withdrawals. The guaranteed interest rate applicable to these deposit accounts is determined each month by Empower Annuity Insurance Company of America. Contributions directed to mutual funds are segregated from other assets of Empower Annuity Insurance Company of America as required by law and are managed by unaffiliated registered investment companies.

### (4) FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

**Mutual Funds:** Valued at the net asset value (*NAV*), as provided by the respective registered investment companies, of shares held by the Plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### (6) PARTY-IN-INTEREST TRANSACTIONS

The Company has not considered normal Plan operations such as participant and employer contributions or benefits paid to participants as party-in-interest transactions that require separate disclosure. Certain Plan investments are in guaranteed interest accounts managed by Empower Annuity Insurance Company of America, the Trustee. Fees paid during the year for professional services rendered by parties in interest were based on customary and reasonable rates for such services and partially absorbed by the employer. Participant loan origination fees are paid out of the relevant participants' accounts. These transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rules.

### (7) PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the employer may determine. In the event of Plan termination, participants will become fully vested in their account balances.

### (8) TAX STATUS

The Plan is designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code. The Plan's federal forms 5500 are subject to examination by the IRS and the Department of Labor generally for the three years after they were filed.

Management has reviewed the tax positions for each of its open tax years (2021 – 2023) or expected to be taken in the Plan's 2024 tax return and has concluded that there are no uncertain tax positions that would require recognition in the financial statements.

### (9) RISKS AND UNCERTAINTIES

The Plan invests in various registered investment companies and guaranteed interest accounts. These investments are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in their values will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### (10) SUBSEQUENT EVENTS

The Plan's policy is to evaluate events and transactions subsequent to its year end for potential recognition in the financial statements or disclosure in the notes to the financial statements. All events have been evaluated through September 11, 2025, which is the date the financial statements were available to be issued.
