Opinion

We have audited the accompanying financial statements of Select Sires, Inc. 401(k) Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

DESCRIPTION OF PLAN

The following brief description of the Select Sires, Inc. 401(k) Plan and Trust (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General

The Plan is a defined contribution retirement plan sponsored by Select Sires, Inc. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Beginning January 1, 1999, the Plan was opened to participation by other Select Sires members. Several of the Select Sires members have participated in the past, but have since left the plan. For the years ended December 31, 2024 and 2023, in addition to the Select Sires employees, the Plan also covers employees of Minnesota Select Sires (collectively the Plan Sponsors). As a result, it is considered to be a multiple employer plan.

In October 2023, Minnesota Select Sires merged with 3 other cooperatives to become Select Sires Members Cooperative and as a result the board of Select Sires Members Cooperative elected to separate from the Plan effective December 29, 2023 when these participants will be eligible for their plan. There were rollovers from the Plan to the Select Sires Members Cooperative Plan of \$6,103,813 in January 2024.

Effective July 1, 2017, Select Sires, Inc. acquired the assets of Tri-State Breeders Cooperative, doing business as Accelerated Genetics and Subsidiaries ("Accelerated Genetics"), at which time the Plan was amended to allow employees of Accelerated Genetics to be eligible to participate.

In August 2023, the plan sponsor signed a letter of intent to merge with another company. Management has not yet determined what impact, if any, this will have on the plan.

Eligibility

An employee shall be eligible to participate in the Plan on the entry date (if employed) coincident with the date of completion of one year of service and attainment of age 19½.

Contributions

To participate in the Plan, an eligible employee must enter into a contribution agreement with the employer authorizing the employer to deduct and withhold from such employee's compensation a specified amount, or percentage thereof, ranging from 1% to 50%, and to contribute such amount to the employee's account in the Plan. Participant contributions are immediately vested. Any employer may make discretionary and/or non-discretionary contributions to the Plan. Employer contributions are 100% vested after 3 years of service.

In accordance with Section 401(k) of the Internal Revenue Code, all amounts withheld from compensation and contributed to a participant's account, up to the maximum allowed, shall be excluded from gross income of the participant for federal income tax purposes.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions in any of the 27 investment options. Participants may change their investment options any time. The Plan Sponsors continually monitor the investment options and may make changes from time to time in an effort to provide the best return for the participants.

Payment of Benefits

The form of payment under the Plan may be a lump sum distribution or periodic installment payments over less than ten years. A participant's account shall be payable to him or her, or in the event of death to a beneficiary, upon the earlier of disability, termination of employment or retirement date. Retirement date is upon attainment of age 65 or age 55 with at least five years of service.

Administrative Expenses

The Plan's administrative expenses are paid either by the Plan or the Plan Sponsors as provided by the Plan document. The Plan Sponsors absorb or reimburse the Plan for the majority of the administrative expenses.

Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum of \$50,000 or 50% of their vested account balance for a maximum of five years unless for a primary residence, for which the maximum is 15 years. The loans are secured by the balance in the participant's account and bear interest at local prevailing rates as determined by the Plan administrator.

Forfeited Accounts

Forfeitures represent the non-vested portion of employer contributions to accounts of former participants. The balance in the account at December 31, 2024 and 2023 was \$24,379 and \$12,309, respectively. These accounts are used to offset future employer matching contributions or to offset administrative fees. During the years ended December 31, 2024 and 2023, \$25,697 and \$26,141 respectively, of forfeitures were used to offset administrative fees.

Plan Amendments or Terminations

The Plan Sponsors reserve the right at any time to amend or terminate the Plan, provided that no such amendment or termination shall have the effect of giving the Plan Sponsors any right, or of reducing the rights of any participant, in the funds then held by the Trustee. No amendment to the Plan shall have the effect of eliminating or reducing a retirement benefit, or eliminating an optional form of benefit with respect to benefits attributable to service before the amendment.

SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The financial statements of the Plan are prepared on the accrual basis of accounting. Following are the significant accounting policies adopted by the Plan and used in the preparation of these financial statements:

Investment Valuation and Income Recognition

Investments in mutual funds are recorded at fair value based upon quoted market prices at year end. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Cost of investments is determined using the average cost basis and is used when determining realized gains and losses upon disposition.

The common collective trust is valued at its net asset value per share (NAV), as reported in the trust's audited financial statements. The NAV is based on the fair value of the underlying investments held by the trust less its liabilities, is readily determinable and available on a daily basis. Transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in

order to ensure that securities liquidations at the then current NAV will be carried out in an orderly business manner. The common collective trust has a daily redemption frequency, a redemption notice period of one year and no unfunded commitments.

Contributions

Contributions are recorded as earned on the accrual basis when withheld from the participant's earnings and when discretionary contributions are allocated by the Plan Sponsors.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of the financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Although these estimates are based on the Plan administrator's knowledge of current events and actions it may undertake in the future, they may ultimately differ from actual results.

Risks and Uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate and market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes would materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

PARTY-IN-INTEREST TRANSACTIONS

Matrix Trust Company and Milliman, Inc. provide investment and record-keeping services to the Plan. BHM CPA Group, Inc. serves as the Plan's auditor. As a result, transactions with these parties qualify as party-in-interest transactions.

Certain administrative functions are performed by officers or employees of the Plan Sponsors. No such officer or employee received compensation from the Plan. Certain administrative expenses of the Plan are paid directly by the Plan Sponsor and are not charged to the Plan.

REPORTABLE TRANSACTIONS

The Plan's assets are participant-directed, and thus, the schedule of reportable transactions is not required.

INCOME TAX STATUS

The Select Sires, Inc. 401(k) Plan and Trust became effective May 1, 1997. In its most recent determination letter, dated April 22, 2004, the Internal Revenue Service informed the Plan administrator and Plan Sponsors that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code. The Plan administrator and trustees are not aware of any provision, action or event that has occurred that might affect the Plan's qualified status.

The Plan complies with Accounting Standards Codification (ASC) 740-10 related to uncertain tax positions. This standard prescribes a recognition threshold and measurement attribute for financial statement recognition and measurement of a tax position taken or expected to be taken on a tax return. Plan administration is not aware of any tax positions taken by the Plan that it considers to be uncertain. Tax returns for the years ended 2021, 2022 and 2023 are open and subject to examination by the Internal Revenue Service.

FAIR VALUE MEASUREMENTS

The Plan complies with ASC 820, *Fair Value Measurements and Disclosures*, to account for and report fair value. ASC 820 provides a single definition of fair value, a framework for measuring fair value and expanded disclosures concerning fair value. It also defines fair value as the price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date.

Fair value of certain assets and liabilities are determined based on the fair value hierarchy, which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. Observable inputs are inputs that reflect the assumptions market participants would use in pricing the asset or liability developed based on the best information available in the circumstances. The standard describes three levels within its hierarchy that may be used to measure fair value which are:

Level 1

Values are based on unadjusted quoted prices in active markets for identical assets or liabilities.

Level 2

Values are based on quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3

Values are generated from unobservable inputs that are supported by little or no market activity and that are a significant component of the fair value of the assets or liabilities. These unobservable inputs would reflect management's estimates of assumptions that market participants would use in pricing related assets or liabilities. Valuation techniques might include the use of pricing models, discounted cash flow models or similar techniques.

A financial asset or liability's classification within the hierarchy is determined based on the lowest level input that is significant to the fair value measurement. The assessment of the significance of a particular input to the fair value measurement requires judgment, and may affect the classification of fair value assets and liabilities within the fair value hierarchy levels.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
