## INDEPENDENT AUDITOR'S REPORT

**A. Description of the Plan**

The following description of the North Country Business Products, Inc. ("Company") 401(k) Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** – The Plan is a defined contribution plan covering all employees of North Country Business Products, Inc. (the Company). Employees who are age 21 or older who have completed at least one month of service subsequent to October 1, 2021 are eligible to participate.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees oversees governance of the Plan. The Plan's management determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees. The record keeper maintains records of participant data and the custodian holds Plan assets.

**Contributions** – Participants may make (a) pre-tax contributions to the traditional 401(k) Plan, and/or (b) after-tax contributions to the Roth 401(k) Plan of any amount of gross pay up to the maximum dollar amount allowed by the law for the Plan year. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

The Company will match 50% of employee 401(k) contributions up to 3% of compensation. Thus, the maximum Company match is limited to 1.5% of a participant's gross earnings. In addition, the Company may make discretionary non-elective contributions to the Plan which will be allocated to each participant's account based on their individual compensation as a percentage of total compensation, although the Company is not required to do so. During the years ended December 31, 2024 and 2023, the Company did not make any non-elective contributions.

**Rollovers** – Participants may elect to rollover amounts from other qualified plans or individual retirement accounts into the Plan, provided that certain conditions are met.

**Participant Accounts** – Each participant's account is credited with the participant's contributions and allocations of (a) the Company's matching contribution, (b) Plan earnings (losses), and (c) charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Concentrations of Credit Risk** – The Plan maintains its cash in a deposit account, the balance of which is periodically in excess of federally insured limits. However, no losses have been experienced in such accounts.

**Vesting** – Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching contribution portion of their accounts plus actual earning thereon is based on years of service. A year of service is considered 1,000 hours, and a participant is 100% vested after six years of credited service according to the Plan document, or immediately if employment is terminated due to death, disability, or retirement upon attainment of normal retirement age.

**Investment Options** – The Plan offers a variety of pooled separate accounts with varying general investment objectives and degrees of risk. Participants enrolled in the Plan may direct deferrals and employer contributions in any of the funds offered by the Plan. Participants may change investment options during the year by logging into the ADP website.

**Forfeited Accounts** – If participants terminate employment with the Company prior to being 100% vested in their account balance, they forfeit the non-vested interest in such account balance. Such forfeitures may be used to pay Plan expenses and if any forfeitures are remaining they can be used to offset other employer contributions under the Plan. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$8,965 and \$5,217, respectively. Also, in 2024 and 2023, employer contributions were reduced by \$0 and \$1,719, respectively, from forfeited non-vested accounts. There were supplemental administrative service fees paid from forfeited non-vested accounts of \$0 and \$1,124 in 2024 and 2023, respectively.

**Payment of Benefits** – Upon retirement, termination of employment, disability or death, a participant or his or her beneficiary in the event of death, may elect to receive either a lump-sum payment, a partial lump-sum payment, or installment payments in an amount up to the value of the vested interest in his or her account, less any applicable tax withholdings and fees. Employees may elect in-service withdrawals of vested account balances upon attaining age 59 ½. Generally, certain minimum distributions are required for participants who have separated from service and have reached the required age. The Plan does allow for hardship withdrawals, subject to account balance limits and applicable laws.

Terminated participants with account balances of \$7,000 or less will receive a lump-sum cash payment as soon as administratively practicable upon the participant's employment termination.

**Notes Receivable from Participants** – The Plan was amended on October 1, 2021 to allow for participant loans. Subsequent to this amendment, participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance minus the highest total outstanding Plan loan balance in the 12 months immediately before the date of the participant’s new loan. Participants may have up to two outstanding loans. The loans are issued directly from fund balances in the participant’s account. These loans are included in the statements of net assets available for benefits. All notes are secured by the balance in the participant’s account and bear reasonable interest rates, established by MN Life Insurance Company (9% to 9.5% in 2024 and 2023). Loan payments are made through monthly ACH withdrawals directly from participants’ bank accounts, amortized over a period not exceeding five years, except in the purchase of a primary residence. Loans outstanding, including any accrued interest, at December 31, 2024 and 2023 totaled \$185,937 and \$111,682, respectively.

**B. Summary of Significant Accounting Policies**

**Basis of Accounting** – The financial statements of the Plan are prepared using the accrual basis of accounting.

**Use of Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

**Notes Receivable from Participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant’s account, are deducted from the loan proceeds when the loan is originated. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan Administrator deems the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. Total deemed distributions of participant loans for the years ended December 31, 2024 and 2023 were \$5,131 and \$0, respectively.

**Investment Valuation and Income Recognition** – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s management determines the Plan’s valuation policies utilizing information provided by the custodian. See Note G for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions** – Contributions from Plan participants and Company contributions are recorded in the year in which the employee contributions are withheld from compensation.

**Administrative Expenses** – The Plan's expenses are paid by either the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. The Third-Party Administrator charges participant fees of \$60 for each withdrawal and \$150 processing fee for each new loan. The expenses to maintain participants' accounts within the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation (depreciation) in fair value of investments.

**Excess Contributions Payable** – Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions. There were no excess contributions payable for the years ended December 31, 2024 and 2023.

**Payment of Benefits** – Benefit payments to participants are recorded when paid. At December 31, 2024 and 2023, there were no benefit claims payable for distributions to participants who have requested a distribution from the Plan prior to the end of the Plan year.

**Date of Management's Review** – Subsequent events were evaluated through September 23, 2025, which is the date the financial statements were available to be issued.

**C. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

**D. Tax Status**

The Plan is placing reliance on an opinion letter received from the Internal Revenue Service (IRS) on the pre-approved plan indication that the pre-approved plan is qualified under Section 401 of the Internal Revenue Code (IRC) and is, therefore, not subject to tax under current income tax law. The pre-approved plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or assets) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**E. Plan Termination**

Although the Company has not expressed an intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**F. Certified Information**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by MN Life Insurance Company, (custodian of the plan).

**G. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to the unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are defined under the FASB ASC 820, *Fair Value Measurement*, are described as follows:

**Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.**

**Level 2 – Inputs to the valuation methodology include:**

- **Quoted prices for similar assets or liabilities in active markets;**
- **Quoted prices for identical or similar assets or liabilities in inactive markets;**
- **Inputs other than quoted prices that are observable for the asset or liability; and**
- **Inputs that are derived principally from or corroborated by observable market data by correlation or other means.**

**If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.**

**Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement. There are no plan assets requiring the use of Level 3 inputs for the period presented.**

**The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.**

**The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023:**

***Pooled Separate Accounts and Insurance Company General Account* – Valued at the Net Asset Value (NAV) of units as determined by the Insurance Company based on the underlying investments held by the separate account. NAV is a readily determinable fair value and is the basis for current transactions. Included in the accounts is a stable value fund called MN Life Guaranteed Return Account. This account is held in the general account of the MN Life Insurance Company. The fund seeks to preserve capital and provide a stable return.**

**The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair market value of certain financial instruments could result in a different fair value measurement at the reporting date.**

**H. Related Party and Party-In-Interest Transactions**

Certain Plan investments are shares of pooled separate accounts which are offered by MN Life Insurance Company, the Plan Custodian, and therefore, these transactions qualify as party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses for the Plan are paid directly by the Company and amounted to \$14,000 and \$13,000 for the years ended December 31, 2024 and 2023, respectively. Notes receivable from participants also reflect party-in-interest transactions.
