Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Ferolie Corporation Employees' Savings and Investment Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. Description of Plan

The following description of the Ferolie Corporation Employees' Savings and Investment Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established on January 1, 1985 covering all eligible employees of Ferolie Corporation (the "Employer"). Employees are eligible to make elective deferrals and receive all employer contributions upon attainment of age 21 and completion of 1,000 hours of service. Effective May 1, 2024, employees are eligible to make elective deferrals upon attainment of age 21 and completion of 3 months of service. Employees are eligible for matching contributions upon attainment of age 21 and completion of 1 year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Eligible participants may defer voluntary contributions based on their eligible compensation on a per pay period, pre-tax or Roth basis, as defined in the Plan document, up to the statutorily permitted amount. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

The Plan includes an automatic enrollment feature whereby eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default rate set at 3% of their eligible compensation with an automatic increase of 1% per year up to a maximum of 10% of their eligible compensation. The amount deducted will be deducted on a pre-tax basis.

In accordance with the Plan document, the Employer may make discretionary matching contributions and profit-sharing contributions on behalf of eligible Plan participants, in a manner that is determined annually by the Employer. During the 2024 plan year, discretionary matching contributions equal to 25% of the first 10% of an individual's eligible compensation were contributed to the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution, allocations of: (a) Employer contributions and (b) Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. All investments are participant directed.

Vesting

Participants are one hundred percent (100%) vested immediately in all elective contributions plus earnings thereon. Participants vest in Employer discretionary matching contributions and profit-sharing contributions based on the following table:

2	25%

4	75%
5	100%

Participants will become 100% vested in their accounts upon death or incurring a disability.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$5,191 and \$10,179. These accounts may be used to reduce future Employer contributions or pay Plan expenses. During 2024, no forfeitures were used to reduce Employer contributions and \$15,125 of forfeitures were used to pay Plan expenses.

Payment of Benefits

Upon termination of service due to death, disability, retirement or separation from service, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Withdrawals from the Plan may also be granted based upon circumstances of financial hardship or after attaining age 59 1/2, in accordance with provisions specified in the Plan document.

Notes Receivable from Participants

The Plan offers a loan feature whereby a participant enrolled in the Plan may borrow a minimum of \$1,000 up to a maximum amount of 50% of their vested account balance or \$50,000 (whichever is less). The loans are secured by the participant's vested account balance (excluding Roth deferrals and related earnings) and bear interest at the prime rate plus 2%. A participant may only have two loans outstanding at any given time. Principal and interest are paid ratably through payroll deductions. The borrower also pays a loan origination and record-keeping fee. The loan must be repaid within a five-year period unless the loan is used for the purchase of a primary residence.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the net asset value ("NAV") per share as a practical expedient are not categorized within the fair value hierarchy.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. The mutual funds and exchange traded funds are valued at the daily closing price as reported by the fund. The funds held by the Plan are open-end and are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. These funds are deemed to be actively traded. The common/collective trust is valued at the NAV of units held by the Plan. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less their liabilities. The practical expedient is not used when it is determined to be probable that a fund will sell the investment for an amount different than the reported NAV. The self-directed brokerage accounts consist of a deposit account, common stocks, mutual funds, and exchange traded funds. Common stocks are valued at the closing price reported on the active markets on which the individual securities are traded. The bank deposit account is an interest-bearing demand deposit account which is valued at fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and a distributable event occurs (retirement, termination, death), the participant loan balance is reduced and a benefit payment is recorded. Until a distributable event occurs, the loan will continue to have a balance and accrue interest.

Expenses

Certain expenses of maintaining the Plan are paid by the Employer and are excluded from these financial statements. Fees related to record-keeping services are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in the NAV of the respective investment vehicles and, consequently, those expenses are not separately reflected but are a component of net appreciation in fair value of investments.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is September 10, 2025.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year), including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus LLC, as agent for Ascensus Trust Company, a qualified institution.

5. Common/Collective Trust

The MetLife GAC 25053 Class 0 Fund (the "Fund") is an investment trust designated for participants who want to structure their asset allocation towards a specific target year in which they intent to retire. The objective of the fund is to maximize returns while maintaining a level of risk appropriate for a person planning to retire on or about the calendar year designated in the funds name. The collective trust is managed and distributed by Reliance Trust Company. The price of the fund's units is based on its NAV, which is in turn based on the NAVs of each portfolio in which it invests. The NAV per unit of each fund equals the total value of its assets, less its liabilities, divided by the number of its outstanding units. This Fund has no unfunded commitments.

Purchases of the Fund are accepted daily and are credited based upon the net asset value per unit as of the close of business on the date the purchase is received by the trustee. Withdrawals generally will be permitted daily for the fund, at a redemption price equal to the net asset value per unit redeemed as determined by the trustee.

5. Common/Collective Trust (continued)

The Fund represented 9% and 12% of the Plan's net assets available for benefits at December 31, 2024 and 2023.

6. Income Tax Status

The Internal Revenue Service ("IRS") issued an opinion letter, dated June 30, 2020, which states that the Plan was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

7. Plan Termination

The Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

8. Party-In-Interest Transactions

Certain Plan investments are managed by The Vanguard Group, Inc., the provider of the recordkeeping platform for Ascensus, LLC. Therefore, these transactions qualify as exempt party-in-interest transactions.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

Certain employees of the Employer, who may be participants in the Plan, perform administrative services for the Plan at no cost to the Plan.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
