**Note 1: Description of Plan**

The following description of the Novatec, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution retirement plan established by Novatec, Inc. on June 1, 2008, and restated effective March 01, 2022, under a Non-Standardized Pre-Approved Profit Sharing Plan sponsored by Professional Capital Services, LLC. The Plan covers generally all employees of Novatec, Inc. who are at least twenty-one years of age and complete one year of service. The Plan qualifies under Section 401(k) of the Internal Revenue Code and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant Contributions: The Plan generally allows eligible employees to contribute 100% of their compensation, not to exceed the maximum limitation on annual additions to a participant's account under applicable provisions of the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participant contributions are made through payroll deductions. Each participant designates the percentage of his or her contributions which are to be invested in one or more of the available investment options. The Plan provides for an automatic enrollment of eligible participants equal to 3% of the participants' qualifying wages with required election to opt out or change their deduction percentage. The Plan document does not contain any escalation clause for the auto-enrollment provision. Participants are also allowed to contribute pre-tax distributions received from other qualified retirement plans. In addition to the pre-tax contributions that an eligible employee can make, the Plan also provides an option for after-tax contributions to a Roth account.

Employer Contributions: The Plan has a safe-harbor match provision where the Company is required to match 100% of employee contributions up to 3% of compensation and 50% of contributions for the next 2% of compensation. The Company may also make discretionary profit sharing contributions to the Plan. Participants that are employed by the Company on the last day of the year or that have completed at least 1,000 hours of service during the Plan year are eligible to receive discretionary profit sharing contributions. Participants who terminate employment during the Plan year due to death, disability or attainment of normal retirement age, are also eligible to receive such contributions. For the years ended December 31, 2024 and 2023, the employer safe harbor contributions totaled \$293,354 and \$299,624, respectively. The Company did not make any discretionary profit sharing contributions to the Plan during the years ended December 31, 2024 and 2023.

Participants Accounts: Each participant's account is credited with the participant's contributions, allocations of the Company contributions, and Plan earnings and losses. Allocation of any Company contributions not based upon participant contributions is based on the compensation of the eligible participants. Plan earnings and losses are allocated based on the account balances of the participants. The benefit to which a participant is entitled is that which can be provided from the participant's vested account. All plan assets as of December 31, 2024 and 2023 have been allocated to participant accounts.

Vesting: Participants are immediately vested in their elective contributions, Company safe-harbor contributions, and investment earnings thereon. Vesting in the Company's discretionary profit sharing contributions and investment earnings thereon are based on years of service. A participant is 100% vested in employer profit sharing contributions immediately after six years of service. In the event of death, disability or retirement, a participant's interest is immediately fully vested in the employer profit sharing contributions and related earnings under terms set forth in the Plan agreement.

**Note 1: Description of Plan (Continued)**

Notes Receivable from Participants: Participants may borrow from their accounts up to the lesser of \$50,000 or 50 percent of their vested account balance. The loans, which must be for at least \$1,000, bear interest at prevailing rates for similar loans as determined by the plan administrator and are carried at their outstanding principal balance. Repayments are generally made through payroll deductions. A participant may have three loans outstanding at any one time.

Payment of Benefits: Upon termination of employment, a participant may elect to have vested Plan benefits distributed as a lump-sum or in installment payments. If employment is terminated prior to retirement, the participant may receive a mandatory distribution depending on their vested account balance in the Plan. Participants are generally required to take minimum distributions upon reaching the age of 73. In-service withdrawals are permitted after a participant has attained 59½ years of age. Hardship withdrawals by a participant are permitted if specified criteria are met.

Forfeitures: Upon separation of service, the non-vested portion of a participant's account is generally forfeited upon termination of employment. Forfeitures can be utilized to reduce Company contributions and to pay the plan's administrative expenses. As of December 31, 2024 and 2023, there were \$1 and \$17,788 of forfeited non-vested amounts, respectively. As of December 31, 2024 and 2023, amounts utilized to pay contributions and administrative expenses were \$17,787 and \$-0-, respectively.

**Note 2: Summary of Significant Accounting Policies**

Following is a description of the significant accounting and reporting policies of the Plan:

Basis of Presentation: The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates: The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan trustees are responsible for oversight of the Plan, determine the appropriateness of the Plan's investment offerings and monitor investment performance. Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the amount participants would receive if they were to initiate permitted transactions under terms of the plan.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Contributions: Contributions from participants, including any related employer matching contributions, are recorded in the period the employer withholds payroll deductions from Plan participants. Discretionary contributions from the employer are recorded in the period the board of directors can reasonably estimate and approve the amount determined and collectability is reasonably assured.

Payment of Benefits: Benefit payments are recorded when paid to participants.

Subsequent Events: In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 1, 2025, the date the financial statements were available to be issued. During the period from January 1, 2025 through October 1, 2025, the Plan did not have any material recognizable subsequent events.

**Note 3: Fair Value Measurements**

Generally Accepted Accounting Principles (GAAP) establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodologies are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for Plan assets measured at fair value:

Interest-Bearing Cash: Interest-bearing cash represents an investment in a money market mutual fund at fair value, based on the closing price at year-end as reported by the fund.

Investments in Mutual Funds: The fair value of mutual funds is based on the closing price at year end as reported by the fund. Mutual funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

There has been no change in the methodologies used at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In determining the appropriate levels, the Plan performs a detailed analysis of the assets that are to be reported at fair value. The table below presents the assets measured at fair value on a recurring basis by level within hierarchy as of December 31, 2024 and 2023.

**Note 4: Information Certified by the Plan Trustee**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, the plan administrator has instructed the Plan's independent auditors not to perform any auditing procedures with respect to information certified as complete and accurate by AdvisorTrust, Inc. (AdvisorTrust), trustee of the Plan, except to compare such information to information included in the Plan's financial statements and supplemental schedules.

Certain information reported in the accompanying financial statements and supplemental schedules, including investments and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, and interest income from notes receivable from participants for the years then ended, was derived from information certified as complete and accurate by AdvisorTrust.

**Note 5: Collective Investment Trust**

The Morley Stable Value Fund (the "Stable Value Fund"), a collective investment trust, meets all of the standards currently required in order to be considered fully benefit-responsive, and therefore, is reported at contract value. It is available only to participants in a qualified retirement savings plan and is designed to protect a participant's capital investment. Fund investments include variety of investment contracts with insurance companies or other institutions, with underlying investments in bonds, guaranteed investment contracts ("GICs"), and other investment products (synthetic GICs and collective investment trusts) with similar characteristics. The Stable Value Fund holds investments in fully benefit-responsive investment contracts that provide that the Plan can make withdrawals at contract value for benefit-responsive requirements.

The Stable Value Fund does not have a set interest rate due to investments in contracts with varying rates and maturities. Variables impacting future crediting rates include current yield and duration of the assets backing the contracts, existing differences between the market values of assets backing the contracts and the contract values of the contracts.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment in the Stable Value Fund at contract value. Certain events may limit the ability of the Plan to transact at contract value with the issuer. The plan administrator does not believe that the occurrence of any such event is probable.

**Note 6: Notes Receivable from Participants**

As of December 31, 2024, 18 participants were indebted to the Plan in the total amount of \$115,734 (14 participants in the total amount of \$85,690 as of December 31, 2023) as the result of loans made to them by the Plan. The loans are evidenced by promissory notes bearing interest at 5.25% - 10.50% per annum, and are payable in installments, the latest of which is due in November 2029. The notes are fully secured by the participants' vested account balances.

**Note 7: Plan Termination**

The Company has the right under the Plan agreement to discontinue its contributions at any time and to terminate the Plan, subject to applicable statutory provisions. In the event of termination, all Plan participants will become fully vested. The Company has not indicated any intention to terminate the Plan.

**Note 8: Income Tax Status**

The Internal Revenue Service (IRS) has ruled, in a letter dated June 30, 2020 that the Non-Standardized Pre-Approved Profit Sharing Plan established by Professional Capital Services, LLC. qualifies under applicable sections of the Internal Revenue Code. An employer who adopts the Volume Submitter plan is generally considered to have a plan that is also qualified. In the opinion of the Plan administrator, the Plan is designed and currently operating in compliance with the applicable requirements of the Internal Revenue Code. The Plan's tax returns are subject to examination by the Internal Revenue Service generally for a period of three years after they are filed.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator does not believe that the Plan has any uncertain tax positions. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

**Note 9: Parties-in-Interest**

AdvisorTrust, the Plan's trustee, and Professional Capital Services, LLC (PCS), the Plans' third party administrator, provide various administrative services that qualify as party-in-interest transactions. The Plan paid administrative expenses of \$100,101 and \$71,721, to AdvisorTrust and PCS and other third parties for the years ended December 31, 2024 and 2023, respectively.

Certain officers and employees of the Plan sponsor are administrators of the plan acting as Fiduciaries and as Trustees and are also participants in the Plan.

**Note 10: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 11: Non-Exempt Prohibited Transactions**

The Company failed to remit to the Plan's trustee certain employee contributions during 2024 and 2022 totaling \$22,700 and \$41,942, respectively, within the period prescribed by the Department of Labor (DOL) regulations. The Company was required to make contributions to the affected participants' accounts to compensate those participants for potential lost income due to the delays. As of December 31, 2024, the Plan Sponsor is in the process of correcting.

**Note 12: Administrative Expenses**

The Plan provides that the Company, at its discretion, can agree to pay administrative expenses of the Plan. The Company paid Plan administrative expenses to various third parties totaling \$18,900 and \$18,000 for the years ended December 31, 2024 and 2023, respectively. Expenses paid directly by the Company are excluded from the financial statements.

**Note 13: Reconciliation of Financial Statements to Form 5500**

The financial statements of the Plan for the years ended December 31, 2024 and 2023 did not differ from the amounts reported on Schedule H (Financial Information) of Form 5500 (Annual Return/Report of Employer Benefit Plan) filed with the Internal Revenue Service.
