### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Chickasaw Nation Governmental Enterprises 401(k) Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of fiduciary net position as of December 31, 2024 and 2023 and the related statements of changes in fiduciary net position for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. **Note 1. Description of the Plan**

The following description of Chickasaw Nation Governmental Enterprises 401(k) Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan sponsored by the Chickasaw Nation (Nation). The Plan was established January 1, 2007 as a direct result of the spinoff from the Chickasaw Nation Governmental 401(k) Plan (Government Plan), which was originally adopted by the Nation as of January 1, 1997. The Plan was spun off from the Government Plan as part of the Nation's compliance with Section 906 of the *Pension Protection Act of 2006*.

The Plan provides benefits for the commercial employees of the Nation who participated in the Government Plan at December 31, 2006 and other commercial employees hired after January 1, 2007. Participants are eligible to participate in the Plan upon attainment of age 18 and completion of 500 hours of service within a six-month period following the employee's commencement date.

The Plan excludes any employees covered by a collective bargaining unit and any nonresident alien employees who receive no earned income from the Nation. Commercial employees are designated by the Nation but include members under the Commerce Division of the Nation and those whose job function supports the Commerce Division of the Nation. Unless already a participant in the Plan as of December 31, 2020, interns and externs, employees who are participants in the Career Development Services Student program, Chickasaw Institute Student program, Re-Entry program, School-to-Work program, Toksali SMART program, or any other participants in similar Nation governmental participant programs who are in "participant employee status" are excluded from eligibility in the Plan. Likewise, unless there is already a participant in the Plan as of January 1, 2022, CSSVH Specialists are excluded from eligibility in the Plan.

The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). The Nation serves as plan administrator and Milliman, Inc. (Milliman) serves as the plan record-keeper and Charles Schwab Bank Trust (Charles Schwab) serves as the plan custodian.

**Contributions**

The Plan permits eligible employees, through a salary deferral election, to have the Nation make annual contributions of up to 100% of eligible compensation. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. By declaration of the Governor of the Nation, the Nation makes safe harbor matching contributions of 100% of employees' salary deferral amounts up to 5%. The Nation may, by action of the Governor, modify, reduce, or eliminate the safe harbor matching contribution. The Nation may make additional employer contributions at the discretion of the Governor. No additional discretionary employer contributions were made for the years ended December 31, 2024 and 2023. Contributions are subject to certain limitations.

**Participant Investment Account Options**

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

For participants who became eligible to participate after January 1, 2016, the plan document also includes an automatic deferral feature whereby a participant is treated as electing to defer a certain percentage of eligible compensation unless the participant made an affirmative election otherwise. The automatic deferral feature provides for an annual increase in the percentage deferred of 1%, which is ultimately capped at 5% of participant compensation.

***Participant Accounts***

Each participant's account is credited with the participant's contributions, the Nation's contributions, and plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions and the Nation's safe harbor matching contributions and earnings thereon.

***Notes Receivable From Participants***

The plan document includes provisions authorizing loans from the Plan to active eligible participants. Loans are made to any eligible participant demonstrating a qualifying need. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loan is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on local prevailing rates as determined by the plan administrator, currently set at 1% above the prime rate, as defined.

***Payment of Benefits***

Upon termination of service due to death, disability, or retirement, an employee may: 1) elect to keep their accounts invested in the Plan (with certain exceptions), 2) roll accounts into an IRA or other employer tax-qualified plan, or 3) receive a lump-sum amount equal to the value of their account (subject to tax withholdings).

***Transfers***

Employees will periodically change their employment with the Nation. Such changes may periodically result in transfers of fiduciary net position between the Plan, the Government Plan, and other plans the Nation sponsors.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared in accordance with accounting principles generally accepted in the United States of America (GAAP) as applied to governmental units using the economic resources measurement focus and the accrual basis of accounting. The Governmental Accounting Standards Board (GASB) is the accepted standard-setting body for establishing governmental accounting and financial reporting principles.

***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of fiduciary net position and changes in fiduciary net position and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value in accordance with GASB Statement No. 72, *Fair Value Measurement and Application*. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

The Plan's interest in the collective investment trust is valued based on information reported by the custodian using the audited financial statements of the collective trust at year-end. The NAV is used as a practical expedient to estimate fair value, as plan management determined that this investment did not have a readily determinable

fair value. The practical expedient would not be used if it is determined to be probable that the Plan will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. The Plan's investment in the collective investment trust does not include any unfunded commitments. The collective investment trust investment strategy is to preserve principal and achieve high current income through a diversified portfolio of investments in high-quality guaranteed investment contracts and similar contracts issued by insurance companies, banks, and other financial institutions. The fund seeks to maintain a weighted maturity range for its holdings of less than five years. The fund had a weighted maturity of approximately three years for 2024 and 2023, and had an approximate yield of 4.4% and 3.9% for the years ending December 31, 2024 and 2023, respectively.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

***Notes Receivable From Participants***

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Nation or the Plan at the Nation's discretion.

**Note 3. Certification of Plan Custodian**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the custodian, a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required schedule of assets (held at end of year) is complete and accurate:

- Investments, noninterest-bearing cash, and notes receivable from participants as shown in the accompanying statements of fiduciary net position as of December 31, 2024 and 2023
- Investment income and interest income on notes receivable from participants as shown in the accompanying statements of changes in fiduciary net position for the years ended December 31, 2024 and 2023
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this information except for comparing such certified investment information to the related information included in the accompanying financial statements and ERISA-required schedule of assets (held at end of year).

**Note 4. Investments**

Investment securities are exposed to various risks that can affect the value of the Plan's investments, such as custodial credit risk, foreign currency risk, interest rate risk, credit risk, and concentration of credit risk.

**Custodial Credit Risk** – Custodial credit risk is the risk that in the event of a failure by the counterparty the Plan will not be able to recover the value of its investments that are in the possession of an outside party. The Plan's policies do not specifically address custodial credit risk.

**Foreign Currency Risk** – Foreign currency risk is the risk that changes in exchange rates will adversely impact the fair value of an investment denominated in a foreign currency. The Plan does not hold any direct investments or instruments denominated in a foreign currency.

**Interest Rate Risk** – Interest rate risk arises from the likelihood that interest rates will rise or fall during the holding period of a fixed-rate security and adversely affect the selling price of the security prior to maturity. The price of debt security typically moves in the opposite direction of the change in interest rates. The Plan's policies do not specifically address interest rate risk. As of December 31, 2024 and 2023 the Plan had investments in mutual funds whose underlying assets are primarily invested in fixed income securities and are subject to interest rate risk. The mutual funds that primarily invest in equity securities are included in investments with a maturity of less than one year because these mutual funds are not subject to interest rate risk. The Plan's collective investment trust is a type of pooled investment with no stated maturity and not subject to interest rate risk.

**Credit Risk** – Credit risk exists when there is a possibility the issuer or other counterparty to an investment may be unable to fulfill its payments on a security under the original term. The Plan's policies do not specifically address credit risk. The Plan had investments in mutual funds and a collective investment trust as of December 31, 2024 and 2023 that are not subject to concentration of credit risk.

**Concentration of Credit Risk** – The Plan’s policies do not specifically address concentration of credit risk. The Plan’s investments in mutual funds and the collective investment trust are not subject to concentration of credit risk.

**Note 5. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of input that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3** Unobservable inputs supported by little or no market activity and significant to the fair value of the assets

The following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of fiduciary net position, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

**Investments**

Quoted market prices, if available, are used to value the investments classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of investments with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such investments are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, investments are classified within Level 3 of the hierarchy. The Plan had no Level 2 or Level 3 investments as of December 31, 2024 and 2023.

**Note 6. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments, as they are paid through revenue-sharing rather than a direct payment.

The Plan paid approximately \$291,000 and \$214,000 of record-keeping fees to Milliman during the years ended 2024 and 2023, respectively.

The Nation also provides certain administrative services at no cost to the Plan.

**Note 7. Tax Status**

The Plan operates under a nonstandardized adoption agreement in connection with a prototype 401(k) defined contribution plan and trust sponsored by Milliman. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax-exempt as of the accompanying financial statement date.

**Note 8. Plan Termination**

Although it has not expressed any intent to do so, the Nation has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA.

**Note 9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the accompanying statements of fiduciary net position.

**Note 10. Nonexempt Transactions**

Defined contribution plans are required to remit employee contributions and loan repayments to the Plan as soon as they can be reasonably segregated from the employer's general assets but no later than the 15th business day of the month following the month in which the employee contributions are withheld by the employer. Once the Plan has determined it has remitted employee contributions late to the Plan, the Plan is required to compute lost earnings on those contributions and allocate lost earnings to the participants impacted in an equitable manner.

While the Company remitted all employee contributions and loan repayments to the Plan for 2024 and 2023, remittances of \$992,733 were not made within the required time period for the year ended December 31, 2023. Lost earnings on these delinquent remittances were fully funded to the Plan during the year ended December 31, 2024. Late remittances to the Plan are required to be reported as nonexempt transactions until the year after they are corrected; therefore, these late contributions are included on Schedule H, Line 4a of Form 5500.
