Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan’s transactions that are presented and disclosed in the financial statements are in conformity with the plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors’ Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists.

The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for the purpose of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

1. Description of Plan

The following description of the General Physician, P.C. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan is a volume submitter 401(k) profit sharing plan, sponsored by General Physician, P.C. (the “Plan Sponsor”). The Plan covers substantially all employees of the Plan Sponsor. In accordance with the Plan agreement, the following classes of employees are excluded from eligibility:

- Union employees;
- Non-resident aliens; and
- Leased employees.

The Plan was established effective January 1, 2010, and was subsequently amended and restated most recently on January 1, 2024 to allow in-Plan Roth conversions.

Plan Amendments – In response to the impacts of the COVID-19 (Coronavirus) pandemic, the Plan has implemented regulations available to employee benefit plans under the Coronavirus Aid, Relief, and Economic Security (“CARES”) Act during the year ended December 31, 2022. The CARES Act was effective April 10, 2020 and formally amended into the plan on September 30, 2022.

The Plan was amended effective January 1, 2023, to include an automatic enrollment provision, as well as an automatic deferral increase provision. Participants will be automatically enrolled with a 3% deferral. On the first day of each plan year, a participant’s deferral amount will automatically increase by 1%, up to a maximum of 10%. The minimum deferral amount will remain at 1% but the maximum deferral amount will decrease to 90%.

The Plan was additionally amended on May 1, 2023, to implement the standard provisions of the Setting Every Community Up for Retirement Enhancement (“SECURE”) Act of 2019, which had various retroactive effective dates.

The Plan was most recently amended on January 1, 2024, to implement a provision allowing for in-plan Roth IRA rollovers, with certain limitations due to the broad potential sources of rollover funds.

Contributions – Participants may elect to contribute to the Plan amounts equal to a full percentage between 1% and 90% of the participant’s eligible compensation, limited to the amount imposed by law. Participants can make Roth contributions into the Plan. Additionally, participants age 50 or older can elect to make a catch-up contribution limited to the amount imposed by law.

Notes to Financial Statements (continued)

1. Description of Plan (continued)

The Plan Sponsor, at its discretion, may make a pro-rata profit sharing contribution to certain eligible participants based on each eligible participant's compensation for the Plan year. Profit sharing contributions may be made to eligible participants who have completed one year of service and are current employees on the last day of the Plan year. The Plan Sponsor made no profit sharing contributions for the years ended December 31, 2024 and 2023, respectively. The Plan Sponsor also makes a Safe Harbor non-elective contribution in the amount of 3% of each eligible participant's compensation. The Plan Sponsor made Safe Harbor non-elective contributions of \$3,170,516 and \$2,960,181 for the years ended December 31, 2024 and 2023, respectively.

Participant Accounts – Individual accounts are maintained for each Plan participant. Participant accounts are increased by participant contributions, Plan Sponsor contributions, and the participant's share of Plan earnings. Participant accounts are decreased by participant distributions, the participant's share of Plan losses, and certain administrative expenses. The allocation of earnings and losses to participant accounts is based on the value of an individual account in relation to the total assets of the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are immediately vested in their contributions, rollovers and Plan Sponsor Safe Harbor contributions and actual earnings thereon. Participants vest in Plan Sponsor profit sharing contributions and actual earnings thereon at 20% after two years of service and 20% each year of service thereafter, becoming fully vested after six years.

Payment of Benefits – A participant may elect financial hardship withdrawals before age 59 ½ while employed by the Company. Financial hardship withdrawals are limited to the total of the participant's contributions and the vested portion of the participant's account attributable to any qualified non-elective contributions made by the Company.

A participant may also elect withdrawals from the portion of the participant's account attributable to rollover contributions at any time during employment with the Company.

After attaining age 59 ½, a participant may elect withdrawals during employment with the Company from the portion of the participant's account attributable to 401(k) contributions, rollover contributions and any qualified non-elective contributions made by the Company and from the vested portion of the participant's account attributable to Company matching contributions.

Upon termination of service due to death, disability, involuntary or voluntary termination, or retirement, a participant or the participant's beneficiary where applicable, is eligible to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Distribution is mandatory if the value of the vested interest is \$5,000 or less. Normal retirement age is 65.

1. Description of Plan (continued)

Forfeitures – Forfeited Plan Sponsor profit sharing contributions are used to reduce any Plan Sponsor profit sharing or Safe Harbor contributions. Forfeitures available for use amounted to \$18,568 and \$18,832 at December 31, 2024 and 2023, respectively. There were no forfeitures applied against Plan Sponsor contributions for the years ended December 31, 2024 and 2023.

Income Taxes – The Plan Sponsor obtained a letter dated September 16, 2022, in which the Internal Revenue Service (“IRS”) stated that the volume submitter profit sharing plan is qualified under Section 401(a) of the Code. An adopting employer may rely upon that letter with respect to qualification of its plan under Section 401(a) of the Code. Although the Plan was restated subsequent to the IRS determination letter, the Plan Administrator believes that the Plan is operating in compliance with the requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax exempt. Accordingly, no provision for income taxes has been included in the accompanying financial statements.

Plan Termination – Although it has not expressed intent to do so, the Plan Sponsor has the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting – The accompanying financial statements are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Investment Valuation and Income Recognition – The Plan’s investments are stated at fair value except for its fully benefit-responsive investment contract, which is valued at contract value (Note 5). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Shares of mutual funds are valued at quoted market prices which represent net asset value of shares held by the Plan at year-end.

Fair value is determined by Empower Annuity Insurance Company of America (“Empower” or the “Trustee”) as of December 31, 2024 and 2023, respectively. On April 1, 2022, Empower acquired the retirement business of Prudential Retirement Insurance and Annuity Company. Following the initial transition period, Empower became the sole administrator of this business during 2022 and fully completed the recordkeeping system migration on October 21, 2023.

2. Summary of Significant Accounting Policies (continued)

Units held in the guaranteed interest account consist of holdings in a fully benefit-responsive investment contract and are reported at contract value in the accompanying statements of net assets available for benefits. Contract value is the relevant measurement attributable to that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investments contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

The Plan presents in the accompanying statements of changes in net assets available for benefits the net appreciation in fair value of investments, which includes both realized gains and losses and unrealized appreciation in the fair value of investments. Realized gains and losses on disposition of investments are based upon actual costs and selling prices.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date.

Payment of Benefits – Benefits are recorded when paid.

Administrative Expenses – Certain accounting and administrative expenses of the Plan are paid by the Plan Sponsor. Expenses relating to certain investment activity are paid by participants from their respective individual accounts. Expenses related to certain recordkeeping functions are paid by the Plan.

Party-In-Interest Transactions – Plan investments include a guaranteed income fund maintained by Empower for the years ended December 31, 2024 and 2023. Empower is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Risks and Uncertainties – Investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying financial statements.

Use of Estimates – The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect certain reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Subsequent Events – Plan management has evaluated subsequent events for recognition or disclosure through October 1, 2025, the date the accompanying financial statements were available to be issued.

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate.

The Trustee also certified net appreciation in fair value of investments of \$5,876,888 and \$6,331,238 and interest and dividends from investments of \$2,440,363 and \$1,501,007 for the years ended December 31, 2024 and 2023, respectively.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- **Level 1** – Unadjusted quoted prices in active markets for identical, unrestricted assets or liabilities that are accessible at the measurement date. There were mutual funds that utilized Level 1 inputs as the primary measure of fair value totaling \$67,340,897 and \$54,936,405 as of December 31, 2024 and 2023, respectively.
- **Level 2** – Quoted prices for similar assets or liabilities in active markets or quoted prices for identical or similar assets or liabilities in markets that are not active. Also includes inputs other than quoted prices that are observable, either directly or indirectly, for substantially the full term through corroboration with observable, independent market data. This includes investments valued at quoted prices adjusted for legal or contractual restrictions specific to the security. There were no assets that utilized Level 2 inputs as the primary measure of fair value as of December 31, 2024 and 2023, respectively.

4. Fair Value Measurements (continued)

- **Level 3** – Pricing inputs are unobservable for the asset or liability. That is, inputs that reflect the reporting entity's own assumptions about the assumptions that market participants would use in pricing the asset or liability. There were no assets that utilized Level 3 inputs as the primary measure of fair value as of December 31, 2024 and 2023.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

As of December 31, 2024 and 2023, the mutual funds held by the Plan were valued based at the daily closing price as reported by the funds and were deemed to be actively traded. These funds were required to publish daily net asset value and transact at that price.

5. Guaranteed Investment Contract with Insurance Company

The Plan has entered into a traditional fully benefit-responsive investment contract (the "Contract") with the Trustee. The Trustee maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented in the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$1,610,938 and \$1,896,305, respectively. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a bi-annual basis.

5. Guaranteed Investment Contract with Insurance Company (continued)

Certain events limit the Plan's ability to transact at contract value with Empower. Such events include (1) amendments to the Plan documents (including complete and partial Plan termination or merger with another plan); (2) changes to the Plan's prohibition on completing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or (4) the failure of the trust to qualify for exemption under ERISA. The Plan Administrator believes that any events that limit the Plan's ability to transact at contract value with participants are not probable to occur.
