However, as discussed below, we identified certain deficiencies in internal control that we consider to be significant deficiencies.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct, misstatements on a timely basis. A material weakness is a deficiency, or a combination of deficiencies, in internal control over financial reporting, such that there is a reasonable possibility that a material misstatement of the plan's financial statements will not be prevented or detected and corrected on a timely basis. A reasonable possibility exists when the likelihood of an event occurring is either reasonably possible or probable as defined as follows:

- *Reasonably possible.* The chance of the future event or events occurring is more than remote but less than likely.
- *Probable.* The future event or events are likely to occur.

A significant deficiency is a deficiency, or a combination of deficiencies, in internal control over financial reporting that is less severe than a material weakness, yet important enough to merit attention by those charged with governance. We consider the following deficiencies in the plan's internal control to be significant deficiencies:

Participant Data

As noted in the prior year, under ERISA, a Plan Sponsor must establish and maintain the benefit plan pursuant to a written plan document that contains certain required elements. The plan sponsor and plan fiduciaries must maintain documentation as evidence the Plan is being administered in accordance with the plan document. During our current year audit, we noted the following deficiencies during our testing:

- For two out of seven participants noted as terminated, the date of termination reported on the census did not agree to the supporting employment records.
- For five out of fifty-five participants, the date of hire reported on the census did not agree to the supporting employment records.
- During our review of employee contributions, we compared the Census data to the detailed participant-level report obtained from the Plan's recordkeeper (Principal). Two variances were identified:
 - Kenny Brown: This participant was not included in the Census; however, the contribution per the Principal report totaled \$14,893.
 - Quentaya Black: A discrepancy of \$296 was noted between the Census and the Principal report (Census reported \$351; Principal reported \$648).

ERISA Compliance

During our audit, we reviewed the Plan Sponsor's insurance documentation noting that the ERISA coverage limit was inadequate for the entire Plan year. In accordance with ERISA §412(a), every fiduciary of an ERISA plan and anyone who handles plan funds must be covered by a fidelity bond. The minimum of such coverage is required to be at least 10% of the amount of funds handled during the preceding plan year and not more than \$500,000. As the net assets available for benefits at the end of the preceding plan year was \$3,174,793, the \$300,000 coverage limit noted in the documentation provided during our audit was short of the minimum amount required.
