## Independent Auditor's Report

To the Plan Administrator of  
PaperWorks Industries Savings Plan for Union Hourly Employees:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of PaperWorks Industries Savings Plan for Union Hourly Employees, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of PaperWorks Industries Savings Plan for Union Hourly Employees's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. ### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of PaperWorks Industries Savings Plan for Union Hourly Employees and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. **1. Description of Plan**

The following description of PaperWorks Industries Savings Plan for Union Hourly Employees (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan established effective August 1, 2008, as restated July 1, 2022. The Plan covers substantially all employees of PaperWorks Industries, Inc. (the "Company"), excluding employees not represented for collective bargaining purposes and employees who are active participants in the PaperWorks Industries, Inc. Pension Plan for Hourly Employees, who have completed 30 days of service and are age 21 or older. Employees over 21 years of age are eligible for matching contributions after one year of service and for all other discretionary contributions after completing 60 days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

**Contributions**

Each year, participants may contribute up to 20% of pretax annual compensation, as defined in the Plan document, up to the maximum limits of the Internal Revenue Code ("IRC"). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Automatically enrolled participants will have their deferral rate increase by 1% on the first day of each subsequent plan year until their deferral rate reaches 10%.

The Company makes matching contributions based on amounts stated within the Collective Bargaining Agreement ("CBA") in effect for the plan year. The Company contributed 50% of participants' elective deferral contributions up to \$3,500 per participant for the plan year ended December 31, 2024 as defined in the CBA. Additional discretionary amounts may be contributed by the Company. For the year ended December 31, 2024, there were no discretionary contributions to the Plan. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

The Company shall make additional contributions equal to a percentage of compensation, based on the schedule below, for the payroll period for each person who was an active participant at any time during that period, excluding any participant who was an active participant in the PaperWorks Industries, Inc. Pension Plan for Hourly Employees. The contribution will be in an amount equal to a percentage of the respective participant's compensation based on the following schedule:

<b>Number of Years of Service</b>	<b>Percentage of Eligible Compensation Contributed</b>
Less than 12 years	2.00%
More than 12 but less than 18 years	3.50%
More than 18 but less than 24 years	4.50%
More than 24 years	6.00%

Effective August 1, 2024, the percentage of eligible compensation contributed for more than 18 but less than 24 years of service was increased to 4.75% and the percentage of eligible compensation contributed for more than 24 years of service was increased to 6.25%. The respective participant's years of service for additional contributions will be determined annually as of the first day of the Plan year, and the additional contribution percentage determined for the participant on such date shall apply for the entire Plan year.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, Company's matching contributions and additional contributions, allocations of the Company's discretionary contributions and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. For purposes of Company's matching contributions, a participant is 20% vested after one year of credited service and continues to vest in increments of 20% until 100% vested after five years of credited service. For purposes of discretionary contributions and additional contributions, a participant is 33% vested after one year of credited service and continues to vest in increments of 33% until 100% vested after three years of credited service.

#### **Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installment payments as provided in the plan document. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. In addition, the Plan allows for hardship distributions if certain criteria are met.

#### **Forfeited Accounts**

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$110 and \$18, respectively. Forfeitures may first be used to pay administrative expenses. Remaining forfeitures, if any, may then be used to reduce employer contributions. During 2024, employer contributions were reduced by \$30,997 and plan administrative expenses were reduced by \$1,313 from forfeited nonvested accounts, in accordance with plan provisions.

## **2. Summary of Accounting Policies**

#### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

#### **Use of Estimates**

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments and are not readily determinable.

#### Subsequent Events

The Plan's management evaluated events that occurred after December 31, 2024 through September 19, 2025, the date when the financial statements were available to be issued. Based on that evaluation, the Plan's management has determined that, except for the below, no other subsequent events have occurred which would require disclosure in the financial statements.

Effective July 1, 2025, the Plan was amended to lower the age requirement to participate in the Plan from 21 to 18. Further, the Plan now allows participants to designate all or a portion of their deferral contributions as Roth contributions.

#### 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, are described as follows:

*Level 1* - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used as of December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled Separate Accounts:* Shares of pooled separate accounts have been determined by the custodians to be valued as Level 1 rather than using NAV as a practical expedient for fair value. The reasoning for this includes that the assets have a readily determinable fair value because a) the NAV is available to current investors and b) the NAV is the basis for current transactions traded in an active market.

*Common/Collective Trusts:* Investments in common/collective trust funds have been determined by the custodians to be valued as Level 1 rather than using NAV as a practical expedient for fair value. The reasoning for this includes that the assets have a readily determinable fair value because a) the NAV is available to current investors and b) the NAV is the basis for current transactions traded in an active market.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its evaluation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**4. Information Certified by Custodians**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Principal Trust Company and Principal Life Insurance Company, the custodians of the Plan, have certified the completeness and accuracy of all investments reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

**5. Related-Party and Party-in-Interest Transactions**

Certain Plan investments are managed by the custodian, and therefore, these transactions qualify as party-in-interest transactions.

Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments. Administrative expenses paid by the Plan amounted to \$5,432 for the year ended December 31, 2024.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**7. Tax Status**

The Plan adopted a pre-approved plan offered by Principal Life Insurance Company. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. The plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. As of December 31, 2024 and 2023, four investments and three investments represented a concentration of greater than 10% of the Plan's net assets available for benefits, respectively.
