**Note 1. Description of Plan**

The following description of the Electronic Warfare Associates, Inc. Savings and Investment Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document, and any amendments thereto, for a more complete description of the Plan’s provisions.

***General***

The Plan is a defined contribution plan covering all eligible employees who are age 18 or older and have one month of service with Electronic Warfare Associates, Inc. or certain other participating employers (collectively referred to as the “Company”). Plan management is responsible for oversight of the Plan, determining the appropriateness of the Plan’s investment offerings, and monitoring investment performance. Fidelity Management Trust Company (“FMTC”) serves as the trustee of the Plan (“Trustee”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

***Contributions***

Participants may contribute up to 60% of compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing rollover contributions from other qualified plans. Participants direct the investment of contributions into various investment options offered by the Plan. Each participating employer of the Company may provide a discretionary matching contribution using a formula determined by management. The Company may also make annual discretionary profit-sharing contributions in an amount that is determined by the Company’s Board of Directors. There was no profit-sharing contribution made for the year ended December 31, 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

***Investment Options***

The Plan currently offers mutual funds, a money market fund, and a self-directed brokerage account as investment options for participants.

***Participant Accounts***

Each participant’s account is credited with the participant’s contribution and allocations of the Company’s contributions, if any, and Plan earnings. Participant accounts are charged with allocation of administrative expenses or recovery that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

***Vesting***

Participants are immediately vested in their contributions, rollover amounts, and actual earnings thereon. Vesting in the Company’s contribution portion of their accounts plus actual earnings thereon is based on years of service. A participant is 100% vested after 2 years of credited service. Participants become fully vested in the event of death, disability, retirement and plan termination.

***Participant Notes Receivable***

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may have three loans outstanding at any one time. The loans are secured by the balance in the participant’s account. Principal and interest is paid ratably through payroll deductions over the period ranging up to five years, unless the loan is for the purchase of a primary residence, in which case the loan may be repaid over a period of up to 10 years. The loan interest rate is set by the plan administrator.

***Payment of Benefits***

Benefit payments are made in the form of participant directed lump sum withdrawals or installments upon separation, retirement, total and permanent disability, or death, as applicable. Benefits may be paid in cash, rolled over to another qualified retirement plan or an individual retirement account (IRA), or remain in the Plan until the participant chooses to take a distribution. For vested balances less than \$5,000 and greater than \$1,000, benefits may, at the option of the participant, be paid as a cash distribution, rolled over to another qualified retirement plan or IRA, or if no election is made transferred to an IRA. Vested account balances less than \$1,000 will be paid to the individual as a cash distribution.

Hardship distributions to employees are permitted from a participant's vested account balance if certain conditions are met. After withdrawal, participants may not make deferral contributions to the Plan for at least six months after receipt of the hardship distribution.

The Plan also provides for minimum required distributions per IRS regulations by April 1 of the calendar year following the later of the calendar year in which the participant reaches age 70 ½ or the calendar year the participant retires. In addition, participants may elect in-service withdrawals of their vested account balances after reaching age 59½.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$41,528 and \$33,241, respectively. These amounts may be used to either reduce future employer contributions or to pay administrative expenses of the Plan. During the year ended December 31, 2024, \$916 in forfeitures were used to reduce plan expenses. Additionally, \$32,376 in forfeitures were used to reduce the employer contribution receivable at December 31, 2024.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis according to accounting principles generally accepted in the United States of America (U.S. GAAP).

***Use of Estimates***

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest (notes receivable had interest rates of 4.25% to 9.50%. Interest income is recorded on the accrual basis. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024.

***Payment of Benefits***

Benefits are recorded when paid.

***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses or recovery. Investment related expenses are included in the net appreciation of fair value of investments.

***Subsequent Events***

Plan management has evaluated subsequent events through September 26, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, the Plan was amended to account for the merger of Sigma Defense 401(k) Plan into the Electronic Warfare Associates, Inc. Savings and Investment Plan.

**Note 3. Fair Value Measurements**

Fair value, as defined under U.S. GAAP, is an exit price representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. U.S. GAAP establishes a three-tier fair value hierarchy which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1** Observable inputs such as quoted prices in active markets.
- Level 2** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

**Mutual Funds and Money Market Fund**

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Self-Directed Brokerage Accounts**

Accounts primarily consist of mutual funds and money market funds that are valued on the basis of readily determinable market prices.

**Note 4. Certification of the Plan Trustee**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule(s) is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 5. Tax Status**

The Plan has not obtained a determination letter from the Internal Revenue Service (IRS) stating that the Plan was in compliance with the applicable requirement of the Internal Revenue Code (IRC). The Plan is relying on the IRS approval of the non-standardized plan that it is utilizing. The IRS has determined and informed the document sponsor by a letter dated June 30, 2020 that the plan document was designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits for any tax periods in progress.

**Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in any Company contributions.

**Note 7. Related-Party and Party-in-Interest Transactions**

Certain Plan investments are managed by Fidelity Management Trust Company, the trustee of the Plan and a party-in-interest to the Plan. Some fees incurred by the Plan for investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Plan paid certain expenses related to Plan operations directly to other service providers. Fees paid by the Plan for administrative services were \$3,713 for the year ended December 31, 2024.

**Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amount reported in the statements of net assets available for benefits.
