Independent Auditor's Report

To the Trustees of the
Beckley's Camping Center Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Beckley's Camping Center Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Beckley's Camping Center Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Beckley's Camping Center Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Notes to Financial Statements

(1) Description of plan

The following description of the Beckley Enterprises, Inc. dba Beckley's Camping Center (the Sponsor) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General: The Plan became effective January 1, 1986. The amended and restated provisions of the Plan became effective on January 1, 2022. It is a defined contribution retirement plan covering all employees of the Sponsor except union, leased, nonresident alien and part-time employees with less than 1,000 hours of service during a year. Employees age 21 or older are eligible to participate in the Plan and receive employer matching contributions after completing 2 months of service. Participants are eligible for non-elective profit sharing contributions after 1 year of service. Participants are credited with one year of service after achieving 1,000 hours of service.

The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA). Participants are entitled to enter the Plan for 401(k) purposes on a monthly basis upon completion of the age requirement.

Contributions: Participants may contribute up to the annual limit as set by federal law. The annual limit for elective deferrals for the year ended December 31, 2024 was \$23,000. For fiscal years beginning after December 31, 2001, individuals age 50 or older by the end of a plan year are allowed to make additional contributions to a 401(k) plan, in excess of the standard limits. Such additional contributions were limited to \$7,500 in 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Sponsor may make a discretionary matching contribution equal to a uniform percentage of a participant's salary deferrals. Each year, the Sponsor will determine the amount of the discretionary percentage. For the year ended December 31, 2024, the discretionary match percentage was 2% of participant salary deferrals.

The Sponsor may also make a discretionary contribution to participant accounts. For 2024, the discretionary percentage was equal to 3% of participant's annual compensation. Employees have the option to select the contribution be paid as a cash bonus or the amount be treated as an employee contribution to the participant's account.

In addition, the Sponsor may also make a discretionary profit sharing contribution equal to a percentage determined by management. For the year ended December 31, 2024, this percentage was 5% of participant's annual compensation. Employees must be employed on the last day of the year to receive this contribution.

Contributions are subject to certain limitations.

(1) Description of plan (continued)

Participant Accounts: Each participant's account is credited with the participant's contribution and allocations of (a) the Sponsor's contribution, (b) Plan earnings, and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances or specific transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their savings contributions and rollovers, plus actual earnings thereon. For participants employed on or after July 1, 2022, employer matching contributions are also 100% vested. Vesting in all other contributions is a portion of their accounts plus actual earnings thereon and is based on years of continuous service. A participant is 100 percent vested after 6 years of credited service as follows:

<u>Years of Vesting Service</u>	<u>Vested Percentage</u>
Less than 2 years	0%
After 2 years	20%
After 3 years	40%
After 4 years	60%
After 5 years	80%
After 6 years	100%

Payment of benefits: On termination of service, a participant will receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account. The participant may have all or any portion of the distribution paid in a direct rollover to an IRA or another employer plan. Participants will be paid the value of their account as soon as possible following the termination of service in a lump sum payment or automatic cash out if balance is less than \$5,000.

Hardship withdrawals are permitted from participant accounts.

Forfeited accounts: Non-vested employer contributions from withdrawing participants can be used to reduce current year employer matching contributions or pay for the Plan's expenses. The forfeitures are from previous year's employer contributions. During 2024, \$26,572 in forfeitures were used to offset employer matching contributions. Forfeited accounts totaled \$43,890 and \$23,252 at December 31, 2024 and 2023, respectively.

(2) Summary of significant accounting policies

Basis of accounting: The accompanying financial statements are presented on the accrual basis of accounting.

(2) Summary of significant accounting policies (continued)

Use of estimates: The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: The Plan's investments are stated at fair value, except for the fully benefit-responsive investment contract which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the custodian. See Note 5 for discussion of fair value measurements.

The Plan's fully-benefit responsive investment contract is reported at contract value. See Note 6 for discussion on the fully benefit-responsive investment contract.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Participant contributions are recognized on the pay date to which they relate. Employer discretionary matching and profit sharing contributions are recognized in the year designated by the Sponsor.

Funding policy: Contributions are funded as accrued.

Administrative expenses: Investment management expenses and other administrative and recordkeeping fees may be paid for by the Plan. Administrative expenses of the Plan can also be paid by the Sponsor, as provided in the Plan document. Certain accounting and administrative functions of the Plan are performed by employees of the Sponsor at no cost to the Plan. Administrative expenses paid by the Plan totaled \$113,346 for the year ended December 31, 2024. Investment related expenses are included in net appreciation in fair value of investments.

Payment of benefits: Benefit payments to participants are recorded when paid.

(3) Information prepared and certified by the Plan's custodian

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Life Insurance Company and Principal Trust Company (collectively, "Principal") certified as to the completeness and accuracy of all investments reflected in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the Schedule of Assets (Held at End of Year) as of December 31, 2024, the related investment activity reflected in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the accompanying Notes to the Financial Statements.

(4) Risks and uncertainties

The Plan provides for various investment options which may include any combination of stocks, bonds, fixed income securities, mutual funds, common trust funds, and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participant's account balances and amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

(5) Fair value measurements

Accounting Standards Codification Topic 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

(5) Fair value measurements (continued)

Following is a description of the valuation methodologies used for assets measured at fair value.

Pooled Separate Accounts: The fair value of the pooled separate accounts is based on net asset value (NAV). The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investments for an amount different than the NAV. Participant transactions (purchases and sales) may occur daily. The fund provides for daily redemptions by the Plan with no advance notice requirements and has redemption prices that are determined by the fund's net asset value per unit. If the Plan initiates a full redemption, the issuer reserves the right to require twelve months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments at December 31, 2024 and 2023.

Registered investment companies (mutual funds): Valued at the net asset value of shares held by the Plan at year end. The mutual funds held by the Plan are mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(6) Fully benefit-responsive investment contract

The Plan has a traditional fully benefit-responsive guaranteed investment contract with Principal Life Insurance Co. (Principal). Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issued is contractually obligated to repay the principal at a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the Statements of Net Assets Available for Benefits at contract value. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$75,663 and \$57,392, respectively.

(6) Fully benefit-responsive investment contract (continued)

Certain events limit the Plan's ability to transact at contract value with Principal. Such events include the following: (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

(7) Party-in-interest transactions

Certain Plan investments are Principal Life Insurance Company accounts managed by Principal Financial Group. Principal Financial Group is the service provider as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$123,657 for the year ended December 31, 2024. Fees paid by the Plan for contract administration, transactions considered as a party-in-interest transactions, to Prime Benefits, Inc. amounted to \$1,924 for the year ended December 31, 2024.

(8) Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

(9) Tax status

Effective September 15, 2017, the Plan adopted a volume submitter prototype plan sponsored by a third party administrator. The prototype plan received its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designated, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is currently designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax-exempt.

(9) Tax status (continued)

Generally accepted accounting principles requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has an uncertain tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan administrator has evaluated the Plan's tax positions and has concluded that there are no uncertain positions taken or expected to be taken that would require adjustments to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. The Plan is generally no longer subject to income tax examinations by federal, state, or local tax authorities for years prior to 2021.

(10) Subsequent events

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through September 17, 2025, the date the financial statements were available to be issued. There were no subsequent events that required recording or disclosure in these financial statements.
