To the Administrators and Participants of the

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

## 1. Description of Plan

The following brief description of the SHC Services, Inc. 401(k) Plan (the Plan) is provided for general information only. Participants should refer to the Plan agreement for more complete information.

*General.* The Plan became effective as of January 1, 2003, and is a defined contribution plan covering all qualified employees of the Company who have completed one month of service and are 21 years of age. An eligible employee may become a participant on the first day of each calendar quarter coinciding with or following the date the employee satisfies the eligibility requirements. A participant is eligible for Company matching contributions after completing twelve months of employment that includes at least 1,000 hours of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Plan Management is responsible for oversight of the Plan. The Investment committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

*Contributions.* Each year, participants may contribute a certain percentage of pre-tax annual compensation through payroll deductions. Participants who attain age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions to various investment options offered by the Plan.

The Company may make a discretionary contribution to the Plan of 50 percent of eligible employees' contributions up to six percent, for a maximum match of three percent. During the year ended December 31, 2024, no Company matching contributions were made to the Plan.

All contributions are subject to certain IRS limitations.

*Participant Accounts.* Each participant's account is credited with the participant's contribution and Company contributions, as well as allocations of the Company's discretionary contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting.* Participants are immediately vested in their salary reduction contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their account is based on years of continuous service. A participant is 100 percent vested after 6 years of credited service.

## 1. Description of Plan (continued)

*Payments of Benefits.* Distributions and withdrawals generally are payable upon termination, financial hardship, total disability, death, or the attainment of the normal retirement age of 65. The participant or designated beneficiary can receive a lump sum distribution of the value of the account including vested portions of employer contributions. An alternative payment schedule may be requested by the participant as specified in the Plan.

For the year ended December 31, 2024 the Plan reported \$20,133,578 of plan assets that were allocated to participants that had withdrawn from the Plan, but for which disbursement of funds from the Plan had not yet been made.

*Forfeited Accounts.* Forfeitures on unvested portions on Company matching contributions may be used to offset future employer contributions or pay Plan expenses. At December 31, 2024 and 2023, the Plan had \$488,129 and \$244,173, respectively, of forfeited nonvested funds. During the year ended December 31, 2024, \$29,569 of forfeitures were used to offset administrative fees.

## 2. Summary of Significant Accounting Policies

### *Basis of accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Management determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

## 2. Summary of Significant Accounting Policies (continued)

Interest income is recognized on the accrual basis as earned.

### *Payment of Benefits*

Benefits are recorded when paid.

### *Operating Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments.

### *Subsequent Events*

The Plan has evaluated subsequent events through September 30, 2025, the date the financial statements were available to be issued.

## 3. Information Certified by the Plan's Custodian

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net depreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Standard Retirement Services, recordkeeper of the Plan.

## 4. Fair Value Measurement

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
Level 2	Inputs to the valuation methodology include: <ul style="list-style-type: none"><li>• quoted prices for similar assets or liabilities in active markets;</li><li>• quoted prices for identical or similar assets or liabilities in inactive markets;</li><li>• Inputs other than quoted prices that are observable for the asset or liability;</li><li>• Inputs that are derived principally from or corroborated by observable market data by correlation or other means.</li></ul>
If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.	
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts:* Valued at fair value based on quoted prices on the last business day of the Plan year.

*Insurance company general account:* Valued at the net asset value of shares held by the Plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 5. Investment Contract with Insurance Company

Investment options of the Plan include the Stable Asset Fund II (the "Fund"). The Fund is available through a rider to Standard Insurance Company's group annuity contract. The contract value represents contributions made, less withdrawals and administrative expenses, plus interest credited. Daily liquidity at contract value is available for participant contributions and withdrawals. The Fund's contract value is a general liability against Standard Insurance Company on the plan/s behalf. There are no particular segregated or identifiable assets of Standard Insurance Company ascribed to the Fund. Contract value approximates fair value.

Crediting rates for the Fund are set by Standard Insurance Company. For the years ended December 31, 2024 and 2023, crediting rates for the Fund were:

#### 6. Party-in-Interest Transactions

Certain plan investments are shares of funds managed by Standard Insurance Company, custodian and record keeper of the Plan, and therefore, these transactions qualify as party-in-interest transactions. Any purchases and sales of these funds are open market transactions at fair market value. Consequently, such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA.

**6. Party-in-Interest Transactions (continued)**

Certain accounting and administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. In addition, the Company pays certain outside administrative expenses of the Plan.

**7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

**8. Income Tax Status**

In an opinion letter dated June 30, 2020, the Internal Revenue Service ruled that the Plan Volume Submitter Document qualifies under Section 401(k) of the Internal Revenue Code ("IRC") and is, therefore, not subject to tax under present income tax laws. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The plan administrator is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the Department of Labor ("DOL"). The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
