## REPORT OF INDEPENDENT AUDITORS

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

**Note 1. Description of Plan**

The following description of the California Tank Lines, Inc. (the “Company”) 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General**

The Plan was established as a defined contribution plan on January 1, 1993 and is subject to the provisions of the Employee Retirement Act of 1974 (ERISA) and Section 401(a) of the Internal Revenue Code (IRC) of 1986. The Plan year begins January 1 and ends December 31.

The Plan is a defined contribution plan wherein participants elect to reduce their compensation and have such reductions contributed to the Plan on their behalf. Participants direct their investments in numerous investment options managed by third party administrator, John Hancock Life Insurance Company (“Hancock”).

All employees are eligible to enroll in the Plan after completing 1,000 hours of service during the Plan year and also must be the age of eighteen. Employees receive credit for ten hours of service for every day in which they complete one hour of service. Eligible employees can enter the Plan on the first day of the succeeding Plan year after they have met the eligibility requirements for the Plan. If an employee fails to complete 500 hours of service in any Plan year, a break in service from the Plan can occur.

**Contributions**

Each year, participants may contribute up to the deferral limits as defined by the Internal Revenue Service (IRS) of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of an additional \$7,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, common stocks, bonds, government securities, and an insurance investment contract as investment options for participants.

The Company may make discretionary contributions. Participants must make elective deferrals into the Plan and be employed on December 31 to receive a discretionary contribution. The Company may make non-elective contributions to the Plan based on eligible earnings. The Company made discretionary contributions of \$173,880 and \$175,619 respectively, for the years ended December 31, 2024 and 2023.

**Participant Accounts**

Each participant’s account is credited with the participant’s contributions and the Company’s discretionary contributions. Investment income or loss is allocated every business day which the New York Stock Exchange is open. Any discretionary or profit-sharing contribution, if any, is made annually to participants employed on the last day of the Plan year.

**Note 1. Description of Plan (Continued)**

**Forfeitures**

Forfeitures of employer contributions may be used first to pay administrative expenses or reduce amounts otherwise required to be contributed to the Plan. There were no forfeitures for the years ended December 31, 2024 and 2023.

**Vesting**

Employee contributions are 100% vested. Employer discretionary and nonelective contributions have the following vesting schedule:

<u>Years of Vesting Service</u>	<u>Vested Interest</u>
Less than 3	0%
3 years or more	100%

In order for the participant to count a year as vested, they must perform at least 1,000 hours of service during the year.

**Termination**

Although the Company has not expressed any intent to do so, management may terminate the Plan at any time. Upon termination of service, a participant may elect to receive either a lump-sum amount equal to the value of his or her account, or one of various payments available under the Plan. In addition, upon termination of the Plan, participants' vested interest in employer contributions shall be 100%.

**Participant Loans**

The Plan does not permit any participant loans.

**Payment of Benefits**

At retirement (age 65), death, disability, or termination of service, a participant may leave their account balance in the Plan or elect to receive a single lump-sum payment in cash. Participants are allowed to withdraw employee account balances prior to termination of their employment under certain conditions specified in the Plan. Benefit payments are recorded when paid.

**Administrative Expenses**

Expenses of administering the Plan are paid principally by the Plan. Administrative fees are deducted from the participants' accounts on a pro-rata basis. The Plan paid fees of \$50,371 and \$45,344 during the years ended December 31, 2024 and 2023, respectively, all of which are rendered by parties-in-interest.

The Company absorbs the cost of certain administrative functions of the Plan including certain external legal and auditing services.

**Note 2. Summary of Significant Accounting Policies**

This summary of significant accounting policies of the Plan is presented to assist in understanding the financial statements. The financial statements and notes are representations of the Company, who is responsible for their integrity and objectivity. The accounting policies conform to accounting principles generally accepted in the United States of America (GAAP) and have been consistently applied in the preparation of the financial statements.

**Use of Estimates**

The preparation of financial statements, in accordance with GAAP, requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Basis of Accounting**

The financial statements of the Plan are maintained on the accrual basis of accounting in accordance with GAAP. Investments held by the Plan are required to be reported at fair value.

**Employee Contributions Receivable**

Employee contributions receivable represents amounts due from the Company for payroll deductions withheld from the employee as contributions to the Plan. These amounts were deducted prior to year-end and received shortly after year-end. As of December 31, 2024 and 2023, the Plan had employee contributions receivable of \$100 and \$0, respectively.

**Investment Valuation and Income Recognition**

Investments are reported at fair value based on quoted market prices. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the date received. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Excess Contributions Payable**

For the years ended December 31, 2024 and 2023, the plan did not have excess contributions payable.

**Administration of the Plan**

Certain administrative expenses of the Plan may be paid by the Company. The Plan is not required to reimburse the Company for any administrative expenses paid for by the Company. Expenses not paid by the Company are paid for by the Plan.

**Income Taxes**

The Plan received a letter from the IRS identifying the Plan as acceptable under section 401 of the IRC. In the opinion of the Company, the Plan is currently being operated in accordance with the Plan agreement and in conformity with the applicable provisions of the IRC and therefore exempt from federal income taxes. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**Income Taxes (continued)**

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**Note 3. Unaudited Information – Certified Investments**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Substantially all information pertaining to the Plan’s investments included in the financial statements, including the associated investment income was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Hancock, the trustee. This information has not been audited by independent accountants.

The following information, included in the accompanying financial statements and supplemental schedules, was obtained from data that has been prepared and certified as complete and accurate by Hancock.

**Note 4. Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset fair value measurement within the fair value hierarchy is based on the lowest level of any input significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following table sets for by level, within the fair value hierarchy, the Plan's financial assets that were accounted for at fair value on a recurring basis on December 31, 2024 and 2023:

**Note 5. Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participant's account balances and the amounts in the statement of net assets available for Plan benefits.

**Note 6. Parties in Interest**

Certain Plan investments are shares of mutual funds and other assets managed by Hancock. Hancock is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$50,371 and \$45,344 for the years ended December 31, 2024 and 2023.

Senior management of the Company are also participants in the Plan and therefore represent parties in interest. These employees make contributions to the Plan in accordance with the provisions of the Plan and in accordance with applicable laws.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**Note 7. Subsequent Events**

In preparing these financial statements, management has evaluated events and transactions for potential recognition or disclosure through August 8, 2025, the date of the auditor's report. Management has determined that there are no material events that would require disclosure in the Plan's financial statements through this date.
