### **Basis for Opinion**

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America..

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

## **Notes to Financial Statements**

### **Note 1 – Description of Plan**

The following description of the LHR Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a tax qualified defined contribution multiple-employer plan covering specific job classification employees of affiliates of Lighthouse Resources, Inc. (the Company). The Plan is administered by the Company. Reliance Trust Company is the trustee of the Plan. The Plan's net assets are held in trust and invested in several investment funds as determined by the employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### **Eligibility**

Participants within specified job classifications are eligible to participate in the Plan who have met requirements established by the affiliate companies of the Company.

#### **Contributions**

Each year, participants may contribute a percentage of their annual compensation, as defined in the Plan. The employer will match a portion of the employees' contribution, as determined by the Plan of the respective affiliate companies of the Company. Participants may also contribute amounts representing rollover distributions from other qualified defined benefit or contribution plans.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the employer's contributions and Plan earnings, and reduced with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participant contributions and the related earnings thereon are fully vested at all times. Vesting of employer contributions ranges from immediate to 5 years. The forfeitures balances for the years ended December 31, 2024 and 2023 were \$17,032 and \$19,228, respectively. The 2024 and 2023 forfeitures were used to offset employer contributions.

#### **Payment of Benefits**

On termination of service due to death, disability, hardship, or retirement, a participant or beneficiary may elect to receive either a lump-sum distribution or installment payments equal to the value of the participant's vested interest in the participant's account over the participant's remaining expected life. For termination of service for other reasons, a participant may receive the value of the vested interest in the participant's account as a lump-sum distribution. Plan participants are eligible for normal retirement at age 65 but may elect to retire at a later date.

The Plan allows for automatic distribution of a terminated participant's account balance totaling less than \$1,000. A terminated participant with an account balance between \$1,000 and \$5,000 may receive a distribution of his or her account balance paid into an individual retirement account.

### **Hardship Withdrawals**

Participants are permitted to withdraw, in a single sum, from his or her vested interest in the Plan in order to satisfy an immediate and heavy financial need of the participant. The amount available for a hardship withdrawal will include contributions that the participant has made to the Plan, but will exclude any earnings and/or any employer contributions.

### **Notes Receivable from Participants**

In accordance with the Plan's loan policy, participants are permitted to take a loan if the purpose of the loan is to satisfy an immediate and heavy financial need of the participant. Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Participants may only have one outstanding loan at any time. Interest on participant loans is fixed for the duration of the loan at 1% above prime rate.

### **Note 2 – Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The Plan's financial statements are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value, except for fully benefit-responsive contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Payment of Benefits**

Benefits are recorded when paid by the Plan.

#### **Notes Receivable from Participants**

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan documents.

#### **Concentrations of Credit Risk**

Financial instruments, which potentially subject the Plan to concentrations of credit risk, consist primarily of marketable securities. Marketable securities are subject to daily changes in market valuations. The Plan has not

experienced any losses in such accounts and believes it is not exposed to any significant credit risk on cash and cash funds.

### **Administrative Expenses**

Expenses related to investment advisory services and management fees are paid by the Plan. Expenses related to maintenance of participant account and plan administration can be paid by the Sponsor at their discretion.

### **Subsequent Events**

Management of the Plan has evaluated subsequent events through October 2, 2025, which is also the date the financial statements were available to be issued. No subsequent events were noted during this evaluation that require recognition or disclosure in these financial statements.

### **Note 3 – Fair Value Measurements**

The Plan discloses and recognizes the fair value of its assets and liabilities in accordance with Accounting Standards Codification (ASC) 820, Fair Value Measurement and Disclosures (ASC 820) which among other things, defines fair value and provides enhanced disclosures about investments that are measured and reported at fair value. ASC 820 establishes a hierarchal disclosure framework, which prioritizes and ranks the level of market price observability used in measuring investments at fair value. A number of factors, including the type of investment and the characteristics specific to the investment, impact market price observability. Investments with readily available active quoted prices generally will have a higher degree of market price observability and a lesser degree of judgment used in measuring fair value.

Investments measured and reported at fair value are classified and disclosed in one of the following categories:

- Level 1 inputs, which have the highest priority, are quoted prices for identical assets in active markets.
- Level 2 inputs are observable inputs other than quoted prices included in Level 1, such as quoted prices for similar assets in active markets or quoted prices for identical or similar assets in markets that are not active.
- Level 3 inputs, which have the lowest priority, are unobservable inputs that reflect the Plan's own assumptions, consistent with reasonably available assumptions made by other market participants.

Inputs are used in applying the various valuation techniques and broadly refer to the assumptions that market participants use to make valuation decisions, including assumptions about risk. Inputs may include price information, volatility statistics, specific and broad credit data, liquidity statistics, and other factors. An investment's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for investments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy:

**Mutual Funds** - These investments are valued at the net asset value (NAV) of shares held by the fund based on closing prices reported in an active market and classified within Level 1 of the valuation hierarchy. The investments can be redeemed on a daily basis and there is no restriction on redemption.

### Note 4 – Investment Contract with Insurance Company

The Plan has a fully benefit-responsive investment contract with Transamerica. Transamerica maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Transamerica is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, the contract is measured at contract value. Contract value, as reported to the Plan by Transamerica, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk.

Certain events, such as the premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value with Transamerica. The plan administrator believes the occurrence of such events is not probable.

### Note 5 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

### Note 6 – Certified Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the trustee of the Plan), Transamerica Life Insurance Company, and Transamerica Trust Company.

#### **Note 7 – Income Tax Status**

The Company adopted a volume submitter profit sharing plan with CODA sponsored by United 401k Plans, which received a favorable opinion letter from the IRS on June 30, 2020, which stated that the Plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since the prototype plan received the opinion letter, the plan administrator and the Plan's tax counsel believe that the Plan and related trust are currently designed and are currently being operated in compliance with the applicable requirements of the IRC.

#### **Note 8 – Risks and Uncertainties**

The Plan invests in various securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **Note 9 – Party-in-Interest Transactions**

Certain plan investments are shares of mutual funds managed by Transamerica Retirement Solutions; therefore, these transactions qualify as party-in-interest transactions. The Plan paid \$102,474 and \$90,844 to the trustee, investment advisors, and third-party administrator for the applicable services for the years ended December 31, 2024 and 2023, respectively.

#### **Note 10 – Subsidiary**

Millennium Bulk (MB), a subsidiary of LHR was dissolved in April of 2021. The employees of MB are no longer actively participating in the plan. Balances for MB participants were distributed in 2023 per the provisions of the plan. As of December 31, 2024 and 2023, the MB balance was \$0.
