We have performed audits of the financial statements of the Proximo Spirits Inc. 401(k) Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meet the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Notes to Financial Statements

1. Description of the Plan

The following brief description of the Proximo Spirits Inc. 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees, except union employees, of Proximo Spirits Inc. (the Company or the Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility

Full-time employees aged 21 or older are eligible to contribute to the Plan, effective the first day of the month following the date of employment. Part-time employees aged 21 or older are eligible to contribute to the Plan after completing one year of service, or 500 hours. In order to be eligible to share in Employer non-elective contributions, full-time and part-time participants must work one year or 1,000 hours. Employees subject to a collectively bargained agreement; residents of Puerto Rico; and part-time, seasonal, or temporary employees who work less than 500 hours are excluded from participation in the Plan.

Employer Contributions

The Company elected to satisfy the "safe harbor" rules. Before the beginning of each Plan year, participants will be provided with a comprehensive notice of their rights and obligations under the Plan. The Company will make a safe harbor matching contribution equal to 100% of participants' salary deferrals that do not exceed 6% of their compensation, as defined. For the year ended December 31, 2024, the Company made a safe harbor contribution of \$3,503,054.

In addition, each year the Employer may make an additional discretionary non-elective contribution to the Plan. Allocation amounts are based on hours of service during the year, employment status at year-end, compensation received during the year, and the classification level of the employee. During 2024, the Company did not make any discretionary non-elective contributions to the Plan.

Participant Contributions

Participants may contribute a percentage of annual eligible compensation, as defined in the Plan, not less than 1%, in the form of pre-tax or after-tax (Roth) deferrals, through salary deductions. Participants also may contribute amounts representing distributions from other qualified plans (rollovers). Contributions are subject to certain annual dollar limitations, as imposed by the Internal Revenue Code (IRC). The limit for 2024 was \$23,000. In addition, participants who will have attained age 50 or older by the end of the calendar year may make additional catch-up contributions of \$7,500 for 2024.

The Plan includes automatic enrollment for all participants other than those with an existing salary deferral agreement. Participants will be auto enrolled at 6% of compensation, increasing 1% per year until a total of 10% is deferred. Deferrals under the auto enrollment provision will be invested in a target date retirement fund based on the participant's age. Participants can opt out of auto enrollment or change the default investment.

Participant Accounts

The Plan is a participant directed account Plan. The Plan maintains individual accounts for each Plan participant. Each participant's account is credited with the participant's contributions, rollovers, the Company's contributions, if any, Plan earnings or losses, and administrative fees. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately at 100% all participant and Employer contributions.

Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers investment options for participants through mutual funds and a guaranteed interest account (GIA).

Payments of Benefits

A participant is eligible to receive the vested balance in their account under the following circumstances: (a) attaining normal retirement age, as defined; (b) terminating employment before attaining normal retirement age; (c) becoming disabled, as defined; (d) attaining age 59½ but continuing to work; and (e) terminating employment and satisfying the early retirement age requirements, as defined. A participant may elect to receive the value of his or her account in the form of a single lump-sum payment or in installments.

Notes Receivable from Participants

Participants may borrow from their vested accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Principal and interest are paid ratably through payroll deductions over a five-year period, unless it is for the purchase of a principal residence, in which case the loan repayment period may not extend beyond 15 years from the date of the loan. The loans are secured by a participant's vested account balance and bear interest at the rate in effect in the month the loan is effective. The interest rate is the prime rate, as published by *The Wall Street Journal* plus 2%. Participants are permitted to have one outstanding loan at a time. At December 31, 2024 and 2023, the notes bear interest at a rate of 4.25% to 10.50%.

2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and

assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for the GIA which is a fully benefit responsive contract and is reported at contract value (Note 5). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisor and trustee. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are stated at their unpaid principal balance, plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Contributions Receivable

Safe harbor matching contributions and discretionary non-elective contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to each participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

3. Risks and Uncertainties

The Plan invests in various investment options in any combinations of funds offered by the Plan. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes

could materially affect participants' accounts balances and the amounts reported in the statements of net assets available for benefits.

4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurements*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following tables set forth, by level within the fair value hierarchy, a summary of the Plan's investment assets at fair value.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds - Mutual funds are valued at the daily closing price, as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Guaranteed Interest Account

Through the group annuity contract, the Plan offers the GIA as a stable value investment option. Participant accounts invested in the GIA are available for participant-initiated transactions at contract (or book) value, such as transfers to other investment options, loans, and other distributions. The GIA account balances are maintained in MassMutual and Empower's general investment accounts, and there are no reserves against the contract value of these accounts for credit risk of MassMutual and Empower.

The GIA is credited with earnings at an interest rate, which is determined in advance. As of December 31, 2024 and 2023, the guaranteed-interest rate was 2.45% for both years.

Since the GIA is fully benefit-responsive, contract value is the relevant measurement for that portion of the net assets available for benefits attributable to the GIA, because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported by MassMutual/Empower, represents participant contributions made under the contract, plus credited interest earnings, less participant withdrawals and fees. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value. Such events include the following: (1) amendments to the Plan documents (including complete termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exception from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The GIA does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

6. Information Certified by the Trustee

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Great West, a qualified institution.

7. Related Party and Party-in-Interest Transactions

Certain Plan investments are in funds and accounts that are managed by Great West or their subsidiaries and affiliates. Participant loan and distribution processing fees are paid to Great West by participants. The Plan paid for third-party administrator fees, investment advisory, and Plan audit fees which qualify as party-in-interest transactions. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. Certain management fees in the form of an expense ratio charged to each investment option are paid by the Plan and deducted from earnings on investments. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

8. Plan Termination

Although it has not expressed any intention to do so, the Company reserves the right to terminate the Plan, in whole or in part, at any time, subject to the provisions of ERISA. In the event that such termination occurs, all amounts credited to participant accounts will remain 100% vested, and the custodian, in accordance with the Plan document, will distribute the net assets of the Plan in a uniform and non-discriminatory manner.

9. Tax Status

The Plan adopted Empower Retirement LLC's pre-approved volume submitter plan, which received a favorable opinion letter from the Internal Revenue Service (IRS) on March 31, 2014 and which stated that the Plan met the requirements of IRC Section 401(a). The Plan has been amended since adoption, and the Plan Administrator believes the Plan is designed and operated in accordance with, and continues to qualify under, the applicable requirements of the IRC, and that the Plan is exempt from federal income taxes.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
