1. DESCRIPTION OF THE PLAN

The following description of the Guidesoft, Inc. 401(k) Plan & Trust (the Plan) provides only general information. Reference should be made to the Plan document for a more complete description of the Plan's provisions.

General

The plan, effective January 1, 2008, and most recently amended and restated on October 1, 2024, is a defined contribution plan covering the employees of Guidesoft, Inc. (referred to as "the Company"). The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Employees are eligible to participate immediately and are enrolled in the Plan on the first day of quarter following their hire date.

Contributions

Each year, participants may make voluntary contributions up to the IRS limits of pre-tax annual compensation as defined by the Plan. Participants are automatically enrolled to begin contributions to the plan at 4% with auto-escalation of 1% annually, unless another election is made.

The Company may make contributions in two manners. First, a discretionary matching contribution equal to a percentage of a participant's contribution is possible. For the year ended December 31, 2024, the Company has elected to match 50% of a participant's contributions of up to 8% of a participant's eligible compensation. Second, the Company may make a profit sharing contribution allocated to all eligible participants based on their proportionate compensation received to the total compensation received by all other eligible participants. The Company elected not to make a profit sharing contribution for the year ended December 31, 2024.

Participants' Accounts

Each participant's account is credited with the participant's contribution, the Company's matching contribution, the Company's profit sharing contribution and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions, plus actual earnings thereon. Vesting in the Company contribution portion of their account, plus earnings thereon, occurs on a graduated scale as shown below. A participant is 100% vested after five years of credited service.

1. DESCRIPTION OF THE PLAN, CONTINUED

Payment of Benefits and Withdrawals

Distributions and withdrawals are payable upon normal retirement at age 65, termination, disability or death. The Plan also permits hardship withdrawals to participants subject to certain restrictions. The participant, or their beneficiary, elects the manner he or she will receive vested benefits as outlined in the Plan document.

Forfeited Accounts

Forfeitures of employer matching contributions may be used to pay administrative expenses or to reduce future employer contributions. Forfeitures may also be reallocated to participants as though they are additional employer contributions. Forfeitures during the year ended December 31, 2024 were \$60,417. Forfeitures of \$10,342 were applied to reduce administrative expenses during the year ended December 31, 2024. At December 31, 2024 and 2023, \$62,619 and \$11,761 of forfeitures remained to be applied in future years, respectively.

Plan Administration

The Company is the administrator of the Plan, and as such, carries out the duties imposed by ERISA. The fiduciary committee of the Company meets regularly to review investment options and performance. The administrator has delegated certain responsibilities for the operation and administration of the Plan. Some of the administrative expenses of the Plan are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. The total administrative expenses incurred by the Plan were \$104,387 for the year ended December 31, 2024.

Subsequent Events

Subsequent events have been evaluated by Plan management through August 25, 2025, which is the date the financial statements were available to be issued.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting and Use of Estimates

These statements have been prepared on the accrual basis of accounting. The preparation of statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at market value. Shares of registered investment companies are stated at fair value as determined by quoted market prices, which represents the net asset value of shares held at year end.

Purchases and sales of securities are recorded on a settlement-date basis. Dividends are recorded on the ex-dividend date. Changes in the difference between cost and quoted market value of investments are reflected as net appreciation in value of registered investment companies in the statement of changes in net assets available for benefits.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES, CONTINUED

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions.

Payments of Benefits

Benefits are recorded when paid.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include <ul style="list-style-type: none">• quoted prices for similar assets or liabilities in active markets;• quoted prices for identical or similar assets or liabilities in inactive markets;• inputs other than quoted prices that are observable for the asset or liability;• inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Money Market Fund: Valued at the quoted net asset value (NAV) or shares held by the Plan at year end.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

3. FAIR VALUE MEASUREMENTS, CONTINUED

The method previously described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE

The investments at fair value held at December 31, 2024 and 2023, and the net appreciation in fair value of investments and dividend income for the year ended December 31, 2024, as reported and disclosed in the accompanying financial statements and supplemental schedule, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by AdvisorTrust, Inc., the trustee of the Plan.

5. INCOME TAX STATUS

The Internal Revenue Service has determined in its opinion letter dated June 30, 2020, that the prototype plan adopted by the Plan is qualified and the trust established under the Plan is exempt under the appropriate sections of the Internal Revenue Code (the IRC). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes the Plan is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan, as most recently amended and restated, is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if management has taken an uncertain position that more likely than not would not be sustained upon examination by various federal and state taxing authorities. Plan management has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability of disclosure in the accompanying financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. There were no interest or penalties incurred during the year ended December 31, 2024.

The Plan has filed its tax returns for periods through December 31, 2023. These returns are generally open to examination by the relevant taxing authorities for a period of three years from the later of the date the return was filed or its due date. Accordingly, the tax filings for the years ended December 31, 2023, 2022, and 2021, are open to examination at December 31, 2024.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, all assets would be distributed out of the Plan in accordance with the Plan document and all participants would become fully vested.
