### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

**A. Description of Plan**

The following description of the Golden Eagle Distributing Co. 401(k) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all full-time employees of Golden Eagle Distributing Company (the Company) and its wholly owned subsidiaries, Golden Eagle Spotting Company and Golden Eagle Illinois LLC. On May 30, 2025, the Company closed a wholly owned subsidiary, Golden Eagle Spotting Company, which had employed seven participants in the Plan.

Eligible employees are age 21 or older who have completed one year of eligible service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan has quarterly entry dates: the first day of the Plan year and the first day of the fourth, seventh and tenth months of the Plan year.

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023, which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. Most of the significant provisions became effective in 2024 and thereafter. Accordingly, there is no material impact on the Plan's financial statements.

**Contributions**

Contributions to the Plan consist of the following:

1. Elective Deferral Contributions – The total amount of the salary reduction elected to defer by employees. The maximum deferral percentage is 92% of their eligible compensation, as defined by the Plan, not exceeding \$23,000 and \$22,500 for the calendar years 2024 and 2023, respectively. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions not exceeding \$7,500 for calendar years 2024 and 2023. The Plan allows for a Qualified Automatic Contribution Arrangement (QACA) in which employees are automatically enrolled in the Plan once they become eligible at a deferral rate of 3% and will gradually increase by 1% each year the employee participates up to 6% unless the employee takes action to opt out. Total deferrals for the plan years ending December 31, 2024 and 2023, were \$469,552 and \$458,478, respectively.
2. QACA ADP Test Safe Harbor Matching Contribution – For each Plan year, the employer will make a QACA ADP test safe harbor matching contribution to the individual account of each eligible employee. The contribution is equal to 100% for elective deferrals less than 1%, and 50% for elective deferrals greater than 1%, but less than or equal to 6%. The total safe harbor contribution was \$168,394 for the year ended December 31, 2024, and \$179,726 for the year ended December 31, 2023.
3. Qualified Nonelective Employer Profit Sharing Contributions – The employer may make a discretionary contribution in an amount to be determined by the employer for each Plan year. Employer profit sharing contributions will be allocated to the individual accounts of qualifying participants using a pro rate formula, in the ratio that each qualifying participant's compensation for the Plan year bears to the total compensation of all qualifying participants for the Plan year. To be a qualifying participant and entitled to share in the employer profit sharing contribution for any Plan year, a qualifying participant must be an employee of the employer on the last day of the Plan year. The employer profit sharing contribution was \$26,812 for the year ended December 31, 2024, and \$27,907 for the year ended December 31, 2023.

**A. Description of Plan (Concluded)**

***Participant Accounts***

Each participant's account is credited with the participant's contribution, allocations of the Company's contributions, Plan earnings, and charged with an allocation of investment gains or losses, withdrawals, and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Investments***

Upon enrollment in the Plan, participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan.

***Vesting***

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. For QACA ADP Test Safe Harbor Matching Contributions, employees vest 100 percent after completing three years of credited service in accordance with the Plan document. For Qualified Nonelective Employer Profit Sharing Contributions, employees vest 20 percent per year after completing two years of service until becoming 100 percent vested after six years of credited service in accordance with the Plan document. Employees vest immediately if employment is terminated due to death, disability, or retirement upon attainment of the age of 65.

***Notes Receivable from Participants***

The Plan permits participants to borrow a minimum of \$1,000 (with a \$2,105 vested balance). Participants may borrow up to 95% of one half of the vested balance, not to exceed \$50,000 in a 12-month period. The notes are secured by the balance in the participant's account and bear interest at prime rate plus 1%. Only one loan is allowed at a time per participant. Principal and interest are paid ratably through payroll deductions and notes must be fully repaid within five years. Participant notes receivable are valued at their outstanding principal balance plus accrued and unpaid interest. As of December 31, 2024 and 2023, the Plan had outstanding notes to participants with principal balances totaling \$82,836 and \$89,973, respectively.

***Payment of Benefits***

On termination of service due to death, disability, or retirement, a participant could elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or various forms of annuities, as provided in the Plan document. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

***Forfeitures***

Forfeitures are created when participants terminate employment before becoming fully vested in all applicable contributions under the Plan. During the years ended December 31, 2024 and 2023, forfeited non-vested accounts totaled \$210 and \$1,070, respectively. These accounts are available to be used to reduce future employer contributions to the Plan. Employer contributions were reduced by \$210 and \$1,070 for the years ended December 31, 2024 and 2023, respectively.

***B. Summary of Significant Accounting Policies***

***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

***Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of certain assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, the actual amounts could differ from those estimates.

***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Net appreciation or depreciation of investments included in the accompanying statements of changes in net assets available for benefits includes realized gains or losses from the sale of investments and unrealized appreciation or depreciation in fair value of investments. Net unrealized appreciation or depreciation in the fair value of investments represents the net change in the fair value of the investments held during the year. The net realized gains or losses on the sale of investments represent the difference between the sale proceeds and the fair value of the investment as of the beginning of the year or the cost of the investment if purchased during the year.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

***Payment of Benefits***

Benefit payments to participants are recorded when paid.

***Operating Expenses***

Certain expenses for maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

**C. Certified Investment Information**

**D. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1 Fair Value Measurements**

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

**Level 2 Fair Value Measurements**

Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3 Fair Value Measurement**

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual Funds**

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Collective Trust Fund**

Valued at the NAV of units of a bank collective trust traded on NSCC Fund/SERV. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. Participant transactions (purchases and sales) may occur daily.

***F. Tax Status and Uncertain Tax Positions***

The Company has adopted a non-standardized plan pre-approved by the Internal Revenue Service (IRS). The IRS issued an opinion letter dated August 31, 2020, that the Plan is acceptable with the applicable section of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Company and the Plan administrator believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC and the Plan and related trust continue to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

***G. Reconciliation of Financial Statements to Form 5500.***

For the year ended December 31, 2024, the Form 5500 includes an adjustment of \$219,594 to net investment gains (losses) from registered investment companies to reconcile to net assets available for benefits on the December 31, 2024, financial statements. The reconciling item was included on Form 5500 due to a December 31, 2023, correction.

***H. Plan Termination***

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

***I. Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

***J. Subsequent Events***

The Plan administrator has evaluated events and transactions subsequent to the statements of net assets available for benefits date through the date of the independent auditors' report (the date the financial statements were available to be issued) for potential recognition or disclosure in the financial statements.
