Independent Auditor's Report

To the Plan Administrator and Participants

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Marquez Brothers International, Inc. and Affiliates 401(k) Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Opinion

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Marquez Brothers International, Inc. and Affiliates 401(k) Plan ("the Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan that was established on January 1, 1987 by Marquez Brothers International, Inc. ("the Company" or "Plan Administrator") covering all eligible employees of the Company and its affiliates as defined in the Plan agreement. Certain classes of employees as defined in the Plan agreement are excluded from plan participation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

A Plan Committee ("the Committee") manages the operation and administration of the Plan, including the appropriateness of the Plan's investment offerings and investment performance. The Company has contracted with Transamerica Financial Life Insurance Company Inc. ("Transamerica") to act as custodian and record-keeper to process and maintain the records of participant data. An employee of the Company serves as plan trustee.

The provisions of SECURE 2.0 Act of 2022 continue the themes and reforms that began with the 2019 SECURE Act. Certain provisions of both Acts have been implemented by the Plan and the Plan Administrator will continue to determine provisions which will impact the operation of the Plan. Participants should refer to plan documents for any changes made to the Plan.

Contributions - Each year, participants may contribute an amount of eligible pre-tax annual compensation as defined in the Plan agreement, not to exceed the maximum statutory amount. Participants who are age 50 or older can elect to make catch-up contributions to the Plan, not to exceed the maximum statutory amount. Participants may also contribute amounts representing distributions from other qualified eligible plans.

The Plan allows for an employer discretionary matching contribution subject to certain eligibility requirements. For the years ended December 31, 2024 and 2023, the Company matched 15% of each participant's contribution. The Company's discretionary matching contribution for the year ended December 31, 2024 was \$124,431 of which \$123,953 was a receivable as of December 31, 2024 and was paid in 2025, and \$14,424 was reported as part of the excess contributions payable as of December 31, 2024 and refunded in 2025. The Company's discretionary

matching contribution for the year ended December 31, 2023 was \$114,284 which was a receivable as of December 31, 2023 and was paid in 2024.

Participant Accounts - Each participant's account is credited with the participant's contributions, the Company's discretionary matching contribution, an allocation of plan earnings and losses, and plan expenses as applicable to the Plan. Allocations of plan earnings and losses are based on individual participant investment choices. All contributions/investments are participant directed. The benefit to which a participant is entitled to is the benefit that can be provided from the participant's vested account.

Vesting - Participants are 100% vested in their contributions and rollover amounts plus actual earnings thereon. Vesting in the discretionary matching contribution and earnings is based on years of credited service at the rate of 20% per year beginning at the end of second year with full vesting after 6 years. Participants become fully vested in the event of death, disability, retirement age, or plan termination.

Notes Receivable from Participants - Participant notes are not permitted by the Plan.

Payment of Benefits - Upon the satisfaction of certain distributable events, participants or their beneficiaries may elect to receive their vested account balance and are paid in accordance with plan provisions.

Forfeited Accounts - Forfeited accounts may be used to pay plan expenses or to reduce employer contributions. The forfeiture account balance was \$104,374 and \$121,100 as of December 31, 2024 and 2023, respectively. During 2024, custodian fees, advisory fees and plan audit fees in the amount of \$50,783 were paid through the forfeiture account.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value except for fully benefit-responsive investments which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Committee determines the Plan's valuation policies utilizing information provided by Transamerica. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions - Contributions from plan participants and employer matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

Excess Contributions Payable - Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability. As of December 31, 2024 and 2023, excess contributions payable in the total amount of \$114,731 and \$169,757, respectively, represent contributions and related earnings thereon due to impacted participants to comply with certain non-discrimination testing. The refunds were made in 2025 and 2024, respectively.

Plan Expenses - In 2024, some plan fees were paid by the Company and these amounts are excluded from the Plan's financial statements. Investment/fund fees, certain participant transaction fees, administration fees, audit fees and investment advisor fees are paid through the Plan and charged to participant accounts as applicable.

Payment of Benefits - Benefits are recorded when paid.

Subsequent Events - The Plan has evaluated subsequent events through September 24, 2025 the date the financial statements were available to be issued.

NOTE 3 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near

term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 4 - CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and ERISA required supplemental Schedule of Assets (Held at End of Year), including investments held at December 31, 2024 and 2023, interest and net appreciation in fair value of investments for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Transamerica.

NOTE 5 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active market that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts: Valued on a unitized share basis (similar to a net asset value (“NAV”) calculation) based on the value of the underlying investments in the pooled accounts. The NAV of a pooled separate account is calculated based on a compilation of primarily observable market information. The NAV is used as a practical expedient to estimate fair value for the funds. This practical expedient would not be used if it is determined to be probable that the funds will sell the investments for an amount different from the reported NAV. For the separate accounts, there are no unfunded commitments, the units can be redeemed daily, and there is no redemption notice period.

NOTE 6 - STABLE VALUE ACCOUNT

The Plan's Transamerica Stable Value Advantage Account maintains contributions at Transamerica in a general account. The fund is fully benefit responsive and is reported at contract value which approximates fair value as of December 31, 2024 and 2023. Contract value is the relevant measure for the fund since this is the amount received by participants if they were to initiate permitted transactions under the terms of the contract. Contract value, as reported by Transamerica, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal of all or a portion of their investment at contract value.

Transamerica is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan and participants. The crediting rate is based on a formula established by Transamerica. The crediting rate is reviewed periodically for resetting. Certain events as listed in the contract may limit the ability of the Plan to transact at contract value with the issuer. In addition, certain events allow the issuer to terminate the contract with the Plan. At this time, the Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring. There are no reserves against contract value as of December 31, 2024 and 2023. For this fund, there are no unfunded commitments and the units can be redeemed daily.

NOTE 7 - PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS

Plan investments are held by Transamerica. Any purchases and sales of these investments are performed in the open market at fair value or contract value. Plan related fees are paid to Transamerica, the Plan's auditor, and an investment advisory firm. The Plan has other service providers. All these transactions while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 8 - PLAN TERMINATION AND/OR MODIFICATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 9 - TAX STATUS

The Plan adopted a non-standardized pre-approved plan which received an opinion letter dated June 30, 2020 from the IRS. The Plan has been amended since, however, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by various taxing authorities and government agencies. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 10 - NONEXEMPT TRANSACTIONS

During 2023, certain participant contributions in the amount of \$7,030 were not deposited with the custodian on a timely basis in accordance with the Department of Labor's Rules and Regulations, resulting in lost earnings of \$28 (prohibited transaction amount) which was deposited into the Plan by the Plan Sponsor in 2024.
