We have performed audits of the financial statements of Whataburger 401(k) Savings Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## **Note 1. Description of the Plan**

### ***General***

The following description of Whataburger 401(k) Savings Plan (Plan) provides only general information. Participants should refer to the plan document for a complete description of the Plan's provisions.

The Plan is a defined contribution plan that covers all employees of Whataburger Restaurants, LLC, Whataburger Ventures, LLC, and Whatabrands, LLC (each a Participating Company). An employee will become an active participant on the first day of the month following three months of service during the period in which the Plan is in effect. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

### ***Contributions***

Each year, participants may elect to contribute up to 75% of eligible compensation, as described in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make "catch-up" contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. A Participating Company may contribute a portion of up to the first 6% of eligible compensation that a participant contributes to the Plan as a matching contribution. The Plan makes matching contributions each payroll period, and then, after the end of the plan year, there is a true-up matching contribution. The participant needs to be employed on the last day of the plan year to receive the true-up matching contribution or was not employed due to death or disability.

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of the Participating Company's contributions and plan earnings and is charged with an allocation of administrative expenses.

Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

Participants are immediately vested in their voluntary contributions plus earnings thereon. Participants' vesting in the Participating Company's contribution portion of their accounts plus earnings thereon is based on years of continuous service. Participants employed on or after January 1, 2020, by a Participating Company, will be fully vested in matching and profit-sharing contributions after three years of vesting service.

Participants and employees who terminated employment prior to January 1, 2020 and who are not rehired by a Participating Company will be fully vested in matching and profit-sharing contributions after completing six years of vesting service with a Participating Company.

### ***Payment of Benefits***

Upon termination of service, a participant may elect a lump-sum distribution or installment payments equal to the value of the participant's vested interest in his or her account. Any balance equal to or less than \$5,000 is automatically paid out in cash or rolled over to another eligible retirement plan subject to the participant's election. Hardship withdrawals are also available subject to certain limitations.

***Forfeitures***

At December 31, 2024 and 2023, the total forfeited from nonvested accounts during the year was \$297,119 and \$234,556, respectively. These accounts are used to pay expenses of the Plan and to reduce employer contributions. During 2024 and 2023, expenses of \$474,397 and \$338,278 and employer contributions of \$9,489 and \$627, respectively, were paid from forfeited nonvested accounts.

***Notes Receivable From Participants***

The minimum loan amount of any loan will be \$500 or such lesser amount established by the administrative committee from time to time up to a maximum of the lesser of: i) \$50,000 reduced by the excess, if any, of (A) the highest outstanding balance of loans to the participant from the Plan during the one-year period ending on the day before the day the loan is made, over (B) the outstanding balance of loans to the participant from the Plan on the date on which the loan is made, or ii) 50% of their vested account balance. Interest is based on a commercially reasonable rate at the time the loan is made. The maximum repayment period is generally five years unless the proceeds from the loan are used toward the purchase of the participant's principal residence. Repayments are made through payroll deductions and are reinvested in the individual funds according to the current investment allocations of the participant.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Mutual funds are valued at quoted prices in an active market which represent the net asset value (NAV) of shares held by the Plan at year-end.

Common/collective trusts are valued at NAV, which is based on the fair value of the underlying assets owned by the fund less any liabilities. The NAV, which is not publicly quoted, is available via the Plan's website or when Plan participants access their account values. It is the basis for current transactions, and units can be redeemed at NAV as of the measurement date. Therefore, these investments have a "readily determinable fair value." Because these investments are valued similarly to mutual funds, common/collective trusts are Level 1 assets.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

The Plan's administrative expenses are paid by either the Plan or the Participating Company, as provided by the plan document.

**Note 3. Certification by Plan Custodian**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Fidelity Management Trust Company (Fidelity) serves as the custodian and third-party administrator for the Plan. Accordingly, Fidelity, a qualified institution, certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023
- Investment income (loss), other income, and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment and notes receivable from participants information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with a fiduciary or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain plan investments are shares of mutual funds managed by Fidelity. Fidelity is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

The plan sponsor paid certain professional and administrative fees related to the Plan during the years ended December 31, 2024 and 2023. The Participating Company provides certain administrative services at no cost to the Plan.

**Note 5. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities

***Investments***

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. Level 1 securities include mutual funds and common collective trusts. If quoted market prices are not available, then fair values are estimated by using pricing models, quoted prices of securities with similar characteristics, or discounted cash flows.

In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. There are no Level 2 or 3 investments.

**Note 6. Plan Termination**

Although it has not expressed any intent to do so, the plan sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer's contributions.

**Note 7. Tax Status**

The Plan obtained its latest determination letter on December 15, 2017, in which the Internal Revenue Service stated that the Plan and related trust, as then designed, were in compliance with the applicable requirements of the Internal Revenue Code (IRC) and, therefore, not subject to tax. Although the Plan has been amended since the amendments included as of the filing of the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 9. Subsequent Events**

Effective January 1, 2025, the Plan was amended to update provisions related to vesting and safe harbor contributions. Additionally, changes were made to certain employer contribution provisions.

Effective May 28, 2025, the Plan was amended with respect to plan eligibility of certain classifications of employees.

Subsequent events have been evaluated through September 26, 2025, which is the date the financial statements were available to be issued.
