Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Advisors Asset Management, Inc. 401(k) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of DOL’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in *the Auditor’s Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the *Auditor’s Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Advisors Asset Management, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan, established January 1, 2008, is a defined contribution plan covering all employees of Advisors Asset Management, Inc. (the “Company” or “Employer”), who is not a resident of Puerto Rico, covered by a collective bargaining agreement for which retirement benefits have been the subject of good faith negotiations, a leased employee, and/or a nonresident alien with no income from a U.S. source. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The 401(k) Fiduciary Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan’s investment offerings, and monitors investment performance.

Contributions – Each year, participants may contribute up to the amount allowed by statute into the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans, which are retained as rollovers. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Participants may choose to make their contributions from pretax earnings, Roth, and/or after-tax earnings. Each year, the Company may contribute, at its sole discretion, amounts it designates as profit sharing or matching contributions up to the amount allowed by statute. During the year ended December 31, 2024, the Company contributed 50% of the first 6% contributed by each participant. Company matching contributions totaled \$1,222,738 for the year ended December 31, 2024. The Company made no profit-sharing contributions for the year ended December 31, 2024. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

Participant Accounts – Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and, (b) Plan earnings (losses), charged with withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are immediately vested in their rollover contributions, qualified non-elective contributions, regular contributions, and any earnings thereon. Vesting in the Company’s contributions portion of their accounts is based on years of continuous service. A participant is 100% vested after three years of credited service.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to the lesser of (1) \$50,000 less the highest outstanding note balance during the previous 12-month period or (2) 50% of their vested account balance. The notes are secured by the balance in the participant’s account.

NOTE 1 - DESCRIPTION OF THE PLAN (continued)

Note terms generally range from one to five years. Interest rates on new notes are based upon the prime rate as reported by Thomson Reuters. Principal and interest are paid through payroll deductions under a level amortization schedule. Interest rates on notes outstanding, as of December 31, 2024, range from 3.25% to 8.50%. For employees terminating employment with the Company during the repayment period, the balance of the outstanding loan is treated as a distribution. Interest income is recorded on the accrual basis.

Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits – Upon termination of service (death, disability, or retirement) a participant, or beneficiary in the event of death, may elect to receive a lump-sum distribution or installment payments in accordance with the Plan Agreement. Participants may elect in-service withdrawals of employee pretax contributions and rollover accounts. In-service withdrawals include hardship withdrawals and other withdrawals after age 59 ½. Participants may not make withdrawals of participant contributions, rollover contributions, and certain other contributions more frequently than two times per calendar year.

Forfeited Accounts – The Plan provides that non-vested portions of the Company’s contributions be forfeited by terminated participants and may be used to pay administrative expenses of the Plan or reduce the Employer’s contributions made in subsequent periods. Forfeited amounts available to be offset against Plan administrative expenses or future matching or discretionary contributions were \$14,639 and \$16,472 at December 31, 2024 and 2023, respectively. In 2024, the Company utilized \$33,026 of forfeitures to reduce Plan administrative expenses and employer matching contributions.

Plan Administration – Employer and employee contributions were held and managed by Fidelity Management Trust Company (“Fidelity”), a qualified institution and trustee of the Plan. Fidelity invested assets in accordance with participant directives and made distributions to participants. Certain administrative functions are performed by officers or employees of the Company who receive no compensation from the Plan.

Investments – Participants direct the investment of the accounts from a group of approved mutual funds offered by Fidelity. In addition, participants may invest using self-managed brokerage accounts. Assets in the self-managed brokerage accounts may be invested in publicly traded debt and equity securities, mutual funds, unit investment trusts, and certificates of deposit. Most other types of investments are not allowed for self-managed brokerage accounts.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Use of Estimates – The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes in those assets and liabilities and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits – Benefit payments to participants are recorded upon distribution.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes are treated as distributions based on the terms of the Plan document.

Investment Valuation and Income Recognition – The Plan’s investments are stated at fair value. Quoted market prices are used to value investments. Shares of mutual funds are valued at quoted market prices which represent the net asset value of shares held by the Plan at year-end. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The Plan presents, in the statement of changes in net assets available for benefits, the net appreciation (depreciation) in the fair value of its investments which consists of the realized gains or losses and the unrealized appreciation (depreciation) on those investments. This includes the Plan’s gains and losses on investments bought and sold, as well as, held during the year.

Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Subsequent Events – The Company has performed an evaluation of other subsequent events through September 30, 2025 which is the date the financial statements were available to be issued, and did not identify any other subsequent events which would require adjustment to or disclosure to the financial statements.

NOTE 3 - FAIR VALUE MEASUREMENTS

U.S. GAAP provides for a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Self-managed brokerage accounts consist primarily of Unit Investment Trusts, Common and Preferred Stocks, Corporate Bonds, Money Market Accounts and Mutual Funds, Certificates of Deposit, U.S. Government Bonds and Options.

The following is a description of valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money Market and Mutual funds – Valued at the daily closing price as reported by the fund. The money market and mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The money market and mutual funds held by the Plan are deemed to be actively traded.

Unit Investment Trusts - If not traded on an active market, the trusts are valued based on the underlying assets held in the trust. If actively traded, the trusts are valued at the closing price reported on the active market on which the individual units are traded.

Common Stocks, Preferred Stocks, Exchange-Traded Funds, Options and Warrants - Valued at the closing price reported on the active market on which the individual securities are traded.

Corporate Bonds - Valued at the closing price reported on the active market. If not traded on an active market, the bonds are valued at a spread above a U.S. Treasury Security of the same maturity, or the closest matching maturity.

Money Market Accounts (including interest bearing cash) - Valued at the NAV of shares held by the Plan at year end.

Certificates of Deposit - Measured at amortized cost, which approximates fair value given the instruments short duration.

U.S. Government Bonds - U.S. government bonds are valued using quoted market prices.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's investments in interest and non-interest bearing cash accounts are valued at cost, which approximates fair value. All other investments in the Statements of Net Assets Available for Benefits are reported at fair value. The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023:

NOTE 4 - INFORMATION PREPARED AND CERTIFIED BY TRUSTEE (unaudited)

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Accordingly, Fidelity, a qualified institution, has certified that the following information included in the financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments at fair value and notes receivable from participants as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Interest and dividends and net appreciation in fair value of investments, as shown in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information and notes receivable from participants information included in the Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

At the request of the Plan Administrator, the Plan's independent auditor did not perform auditing procedures with respect to the certified investment information, except for comparing such information to the related information included in the financial statements and ERISA-required supplemental schedule.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the employer contributions allocated to their accounts.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in mutual funds managed by an affiliate of Fidelity, who acts as trustee of the Plan's assets as defined by the Plan. In addition, the Plan invests in unit investment trusts sponsored by the Company and in mutual funds where the Company is the Advisor. These transactions qualify as party-in-interest transactions. However, they are exempt from the prohibited transaction rules. Fees paid by the Plan for the investment management services amounted to \$10,665 for the year ended December 31, 2024. In addition, during the year ended December 31, 2024, the Company paid for certain administrative and audit expenses on behalf of the Plan.

NOTE 7 - FEDERAL INCOME TAX STATUS

The Plan was adopted from a non-standardized form of a pre-approved plan sponsored by FMR, LLC (“FMR”). The IRS has determined and informed FMR by a letter dated June 30, 2020, that the Plan is acceptable under Section 401 of the IRS for use by employers for the benefit of their employees. Although the Company has made amendments to the pre-approved plan since adoption, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the U.S. federal, state, or local tax authorities. The Plan Administrator has evaluated tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, the Plan had maintained its tax exempt status and had taken no uncertain positions that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to income tax examinations by the U.S. federal, state, or local tax authorities over various statutes of limitations, most ranging from three to five years from the date of filing; however, there are currently no audits for any tax periods in progress. Any potential interest and penalty associated with a tax position would be included as a component of income tax expense in the period in which the assessment arises. The Plan Administrator has no reason to believe the Form 5500 is subject to examination for years prior to 2021.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.
