INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
Terra Worldwide Logistics 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Terra Worldwide Logistics 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit.] The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

1. DESCRIPTION OF THE PLAN

The following description of the Terra Worldwide Logistics 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan, which was established effective January 1, 2020, is a contributory defined contribution plan available to qualifying employees of Terra Worldwide Logistics (the Sponsor). To be eligible to participate in the Plan, an employee must complete three months of service. Participants can enter the Plan on the first payroll after meeting eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Result of an acquisition, Connect Global Logistics Inc. became a controlled group member.

Plan Administration

The insurance company and recordkeeper of the Plan is Voya Retirement Insurance and Annuity Company (VRIAC). VRIAC holds all assets of the Plan in accordance with the provisions of the group annuity contract with the Sponsor. All assets of the Plan are in investment plan accounts of VRIAC. The Plan administrator, ERISA Services, Inc., with input from Plan investment advisors, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

Each year, eligible participants may contribute pre-tax deferrals or Roth deferrals up to 100% of their eligible compensation, as defined in the Plan not-to-exceed the amount allowed for income tax purposes. Participants 50 years of age or older may make catch-up contributions as allowed by the Economic Growth and Tax Relief Reconciliation Act of 2001 (EGTRRA). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. A participant may cease making deferral contributions at any time during the Plan year. Upon enrollment in the Plan, participants direct the investment of their contributions into various investment options offered by the Plan. The Sponsor contributes a safe harbor matching contribution calculated as 100% of eligible compensation (as defined by the Plan) up to 6% and is vested immediately. The Sponsor may also make additional discretionary matching contributions. The Sponsor did not make a discretionary matching contribution for the year ended December 31, 2024. Contributions are subject to certain Internal Revenue Code (IRC) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Sponsor's matching contributions. Plan earnings (losses) are allocated based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants may direct their contributions and any related earnings into any investment fund option offered by the Plan under the group annuity contract with VRIAC. Participants may elect to transfer balances between funds within their account at any time. Investment options include a stable value fund and a pooled separate account (PSA). The PSA holds investment accounts which are distinct portfolios of mutual funds. Amounts allocated to any investment account are invested in shares of the corresponding mutual fund offered under the Plan.

Vesting

Participants are vested immediately in their contributions and the Sponsor safe harbor contribution, and the earnings thereon. Participants vest in discretionary employer contributions based upon years of service. Vesting for discretionary employer contributions is ratably at 33% a year after one year of service with full vesting after three years.

Payment of Benefits

Upon termination of service due to death, disability, retirement (age 65) or separation from service, a participant, or their beneficiary, may receive their vested balance in either a single lump-sum distribution, a direct rollover into a qualified retirement plan or individual retirement account, monthly installments or defer receiving payments until age 72. Terminated participants with a vested balance less than \$5,000 that have not elected payment will be cashed out. In-service distributions are available upon reaching age 59 ½, for financial hardships, as defined by the Plan, and from rollovers or after-tax accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contract which is reported at contract value). The fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Sponsor determines the Plan's valuation policies utilizing information provided by the investment advisers and VRIAC.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded when earned on the accrual basis. Net appreciation in the fair value of investments represents realized and unrealized losses and gains on the investments, as well as any fees charged within the pooled separate account.

Payment of Benefits

Benefits are recorded when paid.

Investment and Administrative Expenses

Certain fees and expenses may be charged to Plan investments (as an expense ratio) and are reflected in net appreciation in fair value of investments. Administrative expenses reflect individually requested transactions. Certain legal, professional fees and other usual and reasonable costs of administering the Plan are paid by the Sponsor.

Subsequent Events

In April 2025, Amalie Trade Compliance Consulting LLC, a participating employer and controlled group member of the Terra Worldwide Logistics 401(k) Plan, was acquired by its President through a stock repurchase from TWL Holdco, LLC. As a result of this transaction, employees of Amaile became ineligible to participate in the Plan pursuant to the Plan's eligibility requirements. These employees were subsequently transferred to a separate 401(k) plan sponsored by Amaile Trade Compliance Consulting LLC. This event occurred after the plan year-end and does not impact the financial position of the Plan as of December 31, 2024.

Management has evaluated subsequent events through September 22, 2025, which is the date the financial statements were available to be issued and have determined there are no further subsequent events which require disclosure under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 855, *Subsequent Events*.

3. CERTIFICATION BY INSURANCE COMPANY

Certain information related to investments from participants disclosed in the accompanying financial statements and the ERISA-required supplemental schedule, including investments held as of December 31, 2024 and 2023, and net appreciation in fair value of investments and interest income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by VRIAC.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurements*, are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value:

The PSA is made up of a variety of underlying investments in mutual funds. The net asset value (NAV) of a pooled separate account is based on the market value of its underlying investments adjusted for any dividends or distributions received by VRIAC and the daily equivalent of any fee charged by VRIAC pursuant to the contract. The pooled separate account's NAV is not a publicly quoted price in an active market. There are no unfunded commitments or redemption restrictions on the pooled separate account. The redemption frequency is daily.

The Plan's investments at fair value represent investments in a pooled separate account, which is valued using NAV practical expedient. Due to the adoption of FASB Accounting Standards Update (ASU) 2015-07 – *Fair Value Measurement (Topic 820): Disclosures for Investments in Certain Entities that Calculate Net Asset Value per Share or its Equivalent*, the Plan does not hold any investments requiring categorization within the fair value hierarchy.

5. GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY

The Plan is funded with a group annuity contract issued by VRIAC. The contract offers a fixed investment option and a number of variable investment options through a VRIAC PSA. The contract meets the fully benefit-responsive investment contract criteria; and therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts since this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value for the fixed option represents amounts contributed or transferred to the fixed option less any withdrawals or transfers out, plus all accrued interest. The fixed option earns interest at the higher of the rate guaranteed under the contract or the current rates established and declared in advance by VRIAC. Interest rates for new contributions are declared prior to the beginning of a calendar quarter and are applicable to all contributions received in that quarter until the end of the calendar year next following the current year. The fixed option is backed by VRIAC's general account. There are no reserves against the contract value for credit risk of the contract issuer as of December 31, 2024 and 2023.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive contracts is dependent on the third party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory requirements.

Certain events could limit the ability of the Plan to transact at contract value, including but not limited to, premature termination of the contract by the Plan. This would cause a one-time adjustment to the aggregate contract value, resulting in a fair value different from the contract value; however, the Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value are probable of occurring.

6. PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in units of a PSA and a fixed option managed by VRIAC. VRIAC receives amounts from fees charged within the PSA and are included in net appreciation in fair value of investments. Transactions with VRIAC qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would remain 100% vested in their Sponsor contributions.

8. TAX STATUS

The Sponsor adopted a volume submitter Plan document sponsored by ERISA Services, Inc., which received an advisory letter from the Internal Revenue Service (IRS) dated June 1, 2021, indicating that the volume submitter Plan is designed in accordance with the applicable sections of the IRC. The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and therefore, believes that the Plan is tax-exempt as of the financial statement date. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. RISKS AND UNCERTAINTIES

The Plan's investments offered under the group annuity contract with VRIAC include a PSA and a fixed option. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.
