## INDEPENDENT AUDITORS' REPORT

### TO THE RETIREMENT PROFIT SHARING INVESTMENT COMMITTEE AND PARTICIPANTS OF BASIC RETIREMENT SAVINGS PLAN

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed the audits of the financial statements of Basic Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

#### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

#### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Basic Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General – The Plan was established effective December 31, 1958. The Plan currently provides retirement benefits for certain employees of Basic American, Inc. and participating companies (the “Company”). The Plan is a defined contribution plan covering, generally, all employees, except leased employees and non-resident aliens. Coverage begins after the earlier of three full consecutive calendar months or 1,000 hours of service during a 12 consecutive month period beginning on the date of hire and anniversaries thereof or the date of rehire and anniversaries thereof. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

The Plan is administered by the Company’s Retirement Profit Sharing Investment Committee (the “Committee”). The Committee has overall responsibility for the operation and administration of the Plan. The Committee determines the appropriateness of the Plan’s investment selections and monitors investment performance.

Participant Contributions – Participants may make pre-tax, post-tax (“Roth”) and voluntary after-tax contributions to the Plan. A participant’s combined annual pre-tax and Roth contributions to the Plan cannot exceed 75% of the participant’s annual compensation, limited to \$23,000 for the taxable year ended December 31, 2024. A participant may increase or decrease the amount of contributions at anytime. Additionally, participants who are 50 or older at the end of the year may make catch-up contributions in excess of the annual limit noted above up to \$7,500 for the taxable year ended December 31, 2024. Total combined employee and employer contributions is limited to \$69,000 (\$76,500 if eligible for catch-up contributions) for the taxable year ended December 31, 2024.

Once an employee satisfies the eligibility requirements and if he or she does not make a deferral election within a reasonable period of time after he or she is hired, rehired or reclassified, or affirmatively opts out, the employee’s eligible compensation automatically will be reduced by 6% and that amount shall be deemed the employee’s deferral election.

Effective July 15, 2023, each eligible employee whose deferral election is below 12% will automatically have his or her deferral election increased by 1% unless the employee elects otherwise for that year or creates his or her own deferral election increase schedule. Effective November 1, 2024, the Plan was amended so that an eligible employee whose deferral election is below 15% as of any year will automatically have his or her deferral election increased by 1% unless the employee elects otherwise for that year or creates his or her own deferral election increase schedule.

Employer Contributions – The Company may make a discretionary profit sharing contribution on behalf of participants compensated on a salaried basis. This profit sharing contribution is expressed as a percentage of participants’ compensation and is allocated to participants’ accounts. The Company made a profit sharing contribution at 8% of salaried participants’ eligible compensation for 2024.

NOTE 1 – DESCRIPTION OF THE PLAN (Continued)

Employer Contributions (Continued) – The Company matches contributions made by Company employees who are compensated on an hourly basis by contributing an amount equal to 50% of each participant’s contribution, up to the first 6% of the participant’s eligible compensation. The Company may change this formula at any time.

The Plan provides for additional employer contributions, which are allocated to certain hourly paid employees who are not covered by a collective bargaining agreement. The amount of these contributions varies based on factors such as the participant’s age and whether the participant previously participated in a defined benefit plan sponsored by the Company.

All contributions to the Plan are subject to limits established by the Internal Revenue Code (“IRC”). Contributions are recorded in the Plan year which coincides with the payroll pay date.

Participant Accounts – The Plan maintains an account for each participant, which is credited with the participant’s contributions, employer matching and additional contributions, as well as, allocations of the Company’s profit sharing contributions, Plan investment earnings or losses and expenses. Allocations are based on participant compensation or account balances, as defined by the Plan agreement. The benefit to which a participant is entitled is the benefit that may be provided from the participant’s vested account.

Investment Options – A participant is allowed to direct the investment of his or her account balance into various investments offered through the Plan, including self-directed brokerage accounts.

Vesting – Participants are immediately vested in their pre-tax contributions, after-tax contributions, Roth contributions, rollovers, and additional employer contributions plus actual earnings thereon. Vesting in profit sharing and matching contributions is based on periods of service in accordance with a 5-year graded scale as follows:

4 years	80
5 years	100

Vesting is 100% if, while employed by the Company (or an affiliated company as defined in the Plan), the participant dies, becomes disabled (as defined in the Plan), or reaches normal retirement age.

Vesting (Continued) – Each participant who was an employee of the Basic American Potato Company, an affiliate as defined by the Plan, and was actively employed on October 1, 2016 shall be 100% vested in his or her Plan benefits. Employees working at the Basic American Potato location in Blackfoot, Idaho as of January 31, 2020 shall be 100% vested in his or her Plan benefits. Employees working in a production capacity in Shelley, Idaho as of February 28, 2020 shall be 100% vested in his or her Plan benefits. Employees working in a packaging capacity in Shelley, Idaho as of June 30, 2021 shall be 100% vested in his or her Plan benefits. Employees of Heartland Harvest, Inc. (“Heartland Harvest”), a former adopting employer, who were hired on or before December 31, 2019 shall be 100% vested in his or her plan benefits. Heartland Harvest employees who were actively employed on September 1, 2023 shall be 100% vested in his or her Plan benefits.

Notes Receivable from Participants – Participants may borrow from their vested account balance, excluding Roth and In-Plan Roth rollover sources, provided they meet the Plan’s eligibility requirements. The minimum loan amount is \$1,000 and the maximum amount is the lesser of one-half of the participant’s vested account balance or \$50,000. The term of the loan is not to exceed five years, except for loans used to finance the purchase of a participant’s principal residence, which may not exceed 15 years. The loans are secured by the balance in the participant’s account. Interest rates are determined based on current interest rates charged by persons in the business of lending money for similar loans at the time the loan is made and remain fixed throughout the life of the loan. Principal and interest are paid ratably through payroll deductions and loans are due immediately upon termination of employment.

Payments of Benefits – Upon termination of employment, death, disability or retirement, a participant or beneficiary is entitled to receive the value of the participant’s vested interest in his or her account (a) as one or more lump-sum payments, or (b) in installments. In addition, a single participant can elect to receive a single life annuity and a married participant can elect to receive a 50% joint and survivor annuity. Normal retirement is 65 years of age. A participant also can take a distribution of his or her rollover contributions or voluntary after-tax contributions (if any) at any time, of his or her total vested account upon reaching age 59½, and of his or her salary deferrals upon incurring a hardship, as defined by the Plan. Benefit payments to the participant generally must begin by the later of the year after the participant attains age 73 or the year in which the participant terminates employment. A balance less than \$1,000 will be distributed directly to the participant as a lump-sum payment.

Forfeited Accounts – A participant’s non-vested account may be forfeited upon severance of employment. As of December 31, 2024 and 2023, outstanding forfeited non-vested account balances were \$102,189 and \$14,365, respectively, and are included in the investments in the Statements of Net Assets Available for Benefits. Forfeitures may be used to restore non-vested accounts of employees who are rehired, to pay Plan fees, and/or to reduce the Company’s contributions. During the year ended December 31, 2024, forfeitures of \$94,725 and \$3,965 were used to pay Plan fees and reduce employer contributions, respectively.

#### NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The Plan prepares its financial statements on the accrual basis of accounting, in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s management determines the Plan’s valuation policies utilizing information provided by its investment advisers, custodians, and investment managers. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are charged to expense when they are incurred.

Excess Contributions Payable – Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (“IRS”) are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants in 2025 and 2024, respectively.

Payments of Benefits – Benefit payments to participants are recorded upon distribution.

Expenses – Expenses will be paid by the Plan if not paid by the Company. Fees related to the administration of notes receivable from participants, distributions, self-directed brokerage account options and certain investment management services are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation of fair value of investments.

#### NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for Plan assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Interest-Bearing Cash: Valued at cost which represents fair value.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-Directed Brokerage Accounts: Accounts consist of mutual funds, which are valued as described above; common stock, preferred stock, exchange-traded funds and real estate investment trusts valued at the closing price reported on the active market on which the individual securities are traded; corporate bonds valued using pricing models maximizing the use of observable inputs for similar securities; and interest-bearing cash valued at cost which represents fair value.

NOTE 3 – FAIR VALUE MEASUREMENTS (Continued)

Common Collective Trust Fund: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### NOTE 4 – INFORMATION CERTIFIED BY THE TRUSTEE OF THE PLAN

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank, the trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the supplemental Schedule H, line 4i: Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on participant notes receivable reflected in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

#### NOTE 5 – TAX STATUS

The IRS has determined that the non-standardized pre-approved profit sharing plan on which the Plan has adopted, is designed in accordance with applicable sections of the IRC and informed the trustee of such in a letter dated September 21, 2020. Although the Plan has been amended since receiving the opinion letter, the plan investment committee believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process.

#### NOTE 6 – PLAN TERMINATION

Although it has not expressed any intention to do so, the Company reserves the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Benefits will be held in the trust fund which will remain in existence until the Company requests the discontinuance of the trust agreement.

#### NOTE 7 – RELATED-PARTY TRANSACTIONS

During 2024 and 2023, the Plan held certain investments in mutual funds managed by Charles Schwab & Co., Inc. and interest-bearing cash with Schwab Bank, both affiliates of Charles Schwab Trust Bank. Charles Schwab Trust Bank is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

A portion of fees incurred and paid by the Plan to Schwab Retirement Plan Services, Inc., an affiliate of Charles Schwab Trust Bank, for brokerage services are included in net appreciation in fair value of investments. In addition, fees paid directly by the Plan to Schwab Retirement Plan Services, Inc. for recordkeeping services amounted to \$128,208 and are included in administrative expenses in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024. As of December 31, 2024 and 2023, recordkeeping services fees due to Schwab Retirement Plan Services, Inc. of \$32,791 and \$34,548, respectively, are included in administrative expenses payable in the Statements of Net Assets Available for Benefits.

In addition, fees related to the administration of notes receivable from participants and certain investment management services which are provided by Schwab Retirement Plan Services, Inc. are charged directly to participant accounts which amounted to \$255,132 for the year ended December 31, 2024.

The Plan reimburses the Company for the time an employee of the Company spends performing administrative services for the Plan. Costs reimbursed by the Plan were \$76,801 for the year ended December 31, 2024. Administrative fees due to the Company of \$28,396 and \$28,786 are included in administrative expenses payable in the Statements of Net Assets Available for Benefits at December 31, 2024 and 2023, respectively.

The Plan also pays directly any other fees related to the Plan's operations if not paid by the Company.

#### NOTE 8 – RISKS, UNCERTAINTIES AND CONCENTRATIONS

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

As of December 31, 2024 and 2023, three funds accounted for 44% of total investments.

#### NOTE 9 – PLAN OPERATIONAL ERRORS

During the years ended December 31, 2024, 2023 and 2022, management of the Plan discovered that there were certain discrepancies in the application of eligible compensation for operational employees in certain locations. The Plan's management has researched these matters and is in the process of implementing the corrective actions. Plan management believes any potential corrective action amount will be insignificant to the financial statements.

#### NOTE 10 – SUBSEQUENT EVENTS

Effective January 1, 2025, employees between the ages of 60 and 63 are eligible for increased catch-up contributions. The increased catch-up limit for individuals in this age bracket is the greater of \$10,000 or 150% of the regular catch-up contribution limit for those aged 50 and older.

Effective January 1, 2025, the Plan amended employer contributions for salaried employees. As of January 1, 2025, all salaried employees will receive employer contributions equal to 3% of eligible compensation. In addition, employees employed on or before May 27, 2025, will receive an additional employer match equal to 100% of employee contributions up to 5% of eligible compensation. Employees hired after May 27, 2025, will receive an additional employer match equal to 100% of employee contributions up to 3% of eligible compensation for the first 5 years of employment; after 5 years of employment, the employer match increases from 3% to 5% of eligible compensation. A salaried employee must complete 3 months of service to be eligible for these employer contributions.

The Plan's management has evaluated subsequent events through September 23, 2025, which is the date the financial statements were available to be issued.
