**NOTE 1 DESCRIPTION OF PLAN**

The following description of the Uponor North America Retirement Savings and Investment Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering substantially all employees of Uponor North America, Inc. (the Company). The Plan was established July 1, 1996. The Plan has been amended and restated throughout the years to comply with tax legislation and was most recently restated effective January 1, 2022 and last amended July 1, 2024 to add installments as a distribution option. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Eligibility**

Employees who have 30 days of service and are age 21 or older are eligible to participate in the Plan. However, an individual performing services for the Company as an independent contractor, agent, consultant, self-employed individual, nonresident alien, or leased employee is not eligible to participate in the Plan. Plan entry dates are the first day of the month coinciding with or next following the completion of the above eligibility requirements.

**Contributions**

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a percentage, limited by Plan provisions, of their compensation contributed as pre-tax 401(k) or Roth contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company makes a safe harbor matching contribution equal to 100% of elective deferrals that do not exceed 4% of eligible compensation. The Company may also make a discretionary profit sharing contribution. There were no Company discretionary contributions for the years ended December 31, 2024 and 2023.

The Plan includes an auto-enrollment provision whereby all eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation, and their contributions invested in the designated default fund until changed by the participant. Employee contributions are automatically increased by 1% annually up to a maximum deferral percentage of 10%.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, the Company's safe harbor matching and profit sharing contributions, an allocation of Plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or participant transactions, as defined. Income is allocated daily based on the shares in the participant's account. Participants may direct their accounts into various investment options. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

**Vesting**

Participants are immediately vested in deferral and matching contributions plus actual earnings thereon. A participant is 100% vested in the profit sharing contribution portion of their account after five years of service. A participant is fully vested in all contributions and earnings thereon upon reaching normal retirement age, upon death, or upon permanent disability.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Note terms range up to five years or up to 10 years for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest based on the prime rate. Principal and interest are generally paid ratably through bi-weekly payroll deductions.

**Benefit Payments**

Participants may elect to receive the value of their account as a lump sum distribution or in installments upon termination, retirement, death, or disability. Vested account balances less than \$5,000 will be automatically distributed without the participants consent. Effective June 13, 2024, the vested account balance amount to be automatically distributed without the participants consent was increased to \$7,000. If the vested balance exceeds \$1,000, the amount will be paid in a direct rollover to an Individual Retirement Account. Provided certain conditions are met, the Plan also allows in-service distributions upon attainment of age 59½ and hardship withdrawals to participants during employment.

**Forfeited Accounts**

Forfeited nonvested accounts are first used to pay Plan expenses and are then used to reduce safe harbor matching contributions. Forfeited nonvested accounts shall be applied in the Plan year following occurrence. Forfeited nonvested accounts totaled \$3,493 and \$3,318 as of December 31, 2024 and 2023. No forfeitures were used to pay Plan expenses or reduce safe harbor matching contributions for the years ended December 31, 2024 and 2023.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual basis of accounting.

**Investment Valuation and Income Recognition**

The Plan's investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the trustees. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expense.

**Payment of Benefits**

Benefit payments are recorded when paid.

**Subsequent Events**

The Plan has evaluated subsequent events through September 23, 2025, the date the financial statements were available to be issued.

**NOTE 3 FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in valuation methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Trust Fund:* Valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

**NOTE 4 PLAN TAX STATUS**

All required filings of Plan documents with the appropriate agencies have been made. The Plan is placing reliance on an opinion letter received from the IRS on the nonstandardized pre-approved profit sharing plan with cash or deferral arrangement indicating that the Plan is qualified under Section 401 of the Internal Revenue Code (IRC) and is therefore not subject to tax under current income tax law. The nonstandardized pre-approved profit sharing plan with cash or deferral arrangement has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 5 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants will become 100% vested in their accounts.

**NOTE 6 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investments are exposed to various risks such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 7 CERTIFICATION OF INVESTMENT INFORMATION**

Charles Schwab Trust Bank, the qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of notes receivable from participants and all investment information presented in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statements of changes in net assets available for benefits for the years then ended, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 8 TRANSACTIONS WITH PARTIES-IN-INTEREST**

Transactions related to funds managed by the qualified institution qualify as exempt party-in-interest transactions.
