Opinion

We have audited the financial statements of James Craft & Son, Inc. Employee Benefit Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and benefit obligations as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits and changes in benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and benefit obligations of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and changes in benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Note 1 - Description of Plan

The following description of the James Craft & Son, Inc. Employee Benefit Plan (the Plan) provides only general information. Participants should refer to the plan agreement for more complete information.

General

The Plan is a welfare benefit health and welfare plan that provides benefits to all full-time employees of James Craft & Son, Inc. (the Company) who work at least 30 hours per week and have completed 60 days of service as well as former employees electing coverage under the Consolidated Omnibus Budget Reconciliation Act of 1985 (COBRA) provisions. Benefits are also provided to dependents of these individuals who elect coverage on their behalf. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan's health benefits (dependent care flexible spending account, hospital, major medical, medical, medical flexible spending account, prescription drug, and surgical) and some short-term disability benefits are self-insured by the Company. Claims for these self-insured benefits are processed by the Plan's third-party administrators (TPAs) under administrative services only arrangements. The TPAs pay claims directly to or on behalf of participants. The payments for these claims are paid by the Plan's custodial account, which is funded by the general assets of the Plan Sponsor. Despite the Plan's utilization of TPAs for claims processing, the ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan fully insures the accidental death and dismemberment, dental, life insurance, long-term disability, vision, and voluntary life insurance, as well as some short-term disability benefits. The Company purchases annual insurance contracts for these insured benefits. Premiums for these insured benefits are paid by either the Plan's custodial account or trust checking account, which are funded by the general assets of the Company.

Contributions

The Company shall contribute such amounts to the Plan as necessary for timely payment of all claims and administrative expenses of the Plan. The Company provides for stop loss insurance over a specified amount as per agreement with the reinsurance carrier, with the premiums being paid by funds deposited in the Plan. Employee contributions are determined on a fixed fee basis. The amount varies depending on the selection of individual or eligible dependent coverage.

Benefits

The Plan provides health benefits (medical, major medical, hospital, prescription drug, surgical, dental, and vision) to substantially all employees of the Company who meet the age and service requirements of the Plan and to their covered dependents. The Plan also provides accidental death and dismemberment, dependent care and medical flexible spending accounts, life insurance, long-term disability insurance, short-term disability insurance, and voluntary life insurance for eligible full-time employees. Active, full-time employees whose job class is management, superintendents, estimators, or foreman, and who have 10 years of service, are eligible for long-term disability benefits. The Plan also provides continuation of certain benefits upon termination of employment through COBRA as defined in the plan document.

Benefits (continued)

The Company provides most health insurance benefits and pays the administrative fees incurred. The employees pay a portion of their health coverage based upon the coverage chosen through payroll deferrals.

Current health claims are processed through the Aetna network.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, claims incurred but not reported, claims payable, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Cash and Cash Equivalents

The custodial account consists of restricted cash deposits with the TPAs made by the Plan to alleviate timing differences with respect to claims paid versus claims billed by the TPAs.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Payment of Benefits

Premiums paid by the trust are recorded as premium payments in the accompanying statement of changes in net assets available for benefits when paid.

Claim payments are recorded when paid by the third-party claims processor. Out of network fees associated with claims are recorded in benefit payments.

Stop Loss Insurance

The Plan has a stop loss insurance arrangement whereby the stop loss insurance will cover the Plan's obligations for any plan participant's claims in excess of a fixed dollar amount (self-insured retention). The self-insured retention for the Company was \$65,000 and \$60,000 per covered person for the years ended December 31, 2024 and 2023, respectively.

Stop Loss Insurance (continued)

In addition, the Plan has an aggregate stop loss insurance arrangement whereby the aggregate stop loss insurance will cover the Plan's obligations if all claims exceed a fixed dollar amount. Premiums for stop loss insurance are included in insurance premiums in the accompanying statement of changes in net assets available for benefits. Stop loss refunds of \$147,625 and \$197,582 have been netted with claims paid, net in the accompanying statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, respectively.

Plan Benefit Obligations

Plan obligations at December 31, 2024 and 2023 for health claims payable and claims incurred by active participants, but not reported at that date, are estimated by the Plan's actuary. Such estimated amounts are reported in the accompanying statement of benefit obligations. Due to the short-term nature of the reserve liability, time value of money was not used to discount future payments. It is the Plan's policy that deductions for claims are recorded when paid.

Administrative Expenses

The Plan pays administrative expenses that consist primarily of administrative fees paid to the TPAs. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses. All other administrative fees are paid by the Company on behalf of the Plan. Substantially all administrative expenses of the Plan, including, but not limited to, costs related to claims processing are paid from plan assets. Certain other administrative expenses of the Plan, including certain recordkeeping services and professional fees, are also paid from plan assets.

Note 3 - Plan Administration

The Plan has entered into a service agreement with Luminare to provide consulting and administrative services. Luminare is responsible for determining eligibility of the claiming person, evaluating the validity of the claim, calculating the amount of the claim payable, if any, and issuing a check payable to the provider of services, or to the employee in accordance with the terms of the Plan. Luminare charges a fee based on the number of employees participating in the Plan.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2024 and 2023.

Shares of the money market fund are valued at the quoted net asset value of shares held by the Plan at year-end.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - Tax Status

The trust established under the Plan to hold the Plan's net assets is qualified pursuant to Section 501(c)(9) of the Internal Revenue Code (IRC) and, accordingly, the trust's net investment income is exempt from income taxes. The trust obtained a favorable determination letter on October 26, 1982, in which the Internal Revenue Service, and the Company believes that the Plan, as amended, continues to qualify and operate as designed.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the U.S. Federal, state, and local tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of, active employees, discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

Note 7 - Risks and Uncertainties

The Plan maintains cash in bank deposit accounts which may, at times, exceed federally insured limits. The Plan has not experienced any losses in such account. The Plan believes it is not exposed to any significant credit risk on cash.

The Plan invests in a money market fund and is exposed to various risks such as interest rate, market, and credit risks. Due to the minimal level of risk associated with the money market fund, it is unlikely but remotely possible that changes in the values of the investment will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions, including level of past claims. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Note 8 - Related Party Transactions and Party-In-Interest Transactions

Certain cash and cash equivalents and investment accounts are managed by Fulton Bank, the custodian of the Plan, and therefore, these transactions qualify as party-in-interest. Fees paid by the Plan for investment management and custody services are immaterial. As described in Notes 1, 2, and 3, the Plan has several arrangements with service providers. These transactions are party-in-interest transactions under ERISA.
