The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits (modified cash basis) for the years then ended, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

**Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our opinion is not modified with respect to this matter.

**Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about 403(b) Thrift Plan for Land of Lincoln Goodwill Industries, Inc.'s ability to continue as a going concern for one year after the date that the financial statements are issued.

**NOTE A | DESCRIPTION OF PLAN**

The following description of 403(b) Thrift Plan for Land of Lincoln Goodwill Industries, Inc. (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*1. General*

The Plan is a defined contribution 403(b) plan covering all eligible employees of Land of Lincoln Goodwill Industries, Inc., the Plan Sponsor. Employees are eligible to make voluntary salary deferral contributions upon start of employment. To receive employer contributions, participants must be 21 years of age and have completed one year of service (1,000 hours of service). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*2. Contributions*

The Plan Sponsor matches contributions up to 3% of eligible employee contribution. Participants may make voluntary employee salary reduction contributions subject to certain IRS limitations. For 2024 and 2023, the elective deferral limit was \$ 23,000 and \$ 22,500, respectively. However, participants over the age of 50 are eligible to make catch-up contributions up to \$ 7,500 in 2024 and 2023.

*3. Participant Accounts*

Each participant's account is credited with the participant's salary reduction contribution, the employer's contribution, and an allocation of Plan earnings. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*4. Vesting*

Participants' vesting is based on continuous service. Employees' salary reduction contributions are 100% vested. Vesting of the other account elements is based on the vesting schedule as follows:

Less than 2	0 %
2 but less than 3	20
3 but less than 4	40
4 but less than 5	60
5 but less than 6	80
6 or more	100

Participants will become 100% vested at age 55 upon termination of employment for early retirement. Full vesting will also occur in the case of disability or death.

*5. Benefits*

On termination of service due to death, disability or retirement, a participant or his or her beneficiary may elect to receive a lump-sum amount equal to the value of the participant's account, a qualified joint and survivor annuity if the participant is married, or various annuity and installment payment options if the participant is not married. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

*6. Notes Receivable from Participants*

Participants may borrow from their accounts a minimum of \$ 1,000 up to a maximum equal to the lesser of \$ 50,000 or 50% of their vested interest in the Plan. Loans are to be paid within a reasonable period of time. The loans must be adequately secured and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator.

**NOTE A | DESCRIPTION OF PLAN**

*7. Forfeited Accounts*

These accounts are first used to pay for certain Plan expenses and then to supplement employer contributions. During the years ended December 31, 2024 and 2023, \$ 6,804 and \$ 8,516, respectively, from forfeited accounts were used to pay plan expenses. At December 31, 2024 and 2023, forfeited non-vested amounts totaled \$ 8,838 and \$ 8,605, respectively.

**NOTE B | SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements follows:

*1. Basis of Accounting*

The financial statements of the Plan are prepared using the modified cash basis of accounting. Investments are stated at fair value. All additions and related assets are recognized when collected rather than when earned, and deductions are recognized when paid rather than when the obligation was incurred. Accordingly, the financial statements are not intended to present net assets available for benefits and changes in net assets available for benefits in accordance with accounting standards generally accepted in the United States of America.

*2. Use of Estimates*

The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Accordingly, actual results may differ from those estimates.

*3. Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for further discussion of fair value measurements.

Purchases and sales are recorded on a trade-date basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Dividends are recorded on the ex-dividend date.

**NOTE B | SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*4. Notes Receivable from Participants*

Loans to participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred.

*5. Plan Expenses*

Certain expenses associated with the Plan are paid from forfeited non-vested accounts. Any remaining expenses related to the maintenance of the Plan are paid by the Plan Sponsor. Fees related to the administration of notes receivable from participants are charged to the participant's account and included in administrative expenses. Certain investment related expenses are included in net appreciation (depreciation) of fair value of investments.

*6. Payment of Benefits*

Benefits are recorded when paid.

*7. Subsequent Events*

Management has evaluated subsequent events for recognition and disclosure in the financial statements through October 3, 2025, which is the date the financial statements were available to be issued. Through October 3, 2025, no subsequent events required recognition or disclosure in the financial statements.

**NOTE C | SUMMARY OF FINANCIAL INFORMATION CERTIFIED BY THE CUSTODIAN**

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, permitted under such election, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Capital Bank and Trust Company (custodian), except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplemental schedule.

**NOTE D | FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Valuation is based on quoted prices for identical assets and liabilities in active markets.

Level 2 - Valuation is derived from inputs, other than quoted prices included in Level 1, which are observable for the asset or liability either directly or indirectly. Investments classified as Level 2 are generally valued by benchmarking model-derived prices to quoted market prices and trade data for identical or comparable securities. The significant inputs used in this approach include interest rates, prepayment timing, yield spreads, maturities, credit losses and credit ratings of the securities.

Level 3 - Valuation is derived from unobservable inputs that are not corroborated by market data.

**NOTE D | FAIR VALUE MEASUREMENTS**

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable relevant inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds are valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Although management has not expressed any intent to do so, the Plan may be terminated at any time by the Plan Sponsor. In the event of partial or total plan termination, participants will be entitled to the full amount in their accounts as of the date of termination, regardless of the percent vested at the time of termination.

**NOTE F | RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments are managed by American Funds and recordkeeping services are provided by Capital Group Retirement Plan Services and Capital Research and Management. American Funds, Capital Group Retirement Plan Services, and Capital Research and Management are related-parties of Capital Bank and Trust through common ownership. Capital Bank and Trust Company is the custodian for the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees for recordkeeping services totaled \$ 5,204 and \$ 8,050 for the years ended December 31, 2024 and 2023, respectively. Audit related fees of \$ 3,744 and \$ 2,692 were paid to Kerber, Eck & Braeckel LLP for the years ended December 31, 2024 and 2023, respectively, which also qualifies as a party-in-interest transaction.

**NOTE G | TAX STATUS**

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code. The Plan was created from a pre-approved plan document that has received an opinion letter from the IRS dated March 31, 2017, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code. Although, the Plan has been amended since adopting the pre-approved plan document; the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

The modified cash basis of accounting requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE H | RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
