Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Planned Companies 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion—

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

NOTE 1. DESCRIPTION OF THE PLAN

The following description of the Planned Companies 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Planned Companies Holdings, Inc. (the "Sponsor") and other related companies of the Sponsor that have adopted the Plan's provisions as a participating employer (collectively the "Company"). All employees, other than excluded employees as defined by the Plan, are eligible to participate in the Plan upon the 1st day of the month after completing two months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to 75% of their pretax annual compensation, as defined in the Plan, up to the statutory maximum. Roth contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans as rollover contributions. The Company made matching contributions equal to 40% of the first 6% of compensation that a participant contributed to the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution, allocations of the Company's contribution and earnings from participant directed investments, net of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants with 3 or more years of service shall be 100% vested in all accrued and future employer contributions.

Forfeitures

Forfeitures are those amounts of the Company's matching contributions in which a participant is not fully vested at the time of termination. These accounts are used to reduce future employer contributions or pay plan expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$29 and \$1,556, respectively. During 2024, \$56,348 of forfeited non-vested accounts were used to reduce employer contributions and \$26,957 of forfeited non-vested accounts were used to pay Plan expenses.

NOTE 1. DESCRIPTION OF THE PLAN (Continued)

Investment Options

Upon enrollment in the Plan, a participant may direct the investment of their contributions to various investment options offered by the Plan. The Plan allows participants to change their investment options daily.

Notes Receivable from Participants

A participant may borrow from their fund account a minimum of \$500 up to a maximum equal to the lesser of 50% of a participant's vested account balance or \$50,000. Participants may only have up to one loan outstanding at a time. The loans are secured by the balance in the participant's account and bear interest at the prime rate, plus 1%, based on the loan application date. Principal and interest is paid ratably through payroll deductions.

Plan Administration

The Plan is administered by the Company. The Plan assets are maintained by its trustee, Empower Trust Company, LLC ("Empower"). The Plan's record-keeper is JP Morgan Invest Holdings LLC ("JP Morgan").

Payment of Benefits

On termination of service due to death, disability or retirement, a participant receives a lump-sum amount equal to the value of the participant's vested interest in his or her account or installments over a period not to exceed the participant's estimated life expectancy. If the participant's vested account balance is greater than \$1,000, but such balance is \$5,000 or less at the date of death, disability, retirement or termination of employment, and the participant has failed to make a distribution election, the participant's vested interest in his or her account will be automatically rolled over into an IRA. Also, if the participant's vested account balance is \$1,000 or less, and a timely distribution or rollover election is not made, the participant's vested account balance will be paid directly to the participant by check as a mandatory distribution. For termination of services for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their allocation of employer contributions.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition

All of the Plan's investments are stated at fair value, except for its common collective trusts, which are stated at the net asset value as a practical expedient to estimate fair value. The net asset value of the common collective trusts are based on the fair value of the underlying investments less its liabilities. Shares of mutual funds are valued at quoted market prices which represent the net asset value of shares held by the Plan at year end. Security transactions are recorded on a trade date basis, which is the date the order to buy or sell is executed. Interest income is accrued on a daily basis. Dividend income is recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Benefit Payments

Benefit payments to participants are recorded when paid.

Plan Expenses

Certain administrative functions are performed by employees of the Company. Such employees receive no compensation from the Plan. Certain administrative expenses, such as professional fees, may be paid directly by the Company. Plan expenses are recorded when incurred.

The Plan has an ERISA Spending Account ("Spending Account") that is funded through revenue sharing arrangements with certain mutual funds that are included as part of the Plan's investment options. The funds in the Spending Account are used to pay third-party service providers for services rendered to the Plan. Any unused amounts held in the Spending Account are allocated back to the participants at the direction of the Plan Sponsor. During the year ended December 31, 2024, \$9,450 of Spending Account funds have been used to pay Plan expenses. At December 31, 2024 and 2023, funds held in the Spending Account totaled \$56,480 and \$25,668, respectively.

Party-In-Interest Transactions

The Plan has notes receivable from participants as well as certain Plan investment that are managed by, JP Morgan. These transactions qualify as party-in-interest transactions.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Risk and Uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Concentrations

All of the Plan's investments were held by, Empower, located in Greenwood Village, Colorado.

Use of Estimates in the Preparation of Financial Statements

The preparation of financial statements, in conformity with accounting principles generally accepted in the United States of America, requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 3. INFORMATION PREPARED AND CERTIFIED BY EMPOWER (UNAUDITED)

The following information included in the accompanying financial statements and supplemental information was obtained by management and agreed to or derived from data that has been prepared by and certified as complete and accurate by Empower.

For the year ended December 31, 2024, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the Plan year) appreciated in value by \$794,885.

In addition, during the year ended December 31, 2024, dividends related to the Plan's investments and interest on notes receivable from participants amounted to \$417,469 and \$28,308, respectively. At December 31, 2024 and 2023, the interest rates on notes receivable from participants ranged from 4.16% to 9.50%.

NOTE 4. FAIR VALUE MEASUREMENTS

Generally accepted accounting principles require the Plan to report its investments at fair value on a recurring basis. Fair value is measured by a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follow:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A description of the valuation methodologies used for assets measured at fair value is included in Note 2. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The methodologies may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The investments in the common collective trusts are investments in a direct filing entities. There are no unfunded commitments or redemption restrictions related to these investments and participants may redeem units in the fund daily.

NOTE 5. EXCESS CONTRIBUTIONS PAYABLE

The Plan failed the discrimination test for the years ended December 31, 2024 and 2023, resulting in excess contributions amounting to \$226,354 and \$191,642, respectively, which are recorded as a liabilities in the accompanying statements of net assets available for benefits. The excess contributions made during 2024 and 2023 were reimbursed to participants during 2025 and 2024, respectively.

NOTE 6. INCOME TAX STATUS

The Plan obtained its latest determination letter on July 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

The Plan assesses its tax positions in accordance with “Accounting for Uncertainties in Income Taxes” as prescribed by the Accounting Standards Codification, which provides guidance for financial statement recognition and measurement of uncertain tax positions taken or expected to be taken in a tax return for open tax years (generally a period of three years from the later of each return’s due date or the date filed) that remain subject to examination by the Plan’s major tax jurisdictions.

The Plan assesses its tax positions and determines whether it has any material unrecognized liabilities for uncertain tax positions. The Plan records these liabilities to the extent it deems them more likely than not to be incurred. Interest and penalties related to uncertain tax positions, if any, would be classified as a component of income tax expense.

The Plan believes that it does not have any significant uncertain tax positions requiring recognition or measurement in the accompanying financial statements.

After year end, the Plan was amended to exclude highly compensated employees and modify the definition of compensation, as defined by the Plan. Additionally, the Plan was amended to allow for Employer prevailing wage contributions and Employer discretionary nonelective contributions.

The Company has evaluated subsequent events through September 23, 2025, which is the date the accompanying financial statements were available to be issued.
