Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Dairy Farmers of America, Inc. Super Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental Schedule of Assets is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following description of the Dairy Farmers of America, Inc. Super Savings Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document and *Summary Plan Description* for a more complete description of the Plan’s provisions, which are available from the plan administrator.

General – The Plan is a defined contribution plan sponsored by Dairy Farmers of America, Inc. (“DFA” or “Employer”). The Plan is subject to the provisions of the Employment Retirement Income Security Act of 1974 (“ERISA”). Fidelity Management Trust Company serves as the Plan’s Trustee, and Fidelity Retirement Services serves as the participant recordkeeper.

Plan Amendments – Employees hired or rehired on or after May 1, 2023, are no longer eligible to receive employer non-matching contributions. Effective January 1, 2023, seasonal and temporary employees shall not be subject to automatic contribution provisions. Effective January 1, 2024, the threshold for account balances of terminated employees subject to automatic distribution increased to \$7,000. Effective January 1, 2023, the required age was increased to 73 for beginning Required Minimum Distributions.

Plan Mergers – Effective January 1, 2025, there are 3 benefit Plans related to companies acquired by the Plan Sponsor that will merge into this Plan. The merging Plans hold some investments that are the same funds already held by the Plan. These funds, totaling \$2,650,918, were transferred into this Plan “in-kind” on December 31, 2024.

Transfers To and From Affiliated Plan – During the year ended December 31, 2024, assets of \$424,071 were transferred to the DFA Dairy Brands Smartchoice Super Savings Plan. During the year ended December 31, 2024, assets of \$658,125 were transferred into the Plan from the DFA Dairy Brands Smartchoice Super Savings Plan. Such transfers occur when certain employees change employment classification between affiliated DFA entities.

Eligibility – Employees become a participant in the Plan for the purpose of making elective deferrals, receiving employer fixed matching contributions and employer discretionary matching contributions, immediately upon employment. Employees that are classified as a seasonal or temporary employee will become a participant in the Plan on the next entry date after completing a year of service. Employees become eligible for receiving the employer discretionary service-based contributions on the next entry date following one year of employment. Participants enter the Plan on the first day of each payroll period.

Contributions – Employees are automatically enrolled in the Plan at a deferral rate of 6% of compensation, unless the participant elects a different percentage or opts out in writing. Participants may elect to defer up to a maximum of 50% of their compensation, subject to certain Internal Revenue Code (“IRC”) provisions. The employer makes a matching contribution equal to 50% of the participant’s contributions (not to exceed 6% of a participant’s compensation).

The employer may also make a discretionary matching contribution to be allocated to eligible participants. Discretionary contributions of \$5,006,891, net of forfeitures used, are included in the 2024 employer’s contributions receivable. Additionally, the employer makes a service-based contribution for eligible participants ranging from 2% to 10% of a participant’s compensation, depending on years of service. Service-based contributions of \$9,509,888, net of forfeitures used, are included in the 2024 employer’s contributions receivable.

Participant Accounts – Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) Plan earnings or losses. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options – Participants direct their investments into a variety of mutual funds, common investment trusts, and a guaranteed investment contract offered by the Plan. The Plan also allows individually directed brokerage accounts as an investment option. Participants may change the allocation of their investments daily. The Plan entered into a Master Trust Agreement effective October 18, 2020 (see Note 3).

Vesting – Participants' contributions are fully vested at all times. Employer matching contributions vest in 20% increments, with 20% vested after one year and 100% vested after 5 years of service. The employer service-based contributions become 100% vested after 3 years of service. In the event of death, reaching normal retirement age, permanent disability or termination of the Plan, the Company contributions will become fully vested. A year of service for vesting means each consecutive twelve month period beginning on the employee's hire date.

Forfeitures – Forfeited balances of terminated participants' nonvested accounts are used to reduce future employer contributions. In 2024, forfeitures of \$3,364,000 were used to reduce employer contributions receivable. As of December 31, 2024 and 2023, there was \$3,130,569 and \$1,578,752, respectively, of forfeited accounts available to reduce future employer contributions.

Payment of Benefits – Upon termination of employment, the participant, or in the case of death, the participant's beneficiary receives the participant's account balance in a single lump-sum. In the event of termination by a participant, account balances under \$7,000 will be subject to automatic distribution. Vested balances between \$1,000 and \$7,000 will be automatically rolled over to an IRA account in the participant's name, unless otherwise instructed by the participant.

Notes Receivable from Participant's – Participants may borrow a minimum of \$1,000 up to the maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan payments are made through payroll deductions and must be repaid to the participant's account within five years, unless the loan is for a home purchase, which may be repaid over 15 years. The loans are secured by the balance in the participant's account and bear interest 1% plus the prime rate. A participant is charged \$35 for the initial loan set-up, and an annual loan maintenance fee of \$15.

In-Service Withdrawals – Participants may make withdrawals prior to termination of employment. Hardship withdrawals are available to Plan participants for purposes as defined by the Plan and permitted by the IRC. Hardship withdrawals are limited to the participant's own contributions to the Plan.

Participants who have obtained the age of 59 ½ are allowed to receive a distribution of all or any portion of the vested account balance in a single lump sum payment.

Administrative Expenses – Administrative expenses are paid by the Plan or the Company, as defined in the Plan. During 2024, the Plan paid administrative expenses of \$429,107 for recordkeeping, custodial and audit services.

Revenue Credit Program – The Plan participates in the Fidelity Revenue Credit Program in which it receives quarterly credit through revenue sharing generated by the Plan's mutual fund investments that totaled \$1,224,075 during the year. The Plan established a Revenue Credit Account that is funded quarterly, in arrears by the Trustee. The funds may be used to pay Plan expenses or can be allocated to participants. In 2024, \$1,097,520 has been reallocated to participants. There were no funds used to pay administrative expenses. The balance of the revenue credit account is \$301,398 and \$159,987, as of December 31, 2024 and 2023, respectively.

Termination of the Plan – Although the Company has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the Plan and under ERISA. In the event that the Plan is terminated, participants' accounts would become fully vested at that time.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – The Plan's investments, including the Plan's interest in the Master Trust, are stated at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Management fees and operating expenses charged to the Plan for investments in mutual funds and the common collective trusts are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance is considered necessary.

Contributions – Contributions are recorded in the year that services are rendered.

Payment of Benefits – Benefit payments are reported in the year of payment.

Date of Management's Review – Subsequent events have been evaluated through September 15, 2025, which is the date the financial statements were available to be issued.

3. INVESTMENT IN MASTER TRUST

Effective October 18, 2020, the Plan has entered into a Master Trust Agreement and a Master Trust was formed to hold the assets of this Plan, and the assets of the DFA Dairy Brands Smartchoice Savings Plan. The investment assets of the Master Trust are held in a trust account at Fidelity Management Trust Company. Use of the Master Trust permits the commingling of the assets of the Plans for investment and administrative purposes. Although assets are commingled in the Master Trust, supporting records are maintained for the purpose of allocating the net earnings of the investment accounts to the participating Plans, and to the individual participants' accounts, based on their individual investment selections and balances.

4. FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

The assets fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for Master Trust assets measured at fair value. There have been no changes used in the methodologies used at December 31, 2024 and 2023:

Mutual funds and money market accounts – Valued at the net asset value (NAV) of shares held by the plan at year end based on published quoted prices.

Common collective trust (“CCT”) – Valued at the net asset value (NAV) of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held in the fund less its liabilities. This investment is valued daily, may be redeemed daily without restrictions, and with no notice requirements. Additionally, there are no unfunded commitments.

U.S. Treasury Bills – Valued at the closing price reported on the active market on which the individual securities are traded. If no active market is available, they are valued by Interactive Data Corporation based on quoted prices for similar assets or liabilities in an active market.

Certificates of Deposit – Valued at cost plus accrued interest, which approximates fair value.

Common and Preferred Stocks, and Exchange Traded Funds – Valued at the closing price reported on the national exchange on which the securities are traded. These are held in the individually directed brokerage accounts.

Individually directed brokerage accounts – Investments include mutual funds, exchange traded funds, money market accounts, common stock, preferred stock, and certificates of deposit all of which are valued as described above.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan may also hold other assets and liabilities not measured at fair value on a recurring basis, including employer and employee contributions receivable, cash, accrued income, accrued liabilities and payables, and unsettled trades. The fair value of these assets and liabilities approximates their carrying amounts in the accompanying financial statements due to the short maturity of the instruments.

5. RISKS AND UNCERTAINTIES

The Plan's investment in the Master Trust holds investment securities including U.S. Government securities, corporate debt instruments, and corporate stocks. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

6. INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the Trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments as of December 31, 2024 and 2023, and for the year ended December 31, 2024:

- Investment in Master Trust, at fair value
- Gain on interest in Master Trust
- Notes receivable from participants and related interest income
- Schedule of Assets (Held at End of Year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

7. INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan provides a Guaranteed Investment Contract, a group annuity contract issued by Empower Annuity Insurance Company of America, as an investment option for certain participants that joined the plan through a Plan merger. This investment option is considered fully benefit-responsive. The objective of this investment option is to guarantee the return of principal plus compound interest earned over a defined term backed by Empower. There are no specific securities in the general account that back the liabilities of this group annuity contract. The contract is included in the financial statements at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Empower is obligated to pay interest at crediting rates, which are announced in advance and guaranteed per the terms of the contract. The current rate is 0.86%. The contract is expected to expire in September 2025, and any funds invested in this fund will be transferred to the Vanguard money market fund. There are no reserves against contract value for the credit risk of the contract issuer or otherwise.

8. TAX STATUS

The Plan obtained its latest determination letter from the IRS on October 4, 2022, which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the determination letter. However, the Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan qualifies under Section 401(a) and the related trust is tax-exempt as of December 31, 2024. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally accepted accounting principles requires Plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments held in the Master Trust consist of mutual funds and a common collective trust managed by Fidelity. Fidelity is the trustee of the Plan and, therefore, these transactions qualify as party-in-interest. The Plan pays certain fees to Fidelity to administer the Plan and pays professional service fees for the annual audit. These transactions qualify as party-in-interest. Notes receivable from participants are party-in-interest transactions.
