### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of the **Aalto Scientific, Ltd. 401(k) Plan**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### NOTES TO FINANCIAL STATEMENTS

#### **(1) Description of Plan**

The following description of the Aalto Scientific, Ltd. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### ***General***

The Plan is a defined contribution plan covering all eligible employees of Aalto Scientific, Ltd. (the Company). Employees are eligible to enter the plan after attaining age 21 and can join on the first day of the quarter. The Company adopted the Plan effective January 1, 2018. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The board of directors are responsible for oversight of the Plan. The administrative committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the board of directors.

##### ***Contributions***

Under the provisions of the Plan, each participant may contribute a portion of qualified compensation for the Plan year. Participant contributions may be traditional 401(k) deferrals (pre-tax) or Roth 401(k) deferrals (after-tax). The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at three percent of eligible compensation and their contributions treated as a traditional deferral. The automatic enrollment will increase by one percent each new Plan year up to a maximum of 10 percent. Under the employer contributions provision of the Plan, the Company may also contribute matching contributions as well as a profit-sharing contributions. To be eligible for the employer contributions, a participant must be employed on the last day of the Plan year. There were no employer contributions during the year ended December 31, 2024. Participants may also rollover amounts representing distributions from other qualified retirement plans (rollover). Contributions are subject to certain Internal Revenue Service (IRS) limitations.

##### ***Participant Accounts***

Individual accounts are maintained for each participant. Each participant's account is credited with the participant's contributions, the Company's contributions, and qualified rollover contributions, and adjusted for gains and losses based on the investment performance of a participant's account, less any withdrawals, distributions and allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The participant is entitled to a benefit equal to the participant's vested account balance.

## **(1) Description of Plan (Continued)**

### ***Vesting***

Participants are immediately vested in participant contributions plus earnings thereon. All employer matching and profit-sharing contributions are fully vested upon completion of three years of vesting service.

### ***Notes Receivable from Participants***

The Plan does not allow for loans.

### ***Payment of Benefits***

Upon termination of service due to death, disability, retirement, or other reason, a participant may elect to receive a lump-sum payment equal to the value of the participant's vested interest in their account or periodic installments over a period of years not exceeding the normal life expectancy of the participant or, if applicable, their beneficiary. A participant who is still employed by the Company and has attained age 59½ may make an election to withdraw all or a portion of his or her entire account balance.

### ***Hardship Withdrawals***

In the event funds are needed because of extreme financial hardship, as defined by law, the participant may be allowed to make a withdrawal of their vested account balance from eligible accounts, as defined by the Plan. In accordance with the Internal Revenue Code (the Code), benefits withdrawn prior to age 59½ may be subject to additional taxes.

### ***Forfeited Accounts***

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits from the employer contributions under the Plan. There were no forfeited nonvested amounts as of December 31, 2024 and 2023. The forfeited amounts are to be used to pay administrative expenses or to reduce the employer's contribution, as applicable. There were no forfeitures used to reduce employer contributions or pay administrative expenses in 2024.

### ***Investment Options and Investments***

Participants direct the investment of all contributions into various investment options offered by the Plan. Participants may change their investment options at any time.

## **(2) Summary of Significant Accounting Policies**

The accounting policies of the Plan are maintained in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the *Accounting Standards Codification (ASC)* and related Accounting Standards Updates (ASUs). The following describes the more significant of those policies:

### ***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of Plan assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrative committee determines the Plan's valuation policies utilizing information provided by the investment advisors, trustee, and recordkeeper. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income (loss) is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Contributions***

Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

### ***Payment of Benefits***

Benefits are recorded when paid.

### ***Excess Contributions Payable***

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions, when applicable. The Plan distributes excess contributions to the applicable participants prior to March 15 of the subsequent year.

### ***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Other expenses, such as fees related to participant's benefit payments, are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

### **(3) Information Prepared and Certified by the Trustee (Unaudited)**

Certain information in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and cash held as of December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus, LLC (Ascensus), a qualified institution.

### **(4) Fair Value Measurements**

The FASB issued a statement that defines fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- **Mutual Funds:** Valued at the daily closing price as reported by the funds. The funds held by the Plan are open-end funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.
- **Common Collective Trust:** Fair value is based on the daily closing price of the actively-traded underlying investments and quoted to investors based on the NAV of the units of the collective investment fund. The NAV is the basis for current transactions and the investment can be redeemed at NAV as of the measurement date. Therefore, investments have a readily determinable value.

#### (4) Fair Value Measurements (Continued)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### (5) Income Tax Status

The Company adopted the Ascensus (the prototype sponsor) Defined Contribution Prototype Plan. The prototype sponsor has received a favorable opinion letter, dated March 31, 2014, from the Internal Revenue Service (IRS) which states that its prototype plan, in form, meets the requirements of Section 401(a) of the Code and, therefore, is tax-exempt under the provisions of Section 401(a). The plan document has been amended since receiving the determination letter and the Plan has not received a determination letter specific to the Plan itself; however, the Company and the Company's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, accordingly, no provision has been made for income taxes in the accompanying financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **(6) Related-Party and Party-in-Interest Transactions**

Certain Plan assets are investment options offered through Ascensus, its affiliates, or recordkeeper; therefore, these transactions qualify as party-in-interest transactions. Administrative expenses on the statement of changes in net assets available for benefits include amounts paid by the Plan to Ascensus, the bookkeeper, and investment advisors for administrative services.

Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempted from the prohibition of party-in-interest transactions under ERISA.

## **(7) Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

## **(8) Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate risk, market volatility, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

## **(9) Prohibited Transactions**

During the 2024 Plan year, the Plan sponsor failed to deposit participant deferrals of \$3,647 within the required time frame as stated by the United States Department of Labor (DOL). The DOL considers late deposits to be prohibited transactions. The Plan sponsor is in the process of correcting the delinquent participant contributions.

## **(10) Subsequent Events**

Management has evaluated events subsequent to December 31, 2024 through September 16, 2025, the date these financial statements were available to be issued.
