### **1. Description of the Plan**

The following description of the Stoli Group USA, LLC 401(k) Plan (the “Plan”) is provided for general information purposes only. More complete information regarding the Plan’s provisions may be found in the Plan document.

#### ***General***

The Plan is a defined contribution plan covering all employees of Stoli Group USA, LLC (the “Employer”), except residents of Puerto Rico (“Participants”). There is no age requirement for the Plan and employees may enter the Plan on the first day of each month following 30 days of service. Principal Trust Company serves as the trustee for the Plan and holds certain assets of the Plan and Principal Life Insurance Company provides recordkeeping services and holds the remaining assets of the Plan (collectively “Principal”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). All investments are Participant directed.

#### ***Participant Deferral Contributions***

Participant deferral contributions to the Plan are deferrals of the employee’s compensation. Each year, Participants may elect to defer up to 100% of eligible compensation, as defined by the Plan, not to exceed a dollar limit established under the Internal Revenue Code (the “IRC”). Participants may make pre-tax and Roth contributions to their accounts. Participants who have reached the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may contribute amounts representing distributions from other qualified plans (“Participant Rollovers”).

The Plan includes an automatic enrollment feature whereby all newly eligible employees will be automatically enrolled to defer 6% of eligible compensation on a pre-tax basis, as defined. Automatic escalations will increase the contributions by 1% per year until they reach 10%. Automatic enrollment deferrals are invested in the applicable target date retirement fund, as defined, based upon the employee’s birth date. A Participant may choose not to defer or may chose a different percentage once enrolled. The automatic pre-tax deferral election and the default investment option remains in effect until it is changed by the Participant.

#### ***Employer Matching Contributions***

The Employer makes a discretionary matching contribution of 25% of each Participant’s contribution that does not exceed 6% of eligible annual compensation. The matching contribution is calculated each pay period and is 100% vested after one year of employment. The discretionary matching contribution made for the year ended December 31, 2024 totaled \$105,337.

### 1. Description of the Plan (continued)

#### ***Participant Accounts***

Each Participant's account is credited with the Participant's deferral contributions, the respective Employer contributions, an allocation of the Plan's investment earnings or losses, and is charged with benefits paid and an allocation of certain administrative expenses, if applicable. Allocations are based on Participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the Participant's vested account.

#### ***Vesting***

Participants are immediately vested in all employee contributions, rollover and the earnings thereon. Employer contributions vest 100% after one full year of service.

#### ***Forfeitures***

Participants who terminate employment but have not become fully vested in Company contributions forfeit their unvested balances. In accordance with the Plan, the amount of forfeitures will be applied to reduce Company contributions or pay Plan expenses. Forfeitures as of December 31, 2024 and 2023 were \$17,269 and \$3,982, respectively. During the year ended December 31, 2024, \$16,364 was forfeited, and the Plan realized a gain of \$878 on forfeitures. Further, the Plan applied forfeitures in the amount of \$3,955, of which \$3,764 were offset against employer matching contributions and \$191 against administrative expenses for 2024.

#### ***Notes Receivable from Participants***

Participants may borrow from their vested accounts a minimum of \$1,000 and up to a maximum amount equal to the lesser of \$50,000 reduced by the highest outstanding loan balance during the one-year period ending on the day before the loan is made or 50% of their vested account balance. Loan terms range from one to five years; however, terms may be longer for the purchase of a primary residence. Loans are secured by the vested balance in the Participant's account and bear interest at a rate commensurate with local prevailing rates. A Participant may only have one loan outstanding at a time. Notes receivable from Participants, with interest rates ranging from 5.50% to 10.50% at December 31, 2024 and 5.25% to 10.50% at December 31, 2023, mature at various dates through 2029. Principal and interest are paid ratably through payroll deductions or by check if the employee has terminated employment. If a Participant ceases to make loan repayments and the Plan administrator deems the loan to be in default, the Participant's loan balance is reduced, and a benefit payment is made in accordance with the Plan document.

### **1. Description of the Plan (continued)**

#### ***Payment of Benefits***

A participant's vested interest in Plan assets is distributable generally upon termination, disability, retirement, or death. Active participants may receive distributions from the vested amounts in their accounts at any time after attaining the age of 59½ or due to hardships, as defined in the Plan. Participants may elect to receive their account balance as a single lump-sum payment (which payment would generally be eligible to be rolled-over to an individual retirement account of the participant's choosing), as a direct transfer to an individual retirement account established by the custodian of the Plan, or as a partial payment.

#### ***Plan Administration***

The Employer is the Plan administrator and has the authority to appoint person(s) or entities to carry out the operation of the Plan. Individual participant accounts are charged directly for loan recordkeeping and benefit disbursement processing fees, if applicable. Individual Participant accounts may also be charged with an allocation of administrative expenses, if not paid by the Employer.

#### ***Subsequent Events***

Management has evaluated subsequent events for disclosures and/or recognition in the financial statements through the date that the financial statements were available to be issued, which is September 25, 2025.

### **2. Summary of Significant Accounting Policies**

#### ***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

#### ***Investments, Investment Valuation and Income Recognition***

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. See Note 5 for discussion of the investment contract. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

#### ***Investments, Investment Valuation and Income Recognition (continued)***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liability or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments were fair value is measured using the net asset value (“NAV”) per share as a practical expedient is not categorized within the fair value hierarchy.

*Common collective trust funds:* Valued at the NAV of units in the collective trust. The NAV, as provided by Principal, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. The common collective trust funds have no unfunded commitments as of December 31, 2024 and 2023. Each of these common collective trust funds files a Form 5500 as a direct filing entity. As such, significant investment strategies have not been disclosed for these investments.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are categorized at Level 1 in the fair value hierarchy.

*Pooled Separate Accounts* – Valued at the NAV of the units of the separate account. The NAV, as provided by Principal, is used as a practical expedient to determine fair value for these accounts. The NAV is based on the fair value of the underlying investments held by the account less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. These units are not traded on a securities exchange but are redeemable only by the issuer. The rate of return varies based upon each fund’s experience. These accounts do not distribute dividends or interest to the Plan, rather investment performance is reflected in the change in unit value. Participant transactions (purchases and sales) may occur daily. These pooled separate accounts have no unfunded commitments as of December 31, 2024 and 2023.

Purchases and sales are recorded on the trade-date basis. Net appreciation in fair value of investments includes the Plan’s gains and losses on investments bought and sold, as well as held during the year. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

#### ***Unit Values***

Individual participant accounts for the pooled separate accounts and common collective trust funds are maintained on a unit value basis. Participants do not have beneficial ownership in the specific underlying securities or other assets in the funds, but do have an interest therein represented by units which are valued daily. The funds earn dividends and interest which are automatically reinvested in additional units. Generally, contributions to and withdrawals from each fund are converted to units by dividing the amounts of such transactions by the unit values as last determined, and the participants' accounts are charged or credited with the number of units properly attributable to each participant.

#### ***Notes Receivable from Participants***

Loans to Participants are reported as notes receivable from Participants at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from Participants is recognized on the accrual basis of accounting. Related fees are recorded as administrative expenses when incurred.

#### ***Payments of Benefits***

Benefit payments to Participants are recorded in the period in which the participants are paid.

#### ***Administrative Expenses***

The Plan's expenses are paid either by the Plan or the Company as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in the operation and administration of the Plan, are paid by the Plan and are recorded as deductions in the accompanying statement of changes in net assets available for benefits.

#### ***Use of Estimates***

The preparation of financial statements in accordance with U.S. GAAP requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

### **3. Information Certified (Unaudited)**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4(i) – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal.

### 4. Risk and Uncertainties

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect Participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

### 5. Guaranteed Investment Contract

The Plan invests in a fully benefit-responsive guaranteed income fund offered by Principal, which is backed by the full faith and creditworthiness of Principal. The contract met the fully-benefit responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Participants may ordinarily direct the transfer of withdrawal of all or a portion of their investment at contract value. The fund is valued at contract value, which represents contributions made under the contract, plus earnings at guaranteed credit rates, less participant withdrawals and administrative expenses. The guaranteed investment contract is contractually obligated to repay principal and a specified interest rate to the Plan.

Certain events may limit the ability of the Plan to transact at contract value with the Insurance Company. Such events include the following: (i) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (ii) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause significant withdrawal from the Plan, (iii) liquidity constraints at the Insurance Company or (iv) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that there are any events that are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

### 6. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become one-hundred (100%) vested in their accounts. Any unallocated assets of the Plan shall be allocated to Participant accounts and distributed in such a manner as the Employer may determine.

Plan investments include funds that are managed by Principal. Principal is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Administrative expenses of \$45,101 were paid to Principal during the year ended December 31, 2024. Notes receivable from Participants also qualify as exempt party-in-interest transactions as defined by ERISA.

### **8. Tax Status**

The underlying volume submitter profit sharing plan with CODA (cash or deferred arrangement) has received an opinion letter from the Internal Revenue Service, dated June 30, 2020, stating that the form of the Plan is qualified under Section 401(a) of the IRC and that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that the Plan is qualified as of the date of these financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. It is the Plan's policy to account for any uncertainties as described under the income tax laws. Under the income tax laws, the tax-exempt status of an entity is considered a tax position. No such uncertain tax positions have been recognized by the Plan as of December 31, 2024 or 2023.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
