### INDEPENDENT AUDITOR'S REPORT

#### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Valley Tire Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the Valley Tire Retirement Plan (the "Plan") is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of plan provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

General

The Plan is a defined contribution plan with an effective date of October 1, 1993, covering substantially all employees of Valley Tire Company, Inc. (the "Company") who have attained age 21 and have completed one year of service, as defined by the Plan. The Plan excludes certain nonresident aliens and union employees whose employment is governed by a collective bargaining agreement under which retirement benefits were the subject of good faith bargaining.

Contributions - 401(k)

Plan participants may elect to contribute (elective deferrals) up to the maximum percentage allowable not to exceed the limits of Internal Revenue Code Sections 401(k), 402(g), 404 and 415 of their pretax annual compensation as defined in the Plan agreement, which is \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. Participants may also contribute amounts representing distributions from other qualified plans (rollovers).

The Company matches 50% of each participant's contribution of up to 4% of pre-tax annual compensation each payroll period. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 2% of eligible compensation.

Contributions are automatically invested in certain designated funds based on the participants normal retirement age until changed by the participant. Participants direct the investment of their contributions and Company contributions into various pooled separate account investment options offered by the Plan. The Company may also make additional discretionary matching contributions equal to a percentage of each participant's contribution, however, participant contributions for each payroll period that exceed 4% of compensation for such period are not considered. The Company may also make discretionary profit sharing contributions. Employer contributions of \$151,604 were made by the Company for the year ended December 31, 2024.

Funding Policy

The Company shall, within the time period and manner permitted by the Internal Revenue Code, remit to the trustee an amount equal to the sum of the elective deferral contributions and the Company matching contributions.

Participant Accounts

Each participant's account is credited with the participant's contribution, Company contributions and the earnings on the investments. Each participant has the right to direct his or her own investments, and earnings on each participant's investments are credited to his or her respective account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment of Contributions

The participant, with the consent of the trustee, shall direct the investment of all elective deferral, matching and employee rollover contributions made on the participant's behalf. Empower Trust Company, LLC (the "Custodian") offers various investment options under the contract. The participant may allocate the participant's contribution in any proportion the participant chooses among these options. The participant may also direct the transfer of any portion of the participant's account balance between these investment options.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by the excess, if any, of the participant's highest outstanding balance of loans from the Plan during the one year period ending on the day before the date of the new loan over the current outstanding balance of loans as of the date of the new loan or 50% of their account balance, whichever was less. The loans were secured by the balance in the participant's account and interest was charged at a rate that was fixed by the Plan administrator of prime plus 1%, as of the date of the loan. In determining the interest rate, the Plan administrator took into consideration interest rates that were being charged on similar commercial loans by persons in the business of lending money. Generally, notes cannot exceed a term of five years. However, if the loan is for the purchase of the participant's principal residence, a longer term may be permitted. A participant may only have one outstanding loan at a time. Principal and interest is paid ratably through weekly and bi-weekly payroll deductions.

Payment of Benefits

Upon termination of service, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested account balance or annual installments. Participants may elect to roll over all or part of their vested account balance into a different qualified retirement account upon separation from the Plan. Hardship distributions may also be granted in accordance with the provisions of the Plan agreement.

Vesting

Participants are immediately vested in their contributions (elective deferrals and rollovers) plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portions of their accounts plus actual earnings thereon is based on years of continuous service according to the following schedule:

Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their investment election for future contributions or the percentages invested in each of these options, or transfer funds among these options on any business day.

Forfeitures

Any participant who terminates employment forfeits his or her non-vested amounts in discretionary employer contributions. Forfeitures may be used by the Plan for several purposes, including (1) to pay any administrative expenses; and (2) to reduce any matching or non-elective contributions. The Plan had \$199 and \$197 forfeitures available as of December 31, 2024 and 2023, respectively. For the year ended December 31, 2024, employer contributions were reduced by \$1,634 from forfeitures.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

This summary of significant accounting policies of the Plan is presented to assist in understanding the financial statements. The financial statements and notes are representations of the Plan's administrator, who is responsible for their integrity and objectivity. The accounting policies conform to accounting principles generally accepted in the United States and have been consistently applied in the preparation of the financial statements.

Basis of Accounting

The Plan management's policy is to prepare the Plan's financial statements on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are recorded as distributions based upon the terms of the Plan document.

Excess Contributions Payable

Amounts payable to certain participants totaling \$24,557 and \$22,657 as of December 31, 2024 and 2023, respectively, for contributions in excess of amounts allowed under the Internal Revenue Code, are recorded as accounts payable, with a corresponding reduction in employee contributions for those respective years. The Plan distributes the balance prior to March 15 of the subsequent year that they were originally deferred.

Payment of Benefits

Benefits are recorded as expenses when paid through the Benefit Payments and Deemed Distributions accounts. Distributions to participants during 2024 were in the amount of \$254,034.

Administrative Expenses

Certain administrative expenses are paid for by the Company, while others are paid for by the Plan.

Subsequent Events

Management has evaluated subsequent events through September 22, 2025, which was the date the financial statements were available to be issued.

**NOTE 3 – FAIR VALUE MEASUREMENT**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

*Mutual Funds* - valued based on the funds' reported closing NAV as of the last business day of the Plan year. The mutual funds are deemed to be actively traded.

*Fixed Annuities* - values reported are based on the valuation method disclosed in the annuity contract, as calculated by the annuity provider.

*Collective Trust Funds* - valued based on the funds NAV reported by the investment provider.

*Notes Receivable from Participants* - valued at amortized cost, which approximates fair value.

The Plan has evaluated the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the years ended December 31, 2024 and 2023, there were no such transfers.

**NOTE 4 – GUARANTEED INVESTMENT CONTRACT**

The Plan entered into a fully benefit-responsive guaranteed investment contract with Empower Trust Company, LLC (Empower). Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The guaranteed investment contract meets the fully benefit-responsive investment contract criteria, and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are probable of not occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants. In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value.

**NOTE 5 – PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are managed by Empower Trust Company, LLC. Empower Trust Company, LLC is the custodian as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. Case Sabatini & Company is the Plan auditor and qualifies as a party in interest.

**NOTE 6 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 7 – TAX STATUS**

The Plan has adopted the Prototype Defined Contribution Plan Sponsored by Walker Benefits, LLC Basic Plan Document #3. In its letter to Walker Benefits, LLC dated January 27, 2015, the Internal Revenue Service (IRS) has expressed its opinion that the form of the prototype plan is acceptable under Section 401 of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt. Effective January 1, 2022, the Plan was restated to conform to the CARES act.

**NOTE 8 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9 – INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN**

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-5 of the Department of Labor Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 for 2024 and 2023. Accordingly, Empower Trust Company, LLC, the custodian of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023 and the supplemental Schedule H, Line 4(i) – Schedule of Assets Held for Investment Purposes at December 31, 2024, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
