Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Weirton Geriatric Center Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Weirton Geriatric Center Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

NOTE 1 - PLAN DESCRIPTION

The following description of the Weirton Geriatric Center Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan, as established on January 1, 1989, is a profit sharing 401(k) plan which is available to all eligible employees of Weirton Geriatric Center (the "Company") and Serra Retirement Center (commonly owned companies). Eligible employees may become participants upon completion of 1,000 hours of service during a twelve consecutive month period and attaining age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Two individuals serve as discretionary trustees of the Plan. The Trustees determine the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

Each participant may elect to have compensation deferred by up to the annual maximum amount allowable by the Plan. Effective January 1, 2024, the Plan was amended and restated to permit Roth contributions, allowing participants to designate all or a portion of their elective deferrals as Roth after-tax contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The employer may also contribute an additional discretionary amount (3% of eligible wages for 2024 and 2023 plan years) which shall be allocated to each participant account in proportion to his or her eligible compensation for the plan year. The participant will only share in employer discretionary contributions if credited with at least 1,000 hours of service during the Plan year. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, rollover contributions (if any), Company discretionary contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their voluntary salary deferral contributions, rollover contributions, plus actual earnings thereon. Participants vest in accordance with the Plan in their respective employer contributed accounts. The Plan provides gradual vesting for a participant with full vesting after 6 years of service or the earlier of attaining normal retirement age, early retirement age, death, or disability.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at one percent above the prime rate, as defined. Principal and interest are paid ratably through bi-weekly payroll deductions.

Payment of Benefits

Upon termination of service, all distributions from the Plan can be made in one lump-sum cash payment or substantially equal installments. For mandatory distributions such as involuntary cash-outs, if a participant's vested benefit in the Plan exceeds \$5,000, the participant must consent to the distribution before it is made. For mandatory distributions in which a participant's vested account is greater than \$0 but less than \$5,000, consent is not required for the distribution. If a participant's vested account is greater than \$0 but less than \$5,000, a participant may receive this distribution in cash, roll the distribution to an individual retirement account (IRA) or to the qualified plan of the participant's new employer. Hardship distributions are not permitted by the Plan. In service distributions may be made to the participant who has not separated from service provided the participant has reached normal retirement age.

Forfeiture

A forfeiture results from the non-vested portion of the employer discretionary account of a terminating participant. The Plan requires that a forfeiture will occur as of the earlier of (a) the last day of the plan year in which the former participant incurs five (5) consecutive 1-year breaks in service or (b) the distribution of the entire vested portion of the participant's account balance.

The forfeiture balance was \$9,475 and \$5,145 as of December 31, 2024 and 2023, respectively. Forfeitures of employer discretionary contributions can be used to reduce future employer contributions or pay administration expenses. During 2024, forfeitures of \$4,923 were used to pay the third-party administrator fees.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract which is reported at contract value.) Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by the investment advisor, custodian, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date-basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants are recorded in the year in which the participant contributions are withheld from compensation. Employer discretionary contributions are funded subsequent to year end.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 2, 2025, the date the financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Valued at the net asset value ("NAV") of participation units held by the Plan at year end. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

NOTE 4 - RELATED PARTY AND PARTIES-IN-INTEREST TRANSACTIONS

Certain Plan investments as of December 31, 2024 and 2023 consist of pooled separate accounts and a guaranteed investment contract managed by Ameritas Life Insurance Corp. Ameritas Life Insurance Corp. is the third-party administrator of the Plan and accounts for the activity of all investments held by the Plan. The two individuals who serve as discretionary trustees are also Plan participants. Therefore, these transactions qualify as party-in-interest.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

NOTE 6 - TAX STATUS

The Company has adopted a Prototype Non-standardized Profit-Sharing Plan with CODA sponsored by Ameritas Life Insurance Corp. The prototype non-standardized profit-sharing plan has received an opinion letter from the IRS dated June 30, 2020, as to the prototype non-standardized profit-sharing plan's qualified status. The prototype non-standardized profit-sharing plan opinion letter has been relied upon by the Plan. Although the Plan has been amended since receiving the determination letter, the plan administrator and trustees believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and therefore, believe that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Company has taken a significant uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - CERTIFIED INVESTMENTS

Certain information in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest income, and interest income on notes receivable from participants for the year ended December 31, 2024 was obtained by management, and agreed to, or derived from information certified as complete and accurate by Ameritas Life Insurance Corp. (the custodian of the Plan). The contract value of the guaranteed investment contract was also certified by Ameritas Life Insurance Corp.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 - INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has a fully benefit-responsive investment contract with Ameritas Life Insurance Corp. (“Ameritas”) totaling \$2,396,395 and \$2,176,439 as of December 31, 2024 and 2023, respectively. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measurement for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. The Ameritas Guaranteed Investment Account earns a declared interest rate for new deposits in each calendar quarter. Subsequent to the initial guaranteed period, a renewal guarantee is applied for deposits made in the calendar quarter in all prior years. Subsequent annual renewal rates will continue in future years. Interest rate guarantees are backed by assets held by the Ameritas general account. Credited rates are set based on yields earned on new purchases of fixed income securities for the general account for new deposits each quarter. Subsequent renewal rates are based on the investment performance of the general account at the time of renewal. Credited rates are guaranteed for the duration of the guaranteed period, and do not vary with the subsequent performances of assets of the general account which back these guarantees.

The contract value of funds held in the Ameritas Guaranteed Investment Account generally represents principal plus accrued interest. The fair value of these funds reflects the relationship between credited rates earned by funds held in the Guaranteed Investment Account and current market rates. Higher credited rates will produce a higher fair value than lower credited rates under similar market interest rate environments.

Fair value for the Ameritas Guaranteed Investment Account is determined as the present value of future guaranteed account values and participant benefit withdrawals, assuming an annual benefit withdrawal rate of 9%. Benefit withdrawals are assumed to occur at the end of each calendar year.

Present values are derived by discounting future guaranteed account values and benefit withdrawals by the appropriate market interest rates. Market interest rates are deemed to be the same rates to be credited to new issues of the same contract with like guarantees issued as of the date of the fair value determination.

The average yield in the Plan is the percentage earnings credited in the Ameritas Guaranteed Investment Account for the plan year based on the end of the year fair value of Ameritas Guaranteed Investment Account assets. These earnings represent the entire investment return of the Ameritas Guaranteed Investment Account within this contract.

The weighted average interest crediting rate is the weighted average of all new and renewal rates of the contract for each calendar quarter. These rates are guaranteed for the entire duration of the guaranteed period and do not vary with the subsequent performance of assets of the Ameritas general account which back these guarantees.

NOTE 9 - INVESTMENT CONTRACT WITH INSURANCE COMPANY - CONTINUED

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events may limit the ability of the Plan sponsor and/or Plan participants to transact at contract value with Ameritas. Such events would include, but would not be limited to, premature termination of this contract and termination of the retirement plan. In such events, the contract value could be reduced by any applicable surrender charges upon distribution of the contract's funds. Under no event may Ameritas terminate this contract and settle at an amount different from contract value.
