Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of MPFC 403(b) Retirement Plan (the "Plan"), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements (2024 Financial Statements).

Note 1. Plan Description

General

The following description of the MPFC 403(b) Retirement Plan (the “Plan”), as amended, provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

The Plan, which was established on March 1, 2010, is classified as a defined-contribution plan, covering eligible employees of Max Planck Florida Corporation (the “Company”) who normally work more than 20 hours a week. The primary purpose of the Plan is to provide retirement savings benefits to employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Each year, participants may contribute up to 100% of their gross compensation as defined in the Plan. The Company makes a safe harbor matching contribution equal to 100% of participants’ elective contributions up to 3% of their annual compensation, plus 50% of the participants’ elective contributions in excess of 3%, but not greater than 5% of their compensation. In addition to the matching contributions, the Company may make a discretionary contribution for the benefit of all eligible participants. The discretionary contribution for the year ended December 31, 2024 was \$751,015. Contributions are subject to certain limitations.

Participant Investment Account Options

Participants direct the investment of their accounts into various investment options offered by the Plan. Investment account options available include a fully benefit-responsive investment contract and mutual funds.

Participant Accounts

Under the Plan, a separate account is maintained for each participant. Each participant’s account is credited with the participant’s contributions, employer contributions, and allocations of Plan earnings and is charged with an allocation of administrative expenses, if any. Participant contributions and employer contributions are allocated, at the participant’s election, to investment funds held at Lincoln Financial Group Trust Company, Inc. (the “Plan Custodian”). Participants may change their investment options at any time with certain exceptions. Plan earnings are allocated based on the actual earnings of the respective participant’s investments. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant’s account.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances by executing a note in accordance with the Plan’s provisions. The notes are collateralized by the balance in the participant’s account and bear interest at a rate equal to 4.25% to 9.50%. The loan interest rate, determined quarterly, is set at 1% above the prime rate, as defined. Participants may have one outstanding loan at any time, and the loan must be repaid within a period not to exceed five years from the date of the loan, unless the loan is for the purchase of the participant’s principal residence, in which case the loan must be payable within a reasonable time commensurate with the repayment period permitted by commercial lenders for similar loans. Principal and interest are repaid ratably through payroll deductions.

Vesting

Participants are immediately vested in their voluntary contributions and employer safe harbor contributions, plus actual earnings or losses thereon. Vesting in the employer discretionary contributions is 100% after completing three years of service, plus any earnings or losses thereon. There is no vesting in the employer discretionary contributions prior to participants completing three years of service.

Payment of Benefits

Upon the death, permanent disability, or retirement of participants, distribution of benefits may be made in the form of a lump-sum or installment payment. Participants who terminate for reasons other than death, disability, or retirement are entitled only to the vested value in their account. As of December 31, 2024 and 2023, there were no amounts allocated to the accounts of individuals who have elected to withdraw from the Plan but had not yet been paid.

Forfeitures

Non-vested employer contributions forfeited by participants are used by the Company to reduce future employer matching contributions or to pay reasonable plan expenses. As of December 31, 2024 and 2023, the forfeiture account had a balance of approximately \$0 and \$37,000, respectively. There were approximately \$66,000 of forfeitures used by the Plan during the year ended December 31, 2024.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments in mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan Custodian offers a fully benefit-responsive fixed annuity contract (the "Lincoln Stable Value Account") issued by The Lincoln National Life Insurance Company (the "Issuing Company"). The Lincoln Stable Value Account has a minimum guaranteed interest rate, which is 1.70% for all years. The investments in the Lincoln Stable Value Account are backed by the general account of the Issuing Company. Investments held in the Lincoln Stable Value Account are deemed to be fully benefit-responsive, and contract value is the relevant measurement attribute because that is the amount participants normally will receive if they were to initiate permitted transactions under the terms of the Plan. The Plan Custodian values the Lincoln Stable Value Account by crediting the declared rate of interest to the amounts allocated to the account. This value represents the amount Plan participants would receive if they were to withdraw or transfer funds within the Plan. The Plan's ability to receive amounts due in accordance with the fully benefit-responsive contract is dependent upon the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer.

Purchases and sales of funds are reflected on a trade-date basis. Interest income is recorded as earned on the accrual basis. Interest is automatically reinvested in additional fund units.

In accordance with the Plan's policy of stating marketable securities at fair value, the net appreciation for the year ended December 31, 2024 is reflected in the statement of changes in net assets available for benefits as net appreciation in fair value of investments.

Notes Receivable from Participants

Notes receivable from participants are recorded at their unpaid principal balance plus accrued but unpaid interest.

Contributions

Contributions to the Plan are recorded in the period in which they become obligations of the Company.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

The Plan's administrative expenses are shared by the Plan and the Company, as provided by the Plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles, and with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Subsequent Events

The Company has evaluated subsequent events for recognition and disclosure through October 1, 2025, which is the date the financial statements were available to be issued.

Note 3. Certification of Plan Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan Custodian, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate.

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Fair Value Measurements

The fair value of financial instruments is presented based upon a hierarchy of levels that prioritize the inputs of valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

- Level 1** Unadjusted quoted prices in active markets for identical assets or liabilities the Plan has the ability to access at the measurement date.
- Level 2** Inputs to the valuation methodology that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3** Significant, unobservable inputs used for valuing the asset or liability in which little or no market data exists.

A financial instrument's level, within the fair value hierarchy, is based on the lowest level of input that is significant to the fair value measurement in its entirety.

Note 5. Exempt Party-In-Interest Transactions

Certain plan investments are funds managed by the Plan Custodian as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid to the Plan Custodian were \$93,799 for the year ended December 31, 2024. The Company also absorbs significant costs related to various administrative and investment advisory services on behalf of the Plan.

Note 6. Risks and Uncertainties

The Plan's investments are not insured and are subject to risk. Financial information relating to those investments is included in these financial statements based on information provided by the Plan Custodian.

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 7. Income Tax Status

The Plan is intended to be a qualified trust under Section 401 of the Internal Revenue Code ("IRC") and is subject to the provisions of ERISA. The original Plan is a prototype plan prepared and maintained by the Plan's third-party administrator. The prototype plan obtained its latest determination letter on March 31, 2017, in which the Internal Revenue Service stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the adopted Plan has been amended since the latest determination letter date, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and tax exempt. Therefore, no provision for income taxes has been included in the Plan's accompanying financial statements.

Note 8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.
