### ***Opinion***

We have audited the financial statements of The Retirement Plan for Employees of the Oklahoma Publishing Company and Affiliated Corporations (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 (liquidation basis) and the related statements of changes in net assets available for benefits for the years then ended (liquidation basis) and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023 (liquidation basis) and the changes in its net assets available for benefits for the years then ended (liquidation basis), in accordance with accounting principles generally accepted in the United States of America (GAAP).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). As discussed in Note 3 to the financial statements, the Board of Directors of the Oklahoma Publishing Company and Affiliated Corporations, the Plan's sponsor, voted on October 18, 2022 to terminate the Plan and management determined liquidation is imminent. As a result, the liquidation basis of accounting is used in presenting the 2024 and 2023 financial statements. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that these financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. **Note 1. Description of the Plan**

The following description of The Retirement Plan for Employees of the Oklahoma Publishing Company and Affiliated Corporations (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

***General***

The Plan is a noncontributory defined benefit plan that covers all eligible employees of the Oklahoma Publishing Company and certain of its subsidiaries (Company) and provides for retirement, death, and disability benefits. The Company amended the Plan in 2003 to freeze new enrollments in the Plan. Only employees who were hired before October 1, 2003 or were initially hired before that date and rehired before December 1, 2003 are eligible to participate in the Plan. Effective March 31, 2009, the Plan froze the accrual of benefits for all eligible employees. At the Company's discretion, the Plan may unfreeze benefit accruals in the future. At the present time, the Company has no intention to unfreeze the Plan. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended. The Plan's trustee is BOKF, NA (Trustee).

The Plan is administered by the Company's Retirement Plan Committee (Committee). The Committee has overall responsibility for the operation and administration of the Plan. The Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

***Contributions***

The Company has agreed to voluntarily contribute amounts that are necessary to provide assets sufficient to meet the benefits to be paid to plan members. The Plan has met the minimum funding requirements established by ERISA. All contributions are directed into investments selected by the Company.

***Pension Benefits***

Benefits under the Plan are based on employees' 60 highest consecutive compensation months during their last 120 months of credited service as of March 31, 2009. Normal retirement age for plan benefits is 65. Participants may elect to receive reduced benefits upon early retirement, between the ages of 55 and 64, provided they have the minimum years of service with the Company as specified by the Plan. Accrued benefits are payable as an annuity over the participant's lifetime as a qualified joint and one-half survivor annuity, a 75% joint and survivor annuity, or an annuity over the participant's lifetime with a guarantee of a minimum of payments for 10 years. Participants may qualify to receive a lump-sum distribution under certain circumstances defined in the Plan.

***Death and Disability Benefits***

Death benefits are payable to the spouse of a participant if the participant elects to receive their benefits in the form of a qualified joint and one-half survivor annuity or an annuity over the participant's lifetime with a guarantee of a minimum of payments for 10 years. If the participant selected the qualified joint and one-half survivor annuity, the spouse of the participant will receive a 50% survivor annuity, as defined in the Plan, upon the death of the participant. The surviving spouse annuity is equal to 50% of the participant's monthly benefit. This benefit is immediately payable to the spouse if the participant was already receiving benefits. If the participant was not already receiving benefits, payments to the spouse may commence as of the earliest date the participant would have received benefits. If the participant selected an annuity over the participant's lifetime with a guarantee of a minimum of payments for 10 years, a death benefit is payable upon the death of the participant if the participant dies within the guaranteed 10-year period. If the participant selected a 75% joint and survivor annuity, the spouse's annuity is equal to 75% of the participant's monthly benefit.

Active employees who become totally disabled receive annual benefits that are equal to the normal retirement benefit they would have accumulated if they had maintained employment until their normal retirement date, defined as reaching age 65. All benefits for those deemed to be totally disabled are subject to cost-of-living increases.

***Vesting***

All participants in the Plan are fully vested. A participant who terminates for reasons other than retirement is entitled to a deferred vested benefit at age 65 based on their accrued benefit at the time of termination. A participant who has completed 15 or more years of service and terminates for reasons other than retirement may be eligible for reduced benefits at age 55.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the liquidation basis of accounting as of and for the years ended December 31, 2024 and 2023.

Upon receipt of a favorable determination letter by the Internal Revenue Service approving termination of the Plan, the Plan recorded the following cumulative effect adjustments to net assets available for benefits as of the date of adoption as of December 31, 2023 (in thousands):

The Plan was fully liquidated as of December 31, 2024.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets available for benefits, disclosure of contingent assets and liabilities, and the actuarial present value of accumulated plan benefits and changes therein. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Mutual funds are valued at the net asset value of shares held by the Plan at year-end. U.S. government securities are valued on the basis of yields currently available on comparable securities of issuers with similar credit ratings.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan at the Company's discretion.

***Accumulated Plan Benefits***

Accumulated plan benefits (see Note 5) are those estimated future periodic payments, including lump-sum distributions, that are attributable under the Plan's provisions to the service employees have rendered. Accumulated plan benefits include benefits expected to be paid to the following:

- Retired or terminated employees or their beneficiaries
- Present employees or their beneficiaries

Benefits under the Plan are based on employees' compensation from their 60 highest consecutive compensation months during their last 120 months of credited service as of March 31, 2009. Benefits payable under all circumstances—retirement, death, disability, and termination of employment—are included to the extent they are deemed attributable to employee service rendered as of March 31, 2009. Benefits to be provided via annuity contracts excluded from plan assets are excluded from accumulated plan benefits (see Note 8).

**Note 3. Plan Termination**

On October 18, 2022, the Company's Board of Directors adopted resolutions and a plan amendment to terminate the Plan effective December 31, 2022. The Company filed an application with the Internal Revenue Service on February 16, 2023 requesting a favorable determination on the termination of the Plan, which was received on July 1, 2024.

Upon receipt of approval termination, the net assets of the Plan were allocated, as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

1. Annuity benefits that former employees or their beneficiaries have been receiving for at least three years or that employees eligible to retire for that three-year period would have been receiving if they had retired with benefits in the normal form of annuity under the Plan. The priority amount is limited to the lowest benefit that was payable (or would have been payable) during those three years. The amount is further limited to the lowest benefit that would be payable under plan provisions in effect at any time during the five years preceding plan termination.
2. Other vested benefits insured by the PBGC (a U.S. government agency) up to the applicable limitations discussed below
3. All other vested benefits (that is, vested benefits not insured by the PBGC)

Certain benefits under the Plan are insured by the PBGC if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination. However, there is a statutory ceiling, which is adjusted periodically, on the amount of an individual's monthly benefit that the PBGC guarantees.

Whether all participants receive their benefits should the Plan terminate at some future time will depend on the sufficiency, at that time, of the Plan's net assets to provide for accumulated benefit obligations and may also depend on the financial condition of the Company and the level of benefits guaranteed by the PBGC.

**Note 4. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets

**Investments**

Where quoted market prices are available in an active market, investments are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of investments with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such investments are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, investments are classified within Level 3 of the hierarchy.

**Note 5. Accumulated Plan Benefits**

An actuary firm, Milliman, Inc., determines the actuarial present value of accumulated plan benefits, which is the amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements, such as for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

Significant assumptions underlying the actuarial computations are:

- Assumed rate of return on investments: 0% and 4.75% for 2024 and 2023, respectively
- Mortality basis: RP-2014 Adjusted to 2006 Mortality Table projected with Mortality Improvement Scale MP-2021 for 2024 and 2023
- Employee turnover rates based on the Company's prior experience
- Retirement at normal retirement age (65)
- Asset valuation: Market

The 2024 and 2023 actuarial assumptions were based on the liquidation basis of accounting. The computations of the actuarial present value of accumulated plan benefits were made as of January 1, 2024 and 2023. Had the valuations been performed as of December 31, there would be no material differences.

### **Note 6. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Fees for trust services paid by the Plan were approximately \$26,000 and \$43,000 for 2024 and 2023, respectively.

The Plan has a number of service providers. Such providers are parties in interest under ERISA. Actuarial fees paid by the Plan to Milliman, Inc., totaled approximately \$107,000 and \$119,000 for 2024 and 2023, respectively. PBGC premiums totaled approximately \$49,000 and \$328,000 for 2024 and 2023, respectively. Individually, nonmaterial expenses paid to parties in interest aggregated approximately \$82,000 and \$21,000 for 2024 and 2023, respectively. Accrued expenses expected to be incurred in liquidation were approximately \$262,000 at December 31, 2023, see Note 2.

The Company provides certain administrative services at no cost to the Plan.

### **Note 7. Plan Amendments**

Effective February 1, 2022, the Plan was amended to allow for deferred vested participants who have not begun receiving benefit payments to elect to receive a lump-sum distribution of their accrued benefits.

On October 18, 2022, an amendment was made to terminate the Plan effective December 31, 2022 (see Note 3).

### **Note 8. Purchase of Group Annuity Contracts**

On October 29, 2024, the plan sponsor purchased nonparticipating group annuity contracts from a third-party insurer to cover vested benefits. The associated projected benefit obligation was settled through the purchase of the group annuity contracts.

**Note 9. Tax Status**

The Plan has received a determination letter from the Internal Revenue Service dated June 19, 2013 stating the Plan and related trust, as then designed, were in compliance with the applicable requirements of the Internal Revenue Code (IRC) and, therefore, not subject to tax. The Plan has been amended since receiving the determination letter. However, the plan administrator believes the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC. As discussed in Note 3, the Company filed an application for favorable determination on the termination of the Plan and as of December 31, 2023 such application was pending. The plan received favorable determination from the IRS on July 1, 2024.

**Note 10. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the accompanying statements of net assets available for benefits.

Plan contributions are made, and the actuarial present value of accumulated plan benefits are reported, based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimation and assumption process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

**Note 11. Subsequent Events**

Subsequent events have been evaluated through September 29, 2025, which is the date the financial statements were available to be issued.
