**Note 1 - Plan Description**

The following description of iCONN 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all employees of iCONN Systems, LLC (the "Company") who are not covered by collective bargaining agreements and who have completed three months of service, as defined in the plan document. Participation is voluntary and effective the first day of the quarter following the date the eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

The Plan provides for employee salary deferral contributions up to the maximum tax-deferred limitations established by the Internal Revenue Code. The Plan allows participants to contribute post-tax Roth 401(k) contributions in addition to pretax deferrals. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Plan provides for employer safe harbor matching contributions equal to 3 percent of compensation. Safe harbor contributions totaled \$118,882 for 2024 and were remitted subsequent to year end and recorded as a contribution receivable as of December 31, 2024.

The Company may also make discretionary nonelective contributions to the Plan, as approved by the Company's management. For 2024, these discretionary nonelective contributions were a percentage of eligible compensation for all participants who have satisfied the aforementioned eligibility criteria and were employed on the last day of the plan year. Discretionary nonelective contributions totaled \$58,252 for 2024 and were remitted subsequent to year end and recorded as a contribution receivable as of December 31, 2024.

The Company may also make a discretionary matching contribution to the Plan. There were no discretionary matching contributions made during 2024.

**Participant Notes Receivable**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of 50 percent of the participant's vested balance minus any existing loan balance or \$50,000 reduced by the participant's highest outstanding loan balance in the previous 12 months. Notes receivable are collateralized by the participant's account balance and bear interest at a market rate.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

**Vesting**

Participants are immediately 100 percent vested in employee salary, rollover contributions, employer safe harbor contributions, and any income or loss thereon. Vesting in the Company's discretionary nonelective contribution portion of their accounts, plus actual earnings thereon, is based on years of service. Participants vest in discretionary nonelective contributions made by the Company 20 percent after one year of service and an additional 20 percent after each additional year of service thereafter until they become fully vested after five years of service.

**Note 1 - Plan Description (Continued)**

***Benefit Payments***

Distributions are payable upon retirement, death, disability, termination of employment, or attainment of 59½ years of age in the form of a lump-sum amount equal to the vested balance of a participant's account.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document.

***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan.

***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by American Funds Distributors, Inc. or its affiliates, which includes Capital Bank and Trust Company. Capital Bank and Trust Company is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

During 2023, there was an inadvertent distribution to the plan sponsor, which is considered a prohibited transaction under ERISA Section 406(a)(1)(D). This is included in the schedule of nonexempt transactions. The Company corrected this prohibited transaction during 2024.

***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

**Note 2 - Summary of Significant Accounting Policies**

***Investment Valuation and Income Recognition***

Investments held by the Plan are stated at fair value.

The common/collective trust fund is valued at net asset value per share (NAV) (or its equivalent) of the fund, which is based on the fair value of the fund's underlying net assets. There are no redemption restrictions or unfunded commitments on this investment. All other investments are valued based on quoted market prices reported in active markets. See Note 5 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

***Benefit Payments***

Benefits are recorded when paid.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

***Administrative Expenses***

Various administrative costs are paid by the Company.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including September 25, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Certified Information**

Capital Bank and Trust Company (the "Trustee") holds the Plan's investments and executes all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

**Note 4 - Tax Status**

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

**Note 5 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

***Level 2***

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

**Note 5 - Fair Value Measurements (Continued)**

**Level 3**

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

**Mutual Funds**

Mutual funds are valued at quoted prices reported in active markets.

**Common/Collective Trust Fund**

The common/collective trust fund is valued at net asset value per share or its equivalent of the fund, which is based on the fair value of the fund's underlying net assets. There are no redemption restrictions or unfunded commitments on this investment.
