- h. Expenses: The Target Normal Cost was increased by \$-0- to reflect anticipated expenses to be paid from the plan in the current year.
- i. Cash Balance Interest Credit: It was assumed that future interest credits would be 2.90% [average applicable rate during the current and last 4 plan years].
- j. Actuarial Cost Method: The method prescribed by IRC Section 430 was used.
- k. Participants Included: Those expected to meet eligibility by the end of the Plan Year.
