Scope and nature of the ERISA Section 103(a)(3)(C) audit

We have performed audits of the financial statements of Robinson & Cole Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Robinson & Cole Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement, and any amendments thereto, for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution retirement plan covering partners, senior counsel and nonlawyer employees of Robinson & Cole LLP (the Firm). Eligible employees may begin to make salary deferral contributions to the Plan on the first day of the month following their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Firm is responsible for oversight of the Plan. The Plan's Administrative Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Firm's Managing Committee.

Plan Amendments

Effective September 1, 2022, participants become eligible to receive Firm contributions on the first of the month coinciding with or next following the date of his or her hire date. Prior to September 1, 2022, participants were eligible to receive Firm contributions on the January 1 or July 1 coinciding with or next following the date they have attained the age of 21 and completed a year of service, as defined by the Plan. Effective March 1, 2023, participants are eligible to receive Firm contributions on the first of the month coinciding with or next following the date they have attained the age of 21 and completed a year of service, as defined by the Plan.

Contributions

Each year, participants may contribute up to 30% of pre-tax annual compensation, as defined in the Plan. Participants may also designate all or a portion of their contributions as Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans and individual retirement accounts (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect otherwise. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated target date fund until changed by the participant, with annual increases of 1% each January 1 up to a maximum automatic enrollment contribution of 8%.

The Firm contributes matching contributions equal to 100% of each participant's first 1% of salary deferral contributions or Roth contributions and an additional 50% of the next 5% in a plan year. Participants are eligible on the first of the month coinciding with or next following the date of his or her hire date in order to receive matching contributions. The Firm contributes matching contributions as of the last day of June, September, and December of each plan year to those participants who have satisfied these eligibility requirements. Participants direct the investment of the Firm's matching contributions.

The Firm also makes nonelective contributions on periodic basis equal to 6.5% of the participant's eligible compensation, as defined by the Plan, plus an additional amount equal to 5.4% of the participant's excess compensation. Excess compensation is defined as compensation in excess of 80.1% of the Social Security taxable wage base (\$168,600 in 2024). In lieu of these Firm contributions, contract partners and income partners receive an amount equal to 1.5% of their eligible compensation. Participants are eligible on the first of the month coinciding with or next following the date of his or her hire date, in order to receive

nonelective contributions. The Firm contributes nonelective contributions periodically to those participants who have satisfied these eligibility requirements.

Nonlawyer participants, who are non-highly compensated and have completed three consecutive years of service, may elect to have up to eight days of unused vacation time converted to its equivalent in pay and contributed by the Firm to the participant's account. Participants also direct the investment of the Firm's nonelective contributions. Contributions are subject to the limits of the Internal Revenue Code (IRC).

Participant Accounts

Each participant's account is credited with the participant's contributions and Firm matching contributions, as well as allocations of the Firm's nonelective contributions and plan earnings. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants may direct their contributions into any of the funds offered by the Plan, which are held at T. Rowe Price Trust Company (T. Rowe Price). These funds include a variety of investment options with various objectives and degrees of financial risk. In addition, the Plan offers a self-directed brokerage account in which participants may make investments that are not otherwise offered by the Plan. The investments in these self-directed brokerage accounts are held in trust by T. Rowe Price.

Vesting

Participants are immediately vested in employee deferral and rollover contributions, including the earnings on these amounts. Vesting in their employer accounts is based on years of continuous service. In the event of termination due to death, total and permanent disability, or normal or early retirement, participants shall become 100% vested in the Firm matching and nonelective contribution portions of their account. For all other participants, effective January 1, 2007, vesting in the Firm matching contribution portion of their account made on or after January 1, 2007, is based on credited years of service, as defined by the Plan, according to the following schedule:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years, except for loans to purchase a primary residence, which may be offered for a term of up to 15 years. The loans are secured by the balance in the participants' accounts. The loan interest rate, which is fixed at the time of the loan, is set at 1% above the prime rate, as defined. The notes currently bear interest at rates ranging from 4.24% to 9.5%. Participants may only have one loan outstanding for a principal residence and one loan outstanding for any other purpose at any given time. Generally, principal and interest are paid ratably through bi-weekly or semi-monthly payroll deductions.

Payment of Benefits

Upon retirement, disability, death, or termination of employment, the participant shall become entitled to the total value of his or her vested account. Distributions will be paid in a lump-sum or in installments, based upon election of the participant or the Plan, as defined in the Plan. If a participant terminates employment for any reason and his or her vested account balance does not exceed \$1,000, the Plan administrator may distribute such amount in a lump-sum payment to the participant without consent of the participant.

Prior to termination of employment, withdrawals from the salary deferral and Firm matching portions of a participant's account may be made in the event of a financial hardship, in accordance with the provisions specified by the Plan. Participants may also make in-service withdrawals from the rollover portion of their accounts, in accordance with the provisions of the Plan. The Plan also allows participants the ability to make in-service withdrawals provided they have attained age 62.

Forfeitures

Forfeited nonvested accounts totaled \$117 and \$1,194 at December 31, 2024 and 2023, respectively. These accounts will be used to reduce future employer matching and nonelective contributions or to pay plan expenses. During 2024, employer contributions were reduced by \$96,382 from forfeited nonvested accounts. The Plan did not utilize any balance of the forfeited nonvested accounts to pay plan expenses for the year ended December 31, 2024.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant's loan to be in default, the participant's loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits to participants are recorded when paid.

Plan Expenses

Certain expenses of maintaining the Plan are paid directly by the Firm and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions and investment administrative expenses are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

The Plan uses a fee leveling approach. The Plan receives revenue sharing credits from the trustee that are contributed into an administrative budget account and used to pay plan expenses or are reallocated to individual participant accounts. Any revenue sharing amounts generated by the Plan are credited directly back to the underlying investments in the individual participant accounts that generated the revenue sharing credits. In addition, Plan participants are charged with a direct allocation of the Plan's administrative expenses on a quarterly basis. During 2024, the amount received by the Plan of \$116,251 and presented in other income on the statement of changes in net assets available for benefits were used to pay plan expenses. No revenue credits were allocated to participants in 2024.

Risks and Uncertainties

The Plan provides for various investment options. These investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and those changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

Subsequent events were evaluated through October 2, 2025, the date the financial statements were available to be issued.

NOTE 3 - CERTIFICATION BY THE INVESTMENT TRUSTEE

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, T. Rowe Price Trust Company, the trustee of the Plan, has certified that the following data included in the financial statements and supplemental schedule is complete and accurate:

- Investments at fair value as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income, interest income on notes receivable from participants and other income as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- The schedule of assets (held at end of year) at December 31, 2024.

NOTE 4 - FAIR VALUE MEASUREMENTS

Accounting principles generally accepted in the United States of America establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Assets valued using the net asset value (NAV) practical expedient are not required to be reported within the hierarchy.

The following is a description of the valuation methodology used for assets measured at fair value:

Mutual Funds: Mutual funds are valued at the quoted price of shares held by the Plan at year end.

Common and Collective Trust Funds: Common and collective trust funds are stated at their NAVs as reported by the investment manager of the fund based on the fair value of the underlying assets and liabilities at the measurement date. The NAV is used as a practical expedient to estimate fair value.

Self-Directed Brokerage Accounts: Self-directed brokerage accounts include money market funds, mutual funds, exchange traded funds, common and preferred stocks, certificates of deposit and corporate bonds.

Money market and mutual funds held within self-directed accounts are valued at the quoted price of shares held by the Plan at year-end and are valued using Level 1 inputs.

Exchange traded funds and common and preferred stocks held within the self-directed accounts are valued at the closing price reported in the active market in which the individual securities are traded and are valued using Level 1 inputs.

Certificates of deposit held within the self-directed accounts are valued by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer and are valued using Level 2 inputs.

Corporate bonds held within self-directed accounts are valued based on yields currently available on comparable securities of issuers with similar durations and credit ratings and are valued using Level 2 inputs.

Stable Value Collective Trust Fund: The stable value collective trust fund is composed primarily of investment contracts and is valued at the NAV of the units held of the collective trust. The NAV is used as a practical expedient to estimate fair value.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - PLAN TRANSFERS

The Firm also sponsors the Robinson & Cole Employee Savings Plan. Certain employees and their account balances are transferred between the Plan and the Robinson & Cole Employee Savings Plan as a result of changes in their employment classification. Affected employees transferring out of the Plan cease to participate in the Plan and immediately become eligible to participate in the Robinson & Cole Employee Savings Plan. Affected employees transferring into the Plan cease to participate in the Robinson & Cole Employee Savings Plan and immediately become eligible to participate in the Plan. Total transfers to the

Robinson & Cole Employee Savings Plan were \$0 for the year ended December 31, 2024. Total transfers from the Robinson & Cole Employee Savings Plan were \$381,548 for the year ended December 31, 2024.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are managed by affiliates of T. Rowe Price. T. Rowe Price is a trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Indirect fees incurred by the Plan for investment management services are included in the net appreciation in fair value of investments. Direct fees paid by the Plan to the trustee, accountants, and investment advisors for administrative expenses, consulting fees, and investment advice amounted to \$184,737 for the year ended December 31, 2024. The Plan sponsor pays directly any other fees related to the Plan's operations. See Note 2 for discussion of the trustee's contributions into the Plan's administrative budget account.

Certain employees of the Firm who participate in the Plan perform administrative services to the Plan at no cost to the Plan. Notes receivable from participants are also party-in-interest transactions.

NOTE 7 - INCOME TAX STATUS

The Plan obtained its latest determination letter on July 11, 2017, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Firm has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their accounts.
