## Notes to Financial Statements

### 1. Description of the plan

The following description of the Pivot Energy, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan provisions.

**General** - Established effective January 1, 2023, the Plan is a defined contribution plan covering, with certain specified exclusions, all employees that are at least age eighteen. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Plan administrator is Pivot Energy, Inc. (the "Company"). The Plan Administrator keeps records for the Plan. The Plan Trustee is the Chief Financial Officer of Pivot Energy, Inc. (the "Trustee") and Empower Trust Company LLC is the Plan Custodian ("Empower", the "Custodian"). Participant investment options in the Plan are valued every day that Empower, any transfer agent appointed by the Trustee (or Custodian) or the Employer, and any stock exchange used by such agent are open for business (daily valuation).

**Contributions** - Participants may contribute from 1% to 100% of their eligible pay, as defined under the Plan. The Plan permits elective deferrals, including Roth elective deferrals, 401(k) "ADP Test safe harbor contributions", employer matching contributions, and rollover contributions. Participants are allowed to designate all or a portion of their contributions as Roth contributions. The Company may contribute to the Plan at its discretion, up to 4% of employee compensation, as part of the safe harbor match. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Company contributions to the Plan were \$1,161,699 for the year ended December 31, 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Contributions are subject to certain Internal Revenue Code (IRC) limitations.

**Participant accounts** - Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions and an allocation of the Company's discretionary contribution and Plan earnings. Participant accounts are also charged with withdrawals and an allocation of plan losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined under the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

**Investments** - Participants direct the investment of all contributions into various investment options offered by the Plan and may change investments and transfer amounts between funds daily.

**Vesting** - Participants are immediately vested in their voluntary contributions plus actual earnings (losses) thereon. Participants are 100% vested in employer nonelective contributions and employer matching contributions upon entering the Plan.

**Notes receivable from participants** - Participants may borrow from their individual accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or up to fifteen years for the purchase of a primary residence. The loans are secured by the vested balance in the participant's account and bear interest at a rate established quarterly by the Plan administrator based on the published prime rate plus 1%. At December 31, 2024, participant loans have various maturities through August 2029 at interest rates ranging from 9.00% to 9.50%. Principal and interest are paid ratably through payroll deductions.

**Payment of benefits** - On termination of service, a participant will receive a lump-sum amount equal to the value of their vested account as soon as feasibly possible following the participant's termination of service. Participants are also eligible to make hardship withdrawals from their deferred contributions in the event of certain financial hardships.

### 2. Summary of accounting policies

**Basis of accounting** - The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America ("GAAP").

**Use of estimates** - The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Risks and uncertainties** - The Plan utilizes various investment instruments, including mutual funds and fixed annuities. Investment instruments, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

**Investment valuation and income recognition** - The Plan's investments are stated at fair value, except for its investment in the EI Fixed Account - Series Class I fixed annuity which is stated at contract value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the amount Plan participants would receive if they were to initiate permitted transactions under the terms of the Plan (see Note 5). Shares of mutual funds are valued at quoted market prices, which represent the net asset value ("NAV") of shares held by the Plan at year-end. Mutual funds are valued at the NAV per share, which is based on the fair value of the underlying net assets.

The net appreciation (depreciation) in fair value of investments is based on the fair value of the investments at the beginning of the year or cost, if purchased during the year. Net appreciation (depreciation) includes the Plan's gains or losses on investments bought and sold as well as held during the year.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date.

**Notes receivable from participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan Document.

**Administrative expenses** - Administrative expenses are paid by either the Company or the Plan, in accordance with the terms of the Plan Document. Participants pay administrative costs for loans, distributions and qualified domestic relation orders. See further disclosures regarding revenue sharing in Note 6. Management fees and operating expenses charged to the Plan for investments in registered investment companies are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

**Payment of benefits** - Benefit payments to participants are recorded upon distribution. There were no amounts allocated to accounts of persons who have elected to withdraw from the Plan, but have not yet been paid, as of December 31, 2024 or December 31, 2023, respectively.

**Contributions** - Employee contributions and employer matching contributions are recorded when withheld on a semi-monthly basis, in conjunction with the Company's payroll cycle.

**Excess Contributions Payable** - The Plan is required to return contributions received during the Plan year in excess of the IRC limits. There were no excess contributions due to participants as of December 31, 2024 or December 31, 2023, respectively.

### 3. Fair value measurements

Accounting Standard Codification 820, *Fair Value Measurements and Disclosures* ("ASC 820"), provides a framework for measuring fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows:

- Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets,
- Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available, and
- Level 3, which refers to securities valued based on significant unobservable inputs.

Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value:

**Mutual funds** - Shares of mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with Securities and Exchange Commission and are categorized as Level 1. The mutual funds held by the Plan are deemed to be actively traded.

**Transfers between levels** - The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

Plan management evaluates the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the years ended December 31, 2024 and December 31, 2023, there were no transfers between levels.

The following table sets forth by level within the fair value hierarchy a summary of the Plans Investments measured at fair value as a recurring basis as of December 31, 2024.

### 5. Fully benefit-responsive investment contracts

The Plan holds a general account investment product in its investment portfolio that comprises a traditional investment contract. This contract meets the fully benefit-responsive investment criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. As of December 31, 2024 and December 31, 2023, the Plan held investments with a contract value of \$233,441 and \$172,343, respectively.

The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset quarterly and can never be less than zero. The average yield earned by the plan for the benefit responsive fund can be derived by averaging the quarterly gross interest rates for the fund over the year. The average for 2024 is 1.41%, and the average for 2023 is 1.23%.

The fully benefit-responsive investment contract included in the Plan's net assets as of December 31, 2024 includes termination clauses that may limit the ability of the Plan to transact with the issuer at contract value. The contract may be terminated by the Plan or the issuer with advance written notice, and shall terminate on the 75th business date after that notice is received by either party. Additionally, the contract will be terminated in the event of Plan termination by the Company. In the event the contract is terminated, the issuer will remit the Fixed Account Value in accordance with the applicable Fixed Account rider, less any outstanding charges and fees, including the Contract termination charge, if applicable, due to the issuer. These termination events are not considered to be probable of occurring as of December 31, 2024.

### 6. Related party transactions and exempt party-in-interest transactions

Fees paid for investment management services were included as a reduction of the return earned on each fund.

The Plan also allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan, including the Company. The Plan issues loans to participants, which are secured by the vested balances in the participants' accounts. The Plan issues loans to participants under the deferred arrangement portion of the Plan, which are secured by the vested balances in the participants' accounts.

Plan investments include the EI Fixed Account - Series Class I investment contract, which is issued by Empower Advisory Group LLC, a wholly owned subsidiary of the Custodian, and therefore the investment qualifies as party-in-interest. See Note 5 for further information regarding this contract.

Administrative revenues arise when investment managers return a portion of the investment fees to Empower to offset the administrative expenses. Any excess resulting from this revenue sharing remains in an unallocated account from which future Plan expenses can be paid. During the years ended December 31, 2024 and December 31, 2023 there were Plan expenses of \$25,362 and \$43,007 paid from this account, respectively.

### 7. Federal income tax status

The Plan uses a prototype plan document sponsored by USI Consulting Group ("USI"). USI received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

### 8. Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions set forth in ERISA. The Employer has no obligation or liability to maintain the plan for a specific length of time and may terminate the Plan or discontinue contributions under the Plan at any time without liability hereunder for any such discontinuance.
