INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Jesco, Inc. Savings and Investment Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Jesco, Inc. Savings and Investment Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Jesco, Inc. Savings and Investment Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Jesco, Inc. Savings and Investment Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

NOTE A- Description of Plan

The following description of the Jesco, Inc. Savings and Investment Plan (hereinafter as " The Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General

The Company established the Plan to provide non-union employees with a systematic means of saving and investing for the future. All employees who are 19 years of age and have completed six months of service are eligible to participate in the plan on entry date after attaining six months of service. Entry dates are the first day of month after the service obligation is met, or the day the service obligation is met if it falls on the first of the month. The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Assets of the Plan are allocated to participant accounts based on specific contributions made by each participant and respective matches made by the Company. Investment income (loss) is credited to each account based on appreciation (depreciation) of specific assets held in each participant account and any earnings thereon.

2. Contributions

Participants may contribute from 1 percent to 50 percent of compensation by means of payroll deductions, subject to certain discrimination tests prescribed by the Internal Revenue Code and other limitations specified in the Plan. The Company may make a discretionary matching contribution equal to a uniform percentage of salary deferrals. Employees who do not make an election are automatically enrolled at a deferral rate of 6% of eligible compensation.

3. Participant Accounts

Each participant's account is credited with participant's contributions, allocations of the Company's matching contributions and Plan gains or losses. Allocations of earnings and losses for each fund are based on the ratio of weighted average participant account balances per fund to the total weighted average of all participant account balances. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant's accounts.

4. Vesting

Participants are immediately vested in their voluntary contributions, Company matching contributions and actual earnings thereon. However, vesting in Company matching contributions is based on years of service. Prior to normal retirement age, a participant's interest in the contributions of the employer becomes 100 percent vested after three years of service.

5. Distributions

Upon retirement, disability or death, a participant or beneficiary receives the amount credited to the participant's account in either a lump sum or, at the participant's election, in installments. Upon termination, other than retirement, disability or death, a participant becomes eligible to receive the current value of the participants' vested account in a lump sum.

6. Participant Investment Rollovers

Participants are allowed to transfer or rollover funds into the Plan from other qualified plans.

NOTE A- Description of Plan (continued)

7. Participant Notes Receivable

Participants may borrow from their account balances with interest charged at a rate equal to the "prime rate" plus 1 percent, which remains in effect for the duration of the loan. Loan terms range from 1 to 5 years or up to 25 years for the purchase of a primary residence. The minimum loan is \$1,000 and the maximum loan is the lesser of \$50,000 less the highest outstanding loan balance during the one year period prior to the new loan application date, or 50 percent of the participant's account balance less any current outstanding loan balance. The loans are secured by the balance in the participants' account. Principal and interest are paid ratably through payroll deductions. Participants may only take out one loan during any 12 month period and may only have two loans outstanding at any time. As of December 31, 2024 and 2023, the Plan had loans receivable from participants with principal balances plus any accrued and unpaid interest totaling \$256,690 and \$245,765 respectively, which are included in the accompanying Statements of Net Assets Available for Benefits. If the participant elects not to repay the outstanding balance, the loan is canceled and deemed a distribution under the Plan.

8. Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$10,912 and \$6,694, respectively. These accounts will be used to reduce future employer contributions.

NOTE B- Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America.

Use of Accounting Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of certain assets, liabilities and disclosures. Accordingly, the actual amounts could differ from those estimates. Any adjustments applied to estimated amounts are recognized in the year in which such adjustments are determined.

Concentration of Credit Risk

The Plan's contributions are dependent upon contributions from employees of the Plan sponsor and these contributions are voluntary.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability on the financial statements. There were no excess contributions payable for the plan year ended December 31, 2024.

NOTE B- Summary of Significant Accounting Policies (continued)

Investment Valuation and Income Recognition

All investments of the Plan are held at Empower Trust Company, LLC. The investments are comprised of open ended mutual funds selected by the participants.

Empower Trust Company, LLC uses quoted market prices to value investments. Shares of mutual funds are valued at quoted market prices. Notes receivable from participants are reported at their unpaid principal balances plus any accrued interest.

Management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of net appreciation in fair value of investments.

The change in net unrealized appreciation/depreciation of investments held from the beginning of the plan year is included with realized gains/losses reported in the accompanying statement of changes in net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are paid by the participant are excluded from these financial statements.

Payment of Benefits

Benefits are recorded when paid.

Contributions

Contributions from the employees and the Company are recorded in the period in which the Company makes the payroll deductions from participant earnings.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. Other administrative expenses are allocated based on participant account balances at the time the expenses are incurred.

NOTE C- Fair Value Measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the assets or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The Plan's investments are held in trust and administered by the Trustee. All investment information presented in the accompanying financial statements and supplemental schedules, including investments held and net appreciation/depreciation in fair value of investments and interest and dividends, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the Trustee.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Open End Mutual funds* - Valued at the net asset value (NAV) of shares held by the plan at year end.

NOTE D- Fixed Annuity Contract

The Plan has entered into a fixed annuity contract with Key Guaranteed Portfolio Fund totaling \$745,218 for 2024 and \$1,228,546 for 2023. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. This contract meets the fully-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for the fully-responsive investment contracts because this is the amount received by participants if they were permitted to initiate transactions under the terms of the Plan. Contract value, as reported by Empower Trust Company, LLC represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer if all or a portion of their investment at contract value.

NOTE E- Collective Trust Fund

The Plan invests in a collective trust fund, which is a pooled investment vehicle sponsored and managed by Empower Trust Company, LLC. These funds are not registered with the Securities and Exchange Commission and are available only to qualified retirement plans and certain other institutional investors.

The collective trust funds are valued at the net asset value (NAV) provided by the fund manager, which is based on the fair value of the underlying assets in accordance with the fair value hierarchy under Accounting Standards Codification (ASC) 820, *Fair Value Measurement*. The NAV is used as a practical expedient to estimate fair value, as it is the basis for participant transactions.

Redemption from these funds is permitted daily with no restrictions or notice requirements, unless otherwise stated.

For the years ended December 31, 2024 and 2023 the Plan had an investment market value in the collective trust fund of \$297,134 and \$-0- respectively.

NOTE F- Tax Status

The Plan has received a determination letter from the Internal Revenue Service dated March 11, 2011 stating that the Plan is qualified under Section 401(a) of the Internal Revenue Code (the "Code") and therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan has not been amended since receiving the determination letter. Plan management believes the Plan is currently designed and operated in compliance with the applicable requirements of the Code. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax asset or liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examination for years prior to 2019.

NOTE G- Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments and investment income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Trust Company, LLC, the trustee of the Plan.

NOTE H- Rollover Contributions

The Plan allows for rollover contributions for employees. All rollover contributions become 100% vested on the day of the rollover contribution. Rollover contributions for the year ended December 31, 2024 were \$100,042 and are recorded on the statement of changes in net assets available for benefits.

NOTE I – Recent Accounting Standards

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of professional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2023, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements

NOTE J- Related-Party Transactions and Party in Interest Transactions

Certain plan investment funds available under the Plan are managed by Empower Trust Company, LLC. Empower Trust Company, LLC is the trustee for the Plan and, therefore these transactions qualify as party in interest transactions.

NOTE K- Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate, modify, alter or amend the Plan subject to the provisions of ERISA, provided that no such termination, modification, alteration or amendment shall permit any of the funds established pursuant to the Plan to be used for any purpose other than the exclusive benefit of the participating employees. In the event of Plan termination, participants will become 100 percent vested in their accounts.

NOTE L – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes on the values of investment securities will occur in the near term and that such changes could materially affect participants' accounts balances and the amounts reported in the statement of net changes available for benefits.

NOTE M – Subsequent Events

The plan has evaluated subsequent events through September 26, 2025, the date the financial statements were available to be issued. No additional subsequent events have occurred that would require disclosure in the financial statements.
