### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Crane 1 Services, Inc. Retirement Savings Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **Note 1. Description of the Plan**

The following description of the Crane 1 Services, Inc. Retirement Savings Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan sponsored by Crane 1 Services Inc, (Company) and covers all full-time, nonunion employees of the Company. Initial enrollment is available at the beginning of each month after reaching eligibility. The Plan has elected the qualified automatic enrollment arrangement (QACA) as permitted by the prototype plan. Employees failing to complete a deferral election form will be automatically enrolled in the Plan upon reaching eligibility. All employees eligible to participate in the Plan are eligible to receive the safe harbor employer matching contributions, which fully vest after two years or reaching age 55. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). The Board of Directors oversees governance of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance. Fidelity Management Trust Company (Fidelity) serves as the custodian and recordkeeper of the Plan. The Plan is subject to the provision of the ERISA.

Under the terms of the Plan, there is no service requirement and covered employees are eligible to become participants on the next eligible date following their date of hire. Participants may enter the Plan on the first day of each month.

**Contributions**

Each year, participants may elect to contribute up to 100% of compensation, as defined in the Plan agreement, subject to certain Internal Revenue Code (IRC) limitations. Participant salary deferrals may be traditional 401(k) (pretax) or Roth 401(k) (after-tax). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans and certain individual retirement accounts. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Employees who are still automatically enrolled in the plan have their deferral rate increased by 1% annually until reaching a deferral rate of 6%. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

The Company makes safe harbor matching contributions of 100% of the first 1% of base compensation that a participant contributes to the Plan and an additional 50% of the next 5% of base compensation that a participant contributes to the Plan for a maximum match of 3.5%. The Company made safe harbor contributions of \$1,088,089 during the year ended December 31, 2024.

The Company, at its discretion, can make a non-elective discretionary contribution. The discretionary contribution will be allocated as a uniform percentage of eligible compensation based on certain allocation groups. The Company may make a different discretionary contribution for each allocation group. In determining the allocation for a particular allocation group, only eligible participants in such allocation group are taken into account. An employee must be credited with at least 1,000 hours of service during the Plan year to become eligible to receive a contribution and employment at the end of the Plan year is required to participate. Contributions are subject to the vesting schedule below. Each participant is in their own allocation group. The Company made no discretionary contributions during the year ended December 31, 2024.

***Investment Options***

Participants direct the investment of their accounts into various investment options offered by the Plan. The Plan currently offers mutual funds and common collective trust funds as options.

***Participant Accounts***

Each participant's account is credited with the participant's contributions, rollover contributions, and Company safe harbor matching contributions, as well as allocations of the Company's non-elective discretionary contribution and Plan earnings. Participant accounts are charged with benefit payments and an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants vesting is based on service years. Participants are 100% vested in the voluntary salary deferrals, rollover contributions, plus actual earnings thereon. Safe harbor matching contributions are 100% vested after two years of service, in accordance with the QACA election, or upon reaching age 55. The nonelective discretionary contributions are subject to the following vesting schedule:

***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates as determined by the plan administrator. At December 31, 2024, outstanding loans bore interest rates between 3.25% and 8.50%. Principal and interest is paid ratably through payroll deductions.

***Payment of Benefits***

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. In-service withdraws are permitted upon demonstration of financial hardship, age 59½, or upon reaching the normal retirement age.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$123,635 and \$69,341, respectively. These accounts will be used to first reduce administrative expenses with the remaining to be used to reduce safe harbor matching contributions. During 2024, forfeitures of \$82,375 were utilized to pay administrative expenses and \$1,780 used to reduce safe harbor matching contributions.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP).

***Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income, if any, is recorded on an accrual basis. Dividends, if any, are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loan are reclassified as distributions based on terms of the plan document.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Expenses relating to specific participant transactions, such as notes receivable from participants and distributions, are charged directly to the participant's account. Investment related expenses are included in net appreciation in fair value of investments.

***Subsequent Events***

The Plan has evaluated subsequent events through October 3, 2025, the date that the financial statements were available to be issued. See Note 11.

**Note 3. Fair Value Measurements**

Fair value as defined under GAAP is an exit price, representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value.

These tiers include:

- Level 1** Observable inputs such as quoted prices in active markets.
- Level 2** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual Funds**

Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

**Common Collective Trust Funds**

These funds are valued at the net asset value (NAV) of units of the collective fund. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the funds will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require twelve months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

**Note 5. Exempt Party-in-Interest Transactions**

Fidelity is the custodian and manage all of the Plan's assets. The Plan pays custodian fees and asset management fees throughout the year. Fees paid to the custodian for the year ended December 31, 2024 totaled \$86,462. Other fees paid by the Plan of \$48,216 include investment advisory fees.

**Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

**Note 7. Tax Status**

The Plan has not obtained a determination letter from the IRS stating that the Plan was in compliance with the applicable requirement of the IRC. The Plan is relying on the IRS approval of the non-standardized pre-approved plan that it is utilizing. The IRS has determined and informed the document sponsor by a letter dated June 30, 2020, that the plan document was designed in accordance applicable sections of the IRC. The Plan has been amended since that date. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8. Nonexempt Transactions**

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets. While the Company remitted all employee contributions to the Plan, contributions of \$125,768 were not remitted within the required time period for the year ended December 31, 2024.

**Note 9. Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
