As a result of our audit of the Bloomsbury Publishing, Inc. 401(k) Plan (the Plan) for the year ended December 31, 2024, we have the following comments and recommendations:

Employee Contributions

The Department of Labor (the DOL) requires that participant contributions be remitted to the Plan on the earliest date on which they can be segregated from Company general assets. Failure to remit participant contributions to the Plan in a timely manner results in a prohibited transaction that must be separately reported to the DOL. During our audit, we noted one deferral that was not remitted timely. The Plan has currently calculated, remitted and allocated lost earnings to the applicable participants. As required by the DOL, a schedule of delinquent participant contributions has been included in the financial statements.

We recommend that Plan management review the procedures for remitting amounts withheld from participants to the Plan and determine a timeline upon which deferred amounts can be reasonably segregated from the Plan Sponsor's general assets and implement procedures to ensure that the remittances are made timely and consistently in accordance with such timeline.

Eligible Compensation

During our audit, we noted that the compensation used for calculating employee deferrals is not consistent with the definition of eligible compensation stated in the Plan document. Reimbursement stipends were included in compensation when the Plan document states these are not eligible wages.

We recommend Plan management improve its internal controls and processes over the calculation of eligible compensation and provide the necessary training to the persons responsible for setting up payroll and new payroll codes.

Forfeiture Calculations

During our audit, we noted that vesting and forfeitures were not accurately calculated for one participant's distribution which resulted in an incorrect distribution payment to that participant.

We recommend Plan management consult with Plan service providers to implement policies and procedures to review all distribution payments for correct vesting and forfeitures prior to payments being made. We also recommend that Plan management complete a historical review of participant distributions to ensure there are no other vesting and forfeitures calculated incorrectly that would require correction.
