INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
Dennis Kirk, Inc. 401(k) Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Dennis Kirk, Inc. 401(k) Savings Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements ("financial statements").

- the information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings and certain internal control related matters that we identified during the audits.

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of accounting - The Dennis Kirk, Inc. 401(k) Savings Plan ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

Accounting estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Subsequent events - The financial statements include management's evaluation of the events and transactions occurring subsequent to December 31, 2024 through July 9, 2025, which is the date the financial statements were available to be issued.

Risks and uncertainties - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Key parties of the plan - Dennis Kirk, Inc. is the plan sponsor, employer and the plan administrator. Empower Trust Company, LLC is the trustee that holds custody of the plan's mutual funds. Empower Annuity Insurance Company of America holds custody of the plan's guaranteed investment contract. Empower Retirement, LLC is the third party administrator which maintains investment and participant records, performs various compliance tests as tax counsel and is the brand name which refers to the products and services provided by both Empower entities discussed above, collectively referred to as "Empower". Robert W. Baird & Co. Incorporated is the plan's investment advisor.

Investments - The plan administrator determines the investments available to plan participants. The participants allocate their contributions and transfer existing balances among the available investment options. Participants should refer to the prospectuses and annual reports of the investments for more information. Earnings, including the net appreciation (depreciation) of investments bought, sold and held during the years, is reflected in the accompanying statements of changes in net assets available for benefits.

Fair value measurements - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows.

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Following is a description of the valuation methodology used for investments measured at fair value.

Mutual funds - Valued at the daily quoted market prices as reported by the funds. The mutual funds held by the plan are registered with the U.S. Securities and Exchange Commission, are required to publish their daily net asset value and are deemed to be actively traded.

Investment at contract value - The plan invests in the EI Fixed Account - Series Class I, a general account product of Empower. The investment is a fully benefit-responsive guaranteed portfolio investment through a group fixed annuity contract issued by Empower. As a general account product, participants' principal and interest amounts are fully guaranteed by the general assets of Empower. The methodology for calculating the interest crediting rate is based on prevailing market conditions and earnings of medium-long investments compared to a minimum interest crediting rate, as more fully described in the plan's contract with Empower. The interest crediting rate is reset quarterly. The average yield earned by the fund was 1.41% and 1.23% during 2024 and 2023.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract value, as reported to the plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal of all or a portion of the investment at contract value.

The contract does not have a maturity date and there are no contract provisions that require a distribution at contract value at any specified time. The plan sponsor may request a full distribution at any time. In the event the plan requests an immediate lump sum distribution, a market value adjustment is calculated or the plan may request the distribution in installments over a period of 12 months at contract value.

The plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the plan to transact at contract value with the issuer. As of the date these financial statements were available to be issued, the plan administrator is not aware of any events that might limit the ability of the plan to transact at contract value with the contract issuer or that would also limit the ability of the plan to transact at contract value with the participants.

2. DESCRIPTION OF PLAN

The following description of the plan provides only general information. Participants should refer to the plan agreement for a more complete description of the plan's provisions.

General - The plan was established on February 1, 1989, as a defined contribution plan with a 401(k) salary deferral arrangement. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

Eligibility - Prior to January 1, 2025, employees were eligible once they had completed one year of service (defined as 1,000 hours of service in the eligibility contribution period) and had reached age twenty-one. An employee can enter the plan on January 1 and July 1 after meeting the eligibility requirements. Effective January 1, 2025, the service requirement was eliminated and the entry date was changed to immediately upon meeting the eligibility requirements. For purposes of matching contributions, an employee must be employed on the last day of the year in which the contribution relates. For purposes of profit sharing contributions, an employee must have completed 1,000 hours of service in that plan year and must be employed on the last day of the year in which the contribution relates.

Contributions - Contributions are recorded in the year in which eligible compensation is paid. Contributions to the plan can be made in the following ways:

- a. Participants may contribute a percentage of their compensation subject to certain limitations (elective deferral contribution). The plan also permits Roth elective deferral contributions. New participants are automatically enrolled in the plan and have 2% of compensation withheld as deferral contributions. Such participant deferral percentages automatically increase by 1% each year thereafter until they reach a maximum of 4%. Such participants have the option to increase, decrease, or stop the deferral by completing the necessary documentation.
- b. Rollover contributions are accepted by the plan from other qualified plans. There were no such contributions in 2024 or 2023.
- c. Employer matching contributions may be made at the employer's discretion. For the years ended December 31, 2024 and 2023, the employer contributed 50% of the first \$1,000 that a participant contributed to the plan plus 25% of participant contributions in excess of \$1,000 up to 4% of the participant's plan compensation. Total employer matching contributions were \$74,000 and \$68,000 in 2024 and 2023.
- d. Employer nonelective contributions may be made at the employer's discretion. Such contributions would be allocated to participants in the ratio that each participant's compensation bears to the compensation of all eligible participants. There were no such nonelective contributions in 2024. Total nonelective contributions were \$120,000 in 2023.

Participant accounts - Earnings, including the fair value appreciation (depreciation), are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Each participant's account is credited with the participant's elective deferral contributions and rollover contributions and an allocation of employer contributions. Participants are allowed to transfer funds between the various investment options daily and change their deferral percentage each pay period.

Vesting - Participants are always 100% vested in their elective deferral contributions, rollover contributions and related earnings. Participants begin vesting in employer contributions and related earnings upon two full years of service, at which time they are 20% vested. The participant then vests at a rate of 20% for each year thereafter. Upon death, disability or attainment of normal retirement age while employed, participants become 100% vested.

Payment of benefits - Benefits are recorded when paid. Benefit payments may commence upon termination of employment, death, disability or attainment of normal retirement age. Participants generally receive their distribution in the form of a single lump sum payment. Installment payments are permitted to satisfy Required Minimum Distribution obligations. In-service withdrawals can commence upon attaining the age of 59½. In addition, hardship withdrawals are also permitted under certain circumstances.

Administrative expenses - Certain administrative expenses of the plan are paid by the employer. Certain other administrative fees are paid by the plan from plan assets and are recorded as administrative expenses in the accompanying financial statements. Such expenses include participant directed charges for distribution fees and non-participant directed fees for administrative services. Non-participant directed fees are allocated to participants on an account value basis.

Forfeitures - Forfeitures of nonvested account balances are reallocated as nonelective contributions on an annual basis to participants eligible to receive employer contributions. Such reallocations are allocated to participants in the ratio that each participant's compensation bears to the compensation of all eligible participants. Forfeited non-vested accounts reallocated to participant accounts were \$12,000 and \$14,000 in 2024 and in 2023. Unapplied forfeitures were \$26,000 and \$12,000 as of December 31, 2024 and 2023.

Notes receivable from participants - Loans to participants are not permitted under the plan.

3. PARTY-IN-INTEREST TRANSACTIONS

The plan's investments are managed by Empower. Empower is the investment agent as defined by the plan, and therefore, these transactions qualify as party-in-interest transactions. In addition, Empower receives indirect compensation from the plan's mutual fund investment providers for services Empower provides to the funds. Certain revenues received by Empower from such service providers are remitted to the plan in the form of service credits (as part of an administrative services agreement between the plan sponsor and Empower). Such service credits received by the plan are used by the plan to pay advisory services and other plan fees. There are also certain other plan expenses that Empower charges that are paid directly.

All of the above party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

4. TERMINATION OF PLAN

Although it has not expressed any intent to do so, the plan sponsor has the right to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions and related earnings.

5. INCOME TAX STATUS

The plan adopted a Great-West Trust Company, LLC pre-approved profit sharing plan. The pre-approved profit sharing plan received its most recent favorable opinion letter on November 14, 2022, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. As a result, the plan administrator has not obtained a separate Internal Revenue Service opinion letter for the plan. The plan administrator and tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believes the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) for any uncertain tax positions taken by the plan that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions taken and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of December 31, 2024 and 2023. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.

- c. Contributions to and withdrawals from accounts, and purchases, sales and inter-fund transfers of investments during 2024 and 2023; and
- d. The report of individual participant accounts as of and for the years ended December 31, 2024 and 2023.

7. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

As discussed in Note 1, the plan follows the accrual method of accounting for financial statement purposes. The Form 5500 is prepared on a modified cash basis. As a result, the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended differ from the Form 5500.
