To the Trustees of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Cly-Del Manufacturing Company 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution, Empower Trust Company LLC and Talcott Resolution Life Insurance Company, as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

NOTE 1. DESCRIPTION OF PLAN

The following description of The Cly-Del Manufacturing Company 401(k) Plan (the Plan) provides general information. Participants should refer to the plan document for a more comprehensive description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all full-time employees of The Cly-Del Manufacturing Company (the Company). All full-time employees were eligible to participate on the effective date of plan (September 1, 1998). After open enrollment, employees are eligible to participate after completing one year of service in which 1,000 hours of work was performed. A trustee holds, invests, and distributes assets of the plan in accordance with the terms of the plan agreement. Participants in the plan direct their contributions to various investments offered by the plan. A significant amount of administrative expenses of the plan have been assumed by the plan sponsor - The Cly-Del Manufacturing Company.

Contributions - Participants may contribute up to 20% of pretax annual compensation, as defined in the Plan. This was an increase of 10% over the previous document. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers seventeen investment options for participants. The Company will match the employee's contribution equal to 150% of the first 1%, of employee compensation, 50% of the next 2% of employee compensation, and 25% of the next 2% of employee compensation that a participant contributes to the plan. The matching contributions are made in cash. Additional profit-sharing amounts may be contributed at the option of the Company's board of directors. Contributions are subject to certain limitations.

Investment Options - The Plan currently offers various mutual funds held in pooled separate accounts, and an insurance investment contract as investment options for participants.

Participants are allowed to invest in one or more of the investment options. Participants may change their investment elections between the different investment options. Investment options include three groups of investment funds - fixed income funds are invested in fixed income investments with limited equity holdings, equity funds are primarily invested in common and preferred stock, and target retirement funds, which are diversified funds that invest in stocks and bonds. The target retirement funds gradually shift from more aggressive investments to conservative investments based on its target date. As of December 31, 2024, and 2023, the Plan's investments consisted of mutual funds held in pooled separate accounts and a group annuity contract (General Account) by Talcott Resolution Life Insurance Company.

NOTE 1. DESCRIPTION OF PLAN (continued)

Participant Accounts - Each participant's account is credited with the participant's contribution and allocations of (a) the Company's discretionary contribution, if any, and (b) the Company's matching contribution on their deferrals, if any, and (c) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their salary contribution and rollovers plus actual earnings thereon. Vesting in the Company's matching contributions is based on years of continuous service. Terminated participants who are rehired within five years are credited with prior service years. Participants automatically become 100% vested upon death or termination due to disability.

Payment of Benefits - Terminations of employment for reasons other than retirement, death, disability, or termination of plan before the five year fully vested period will result in the forfeiture of any nonvested contributions.

The participants benefits are payable under the plan as of:

- Normal retirement age of 65
- Death
- Termination of Employment
- Financial Hardship
- Eligible in-service withdrawals

Administrative and Investment Management Expenses - Investment management and professional fees are charged to the Plan as a reduction of investment return and included in the investment income reported by the Plan. Contract administrative fees are deducted from participant accounts. All other expenses are paid by the Plan Sponsor.

Forfeited Accounts - Upon a participant's termination, the unvested portion of the participant's account is forfeited. Forfeited non-vested amounts may be used to reduce future matching contributions and or to pay reasonable plan expenses. During the years ended December 31, 2024 and 2023, \$-0- and \$11,362 of forfeitures were used to pay expenses of the Plan, respectively. As of December 31, 2024 and 2023, unallocated forfeitures were \$9,085 and \$1,781, respectively. Forfeitures totaled \$7,158 for the year ended December 31, 2024.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting generally accepted in the United States of America.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Use of Estimates - The preparation of financial statements, in conformity with accounting principles generally accepted in the United States of America (GAAP), requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition - The Plan's investments are primarily reported at fair value, with the exception of the Plan's group annuity contract, a fully benefit-responsive investment contract, that is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the contract and is the relevant measure for the portion of assets attributable to fully benefit-responsive investment contracts.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

See Note 5 for discussion of fair value measurements.

Payments of Benefits - Benefits are recorded when paid.

NOTE 3. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 4. INFORMATION PREPARED AND CERTIFIED BY PLAN'S TRUSTEE

As of December 31, 2024, and 2023, and for the years then ended, the financial information included in the Plan financial statements, except for employer contributions receivable, participant contributions receivable, contributions, benefits paid to participants and investment expenses, has been derived from information certified as complete and accurate by Empower, acting as the custodian in accordance with Section 2520.103-5 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA, as amended. The financial information is included under "Investments" on the statements of net assets available for benefits and "Investment Income" on the statements of changes in net assets available for benefits.

NOTE 5. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets and liabilities measured at fair value, as well as the general classification of such assets and liabilities pursuant to the valuation hierarchy. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Valued using net asset value provided by the administrator of the fund based on the valuation of the underlying mutual fund investments.

NOTE 6. TAX STATUS

The Plan (under Empower Retirement, LLC Defined Contribution Pre-Approved Plan) was amended and restated effective June 1, 2021. The Internal Revenue Service has informed Empower, LLC by a letter dated November 11, 2022, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended and restated since receiving the opinion letter on the Defined Contribution Pre-Approved Plan, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America, require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities, which are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statements of net assets available for benefits. Given recent volatility in the financial markets, it is reasonably possible that investment values could decline in subsequent periods.

The preparation of financial statements in conformity with generally accepted accounting principles re-quires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

NOTE 8. PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are managed by Talcott Resolution Life Insurance Company and is the custodian and recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Novak Francella LLC, auditor of the Plan's financial statements, is also a party-in-interest as defined by ERISA.

Reid & Riege, attorneys for the Plan, is also a party-in-interest as defined by ERISA.

Certain fees paid to related parties for services to the Plan were paid by the Plan Sponsor. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee received compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. The administrative expenses paid directly by the Plan, as well as indirectly through the reduction of investment return, are considered party-in-interest transactions.

NOTE 9. VOLUNTARY CORRECTION PROGRAM

The US Department of Labor (DOL) selected the 2020 Cly-Del Manufacturing Company 401 (k) Plan to ensure that the employee benefit plan; subject to the Employee Retirement Income Security Act of 1974 (ERISA), satisfied applicable reporting and disclosure requirements. As a result of their review, the 2020 Form 5500 filing was rejected and the DOL intends to assess a civil penalty of \$50,000 against the Plan administrator. The Plan administrator submitted additional information, testing and other workpapers to clear the deficiencies and bring the filing into compliance in hopes of reducing or abating the penalty. Any penalty assessed will be the obligation of the plan sponsor. The penalty was reduced to \$2,500 and paid by the Plan sponsor in 2023.

During the 2021 contribution testing it was determined that the definition of compensation being used since inception did not agree with the adoption agreement regarding bonuses. As intended by both the employees and employer, bonuses were not considered compensation for the purposes of 401(k) elective deferrals and matching contributions. To retroactively specify and correct the definition of compensation the plan sponsor filed an application for voluntary correction program ("VCP") on September 16, 2022 with the Internal Revenue Service. If the VCP application is not accepted, management would reimburse the affected participants. Management has determined that the amount payable to the participants to correct the deficiency is \$69,168, which is not material to the financial statements and therefore no receivable was recorded at December 31, 2023. On July 8, 2024, the Plan sponsor received a closing letter from the Internal Revenue Service. The Plan sponsor made the contribution of \$69,168 in 2024.

NOTE 10. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 2, 2025, which is the date the financial statements were available to be issued, and they have been evaluated in accordance with relevant accounting standards.
