### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Skyline Windows, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to financial statements.

Notes to Financial Statements

December 31, 2024 and 2023

### (1) Description of Plan

The following description of the Skyline Windows, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### (a) General

The Plan is a defined contribution plan covering all non-union employees of Skyline Windows, LLC (the Company) who are age 18 or older, and completed two months of service. The Company controls and manages the operation and administration of the Plan. Reliance Trust Company (Reliance) served as the custodian of the Plan, with Automatic Data Processing, Inc. (ADP) executing the plan transactions until April 28, 2023. Subsequently, Empower Trust Company, LLC (Empower) serves as the custodian and executes transactions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). All eligible employees are enrolled at 3%, unless they request to opt out.

#### (b) Contributions

Each year, participants may contribute up to 80 percent of their pretax annual compensation as defined in the Plan, provided that such contributions do not exceed the maximum allowable contribution limit established by the Internal Revenue Service (IRS). A participant may also elect to make Roth contributions. For 2024, the IRS maximum allowable contribution limit was \$23,000; or if over the age of 50, \$7,500. Participants may roll in amounts from other qualified plans. The Company contributes to the plan on behalf of each participant who is eligible to share in matching contributions for the Plan year, a discretionary matching contribution equal to \$.40 per \$1 on the first 5% of compensation that is deferred resulting in a maximum match of 2%. The Company may also make a nonelective contribution.

#### (c) Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contribution, (b) Plan earnings, and (c) charged with an allocation of investment and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### (d) Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Participants become 20 percent vested in the remainder of their accounts after two years of continuous service, 40 percent after three years of continuous service, 60 percent after four years of continuous service, 80 percent after five years of continuous service and 100 percent after six years of continuous service.

### Notes to Financial Statements, Continued

#### (1) Description of Plan, Continued

##### (e) Notes Receivable From Participants

Participants may borrow from their individual accounts a minimum of \$1,000 and a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. In general, loan terms may not exceed five years, except for loans used to acquire a principal residence, in which case the Plan administrator may permit a longer repayment term. The loans are collateralized by the vested balance in the participant's account and bear interest rates of prime plus 1%. Principal and interest is paid ratably through payroll deductions.

##### (f) Payment of Benefits

On termination of service, a participant may elect to receive either a lump-sum amount equal to the value of his or her account or installments over a period of not more than his or her assumed life expectancy (or the participant's and beneficiary's assumed life expectancy) determined at the time of distribution. The participant may also withdraw hardship distributions for various reasons.

##### (g) Forfeited Accounts

Forfeitures of non-vested accounts will be used to reduce future employer contributions or pay reasonable Plan expenses. Forfeitures in 2024 and 2023 amounted to \$14,082 and \$10,585, respectively. Amounts used to reduce employer contributions and pay administrative fees totaled \$7,899 and \$23,508 at December 31, 2024 and 2023 respectively. Forfeitures available for future use at December 31, 2024 and 2023 amounted to \$18,915 and \$5,331, respectively.

#### (2) Summary of Significant Accounting Policies

##### (a) Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### (b) Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

##### (c) Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received from the sale of an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 3 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes both the Plan's gains and losses on investments bought and sold as well as held during the year.

#### (2) Summary of Significant Accounting Policies, Continued

##### (d) Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

##### (e) Contributions

Contributions from Plan participants and the Company contributions are recorded in the year in which the participants compensation is earned.

##### (f) Payment of Benefits

Benefits paid to participants are recorded when paid.

##### (g) Administrative Expenses

Administrative expenses of the Plan not related to investments have been absorbed by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation or depreciation in fair value of investments in the accompanying statements of changes in net assets available for benefits.

##### (h) Subsequent Events

The management of the Plan has evaluated subsequent events through the date of the report which is the date the financial statements were available to be issued.

#### (3) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

- Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- Common Collective Trusts - Valued at the NAV of shares held by the Plan at year end. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. These investments file Form 5500's as direct filing entities.

The incorporation of this financial information in the accompanying financial statements is based solely on their certifications and has not been audited by independent auditors.

(5) Party-In-Interest Transactions

Transactions with Empower and ADP qualify as party-in-interest. Notes receivable from participants are also considered party-in-interest transactions.

(6) Plan Termination

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the accounts of the participants shall immediately be fully vested and nonforfeitable.

(7) Tax Status

The IRS has determined and informed the Company by a letter dated November 14, 2022, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more than likely would not be sustained upon examination by the IRS or the Department of Labor (DOL). The Plan is subject to routine audits by taxing jurisdictions and the DOL; however, there are currently no audits for any tax periods in progress.

(8) Risks and Uncertainties

The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
