Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Axis Energy Services 401(k) Employee Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Axis Energy Services 401(k) Employee Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Axis Energy Services 401(k) Employee Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

(1) **Description of the Plan**

The following description of the Axis Energy Services 401(k) Employee Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a tax-qualified defined contribution plan under Section 401(a) of the Internal Revenue Code which provides retirement, disability or death benefits for full-time employees of Axis Energy Administration, LLC (the "Company") who are age twenty-one (21) or older and have attained ninety (90) days of service. The Plan is subject to various provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan is an amendment and restatement of a pre-existing plan which was originally effective as of June 1, 1993. The Plan as herein discussed is effective as of January 24, 2024.

Contributions and Allocations

Each year, participants may contribute up to ninety percent (90%) of compensation ("eligible compensation" as defined under the Plan), not to exceed maximum annual contribution limits established by the Federal Government. The elective deferral limitations for 2024 and 2023 totaled \$23,000 and \$22,500, respectively. In addition, during the year which a participant attains age fifty (50) and in subsequent years, the participant may elect to make additional pretax "catch up" contributions of up to \$7,500 in the years ended 2024 and 2023.

Participants direct the investment of their contributions into various investment options offered by the Plan.

A matching contribution by the Company is discretionary for each plan year. Matching contributions are limited to a discretionary percentage of compensation or a discretionary dollar amount, the percentage or dollar amount to be applied on a uniform basis for all participants. Matching contributions for the year ended December 31, 2024 totaled \$619,827.

A profit-sharing contribution by the Company is also discretionary for each plan year. Profit sharing contributions shall be calculated in a manner determined by the Company. There were no profit-sharing contributions for the year ended December 31, 2024.

Rollover contributions are permitted by the Plan. Rollover contributions remain in segregated rollover accounts and are always one hundred percent (100%) vested.

Participant Accounts

Under the Plan, elective deferrals made by participants and any employer contributions are placed into investment accounts, as directed by the participant, which are then credited with gains and losses at each valuation date. Valuation dates for this Plan occur daily. The benefit to which a participant is entitled is the benefit that can be provided from the participants vested account.

Vesting

Under the Plan, participants are immediately vested in their contributions plus actual earnings thereon. Participants are vested in the Company's contribution portion of their accounts plus actual earnings thereon based on years of continuous service. All participants are fully vested after completing at least six (6) years of service.

The following represents the vesting schedule for matching and discretionary Employer accounts, including top-heavy:

Notes Receivable from Participants

Participants may borrow, from their fund accounts, a minimum of \$1,000 up to the lesser of \$50,000 or fifty percent (50%) of their account balance. Participants may not have more than one (1) outstanding loan at a time. Interest rates will be 2 percentage points over the current published US Prime interest rate.

Loans are secured with an irrevocable pledge and assignment of the participant's vested interest in his or her account and bear interest at a fixed rate established by the Plan Administrator. Currently, rates are set at two percent above the prime lending rate of a commercial U.S. bank available within reasonable geographic vicinity when the loan is made. Principal and interest is paid ratably as of each payroll withholding period through payroll deductions.

Payment of Benefits

Participants are eligible for a distribution upon termination of service, death, disability or retirement. A participant will receive a lump-sum amount equal to the fair market value of the participant's vested interest in his or her account.

Participants that have separated from service with vested account balances totaling less than \$5,000, are subject to involuntary cash-out provisions.

Participants are eligible for a distribution due to financial hardship under certain conditions in accordance with the Plan document. The amount of a hardship withdrawal may not exceed the cost associated with the financial hardship in addition to any required federal income tax withholding.

(1) Description of the Plan (cont.)

In-service distributions are permitted by the Plan for participants that have attained age fifty-nine and one-half (59 ½.) and can only be made from accounts which are one-hundred percent (100%) vested.

Forfeited Accounts

Forfeitures are amounts which cannot be paid to terminated participants because they were not one hundred percent (100%) vested upon separation from service with the Company. Forfeitures of all contributions will supplement the Plan's administrative expenses and reduce future employer contributions respectively. The Plan, as of December 31, 2024 and 2023, had forfeited non-vested account balances totaling \$12,416 and \$515, respectively. The Plan used \$4,645 to supplement employer contributions during the year ended December 31, 2024.

Plan Merger

On February 6, 2025, the Plan entered into an Agreement and Plan of Merger ("Merger Agreement") with Brigade Energy Services, LLC 401(k) Plan ("Brigade"). The Merger Agreement was effective for plan assets as of December 31, 2024. A receivable has been recognized for the Brigade assets received by the Plan on April 1, 2025.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for Plan benefits at the date of the financial statements and the changes in net assets available for Plan benefits during the reporting period and, when applicable, the disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. *Fair value* is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Loan defaults are considered to have occurred if any scheduled payment remains unpaid beyond the last day of the calendar quarter following the calendar quarter in which the Participant missed the scheduled payment.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Although not required, the Company, as Plan Sponsor, may pay the related costs of administering the Plan. Expenses paid by the Company on behalf of the Plan are not reflected in the financial statements of the Plan.

(3) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 inputs to the valuation methodology include the following:
 - Quoted prices for similar assets or liabilities in active markets
 - Quoted prices for identical or similar assets or liabilities in inactive markets
 - Inputs other than quoted prices that are observable for the asset or liability
 - Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts—Represented by a “unit of account” and a per unit value whose value is the result of the accumulated values of the underlying investments. While the majority of the underlying asset values are based on quoted prices, the net asset value (NAV) of the pooled separate accounts is not publicly quoted. The NAV is based on the value of the underlying assets owned by the pooled separate account, minus any liabilities, and then divided by the number of shares outstanding. The Plan is permitted to redeem investment units at NAV on the measurement date.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In accordance with Topic 820, pooled separate accounts, which are measured at net asset value per share (or its equivalent), have not been classified in a fair value hierarchy.

(4) Guaranteed Investment Contracts with Insurance Entity

The Plan entered into a fully benefit-responsive investment contract that is measured in the financial statements at contract value. Principal maintains contributions in a deposit account that is backed by assets held by their general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The guaranteed investment contract is fully benefit-responsive; contract value is the relevant measurement attribute for that portion on the net assets available for benefits. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The guaranteed investment contract does not permit the insurance entity to terminate the agreement and settle at an amount different than contract value.

(5) Transactions with Parties in Interest

The Plan has issued loans to participants, which are secured by the vested balances in the participants' accounts.

Additionally, Axis Energy Administration, LLC, the Plan sponsor, provides certain accounting and administrative services for which no fees are charged.

Certain plan investments are managed by The Principal Trust Company. The Principal Trust Company is the Plan trustee; therefore, payments to this entity qualify as party-in-interest transactions.

(6) Plan Amendment or Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time. The Company may also amend the Plan. However, no amendment can reduce benefits already earned by the participants. In the event of termination, participants are entitled to the full amount in their account as of the date of termination, regardless of the percent vested at the time of termination.

(7) Tax Status

The IRS stated that the prototype adopted by the plan, as then designed, qualifies under Internal Revenue Code (IRC) Section 401(a). The plan has not received a determination letter specific to the plan itself; however, the plan administrator and the plan's tax counsel believe that the plan was designed and is being operated in compliance with the applicable requirements of the IRS. Therefore, no provision for income taxes has been included in the plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants account balances and the amounts reported in the statement of net assets available for benefits.

(10) Subsequent Events

The Plan Administrator has evaluated all events or transactions that occurred after December 31, 2024 through September 22, 2025, which is the date the financial statements were available to be issued.
