We have performed audits of the accompanying financial statements of 403(b) Thrift Plan for Goodwill Industries of the Valleys, Inc. (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. 

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of 403(b) Thrift Plan for Goodwill Industries of the Valleys, Inc. (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of 403(b) Thrift Plan for Goodwill Industries of the Valleys, Inc.'s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

### Opinion

### Note 1 – Plan Description

---

The following description of the 403(b) Thrift Plan for Goodwill Industries of the Valleys, Inc. (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### *General*

The Plan is a defined contribution plan covering substantially all employees of Goodwill Industries of the Valleys, Inc. (the “Company”), as defined. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

#### *Contributions*

Each year, participants may contribute up to 100% of eligible compensation as Pre-tax or Roth deferrals up to the maximum allowable under the *Internal Revenue Code (IRC)*, as defined in the Plan. There are no minimum age or service requirements for participants to become eligible for deferrals or the Company’s matching contributions. Participants may also contribute amounts representing distributions from other qualified Plans, as defined. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company matches 50% of participant deferrals, up to 6% of eligible compensation, for a maximum match of 3%. Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

#### *Participant Accounts*

Each participant’s account is credited with the participant’s contribution, the Company’s matching contributions, and an allocation of the Plan earnings, and charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### *Vesting*

Participants are immediately vested in their contributions plus earnings thereon. Vesting in the Company’s matching contributions plus earnings thereon is based on years of continuous service. A participant is 100% vested in Company matching contributions after three years of credited service.

#### *Notes from Participants*

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, as defined by the Plan. Note terms range from one to five years unless the note is for purchase of a primary residence, in which case the term may exceed five years. Notes are secured by the balance in the participant’s account and bear interest at a rate commensurate with market rates. The interest rate ranged from 4.60% to 5.85% at December 31, 2024. Principal and interest are paid ratably by participants directly to the Trustee.

### *Payment of Benefits*

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump-sum distribution or annuity payments equal to the value of the participant's vested interest in his or her account. In addition, in-service withdrawals are permitted for hardships or upon reaching age 59 ½, as defined.

### *Administrative Costs*

Plan administrative expenses may be paid by the Company or the Plan on a discretionary basis.

### *Forfeitures*

Forfeited non-vested accounts at December 31, 2024 and 2023 were \$3,124 and \$30,814 respectively. Forfeited balances of terminated participants' non-vested accounts may be used to reduce employer contributions. During the years ended December 31, 2024 and 2023, forfeited non-vested amounts of \$54,207 and \$8,242 were used to reduce employer contributions, respectively.

## **Note 2 – Significant Accounting Policies**

---

### *Basis of Accounting*

The financial statements of the Plan are prepared using the accrual method of accounting.

### *Estimates*

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### *Valuation of Investments and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### *Notes from Participants*

Notes from participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

### *Payment of Benefits*

Benefit payments are recorded when paid.

### *Interest Bearing Cash*

For purposes of preparing the statements of net assets available for benefits, the Mutual of America Interest Accumulation Account held by the Trustee is considered interest bearing cash. This amount is not insured by the Federal Deposit Insurance Corporation (FDIC).

### *Subsequent Events*

Subsequent events have been evaluated through October 1, 2025, the date the financial statements were available to be issued.

---

## **Note 3 – Fair Value Measurements**

---

The Plan's pooled separate accounts are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

### **Note 4 – Investment Contracts**

At December 31, 2024 and 2023, the Plan had assets in the General Account of \$906,149 and \$928,262, respectively. This account holds interest bearing cash in the Mutual of America Interest Accumulation Account and is not considered to be fully benefit-responsive and therefore reported at fair value. This account credits interest at a rate that Mutual of America may declare from time to time and which may increase or decrease at their discretion. The current minimum rate has been set at 3.00% for all contracts that do not have a contractual minimum guarantee of 3.00% or 1.50%. This guarantee is subject to Mutual of America's financial strength and claims-paying ability.

---

### **Note 5 – Related Party Transactions**

Officers or employees of the Company perform certain administrative functions. These employees are also Plan participants. No such officer or employee receives compensation from the Plan.

Plan participants direct their investments in funds issued by the Trustee and managed by the Plan Trustee. Investments in funds issued by the Trustee are considered related party transactions. Fees paid to Mutual of America Life Insurance Company by the Plan for investment management and administrative services were \$5,389 for the year ended December 31, 2024.

### Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will be 100% vested in their accounts.

### Note 7 – Tax Status

The Plan is designed in accordance with applicable sections of the *IRC*. The Plan Administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the *IRC*.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
